(57) **CLAIM**

The ornamental design for the cabinet door, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a cabinet door showing the new design;

FIG. 2 is a bottom plan view thereof;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a left-side elevation view thereof with a right-side elevation view being a mirror image; and,


FIG. 5 is a front perspective view similar to FIG. 1, but with the cabinet door moved to an open position.






