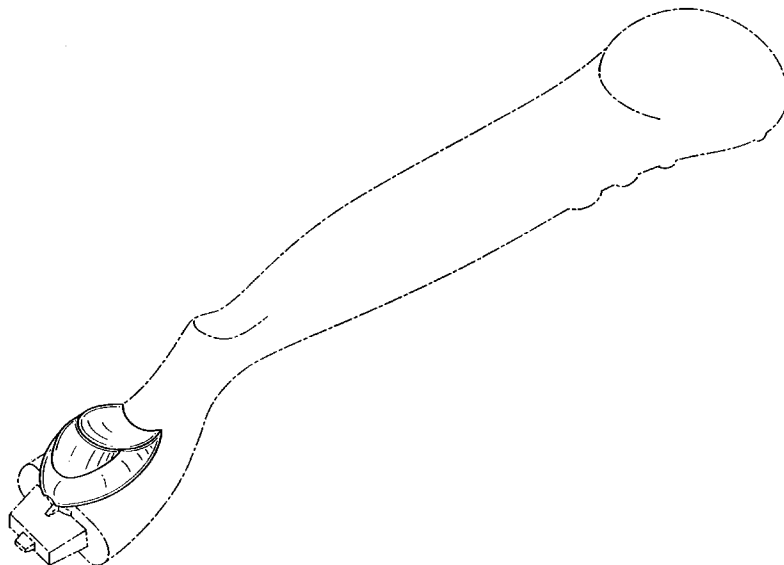
### [57] CLAIM

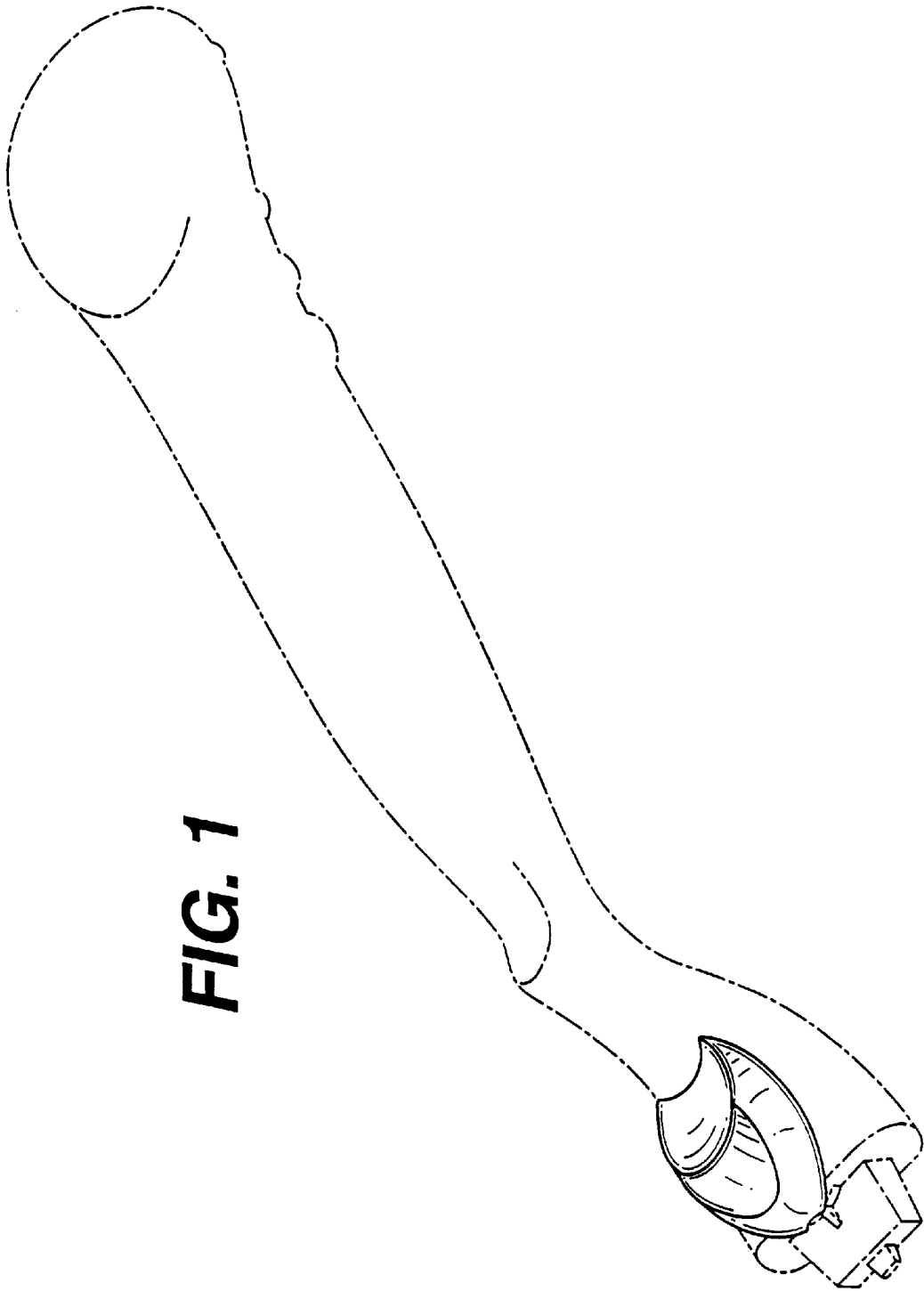
The ornamental design for a razor handle button, as shown and described.

### DESCRIPTION

FIG. 1 is a top perspective view of a razor handle button; FIG. 2 is a top plan view thereof; FIG. 3 is a right side elevational view, the left side elevational view being a mirror image; and, FIG. 4 is a front elevational view thereof. The broken line showing of the razor handle is for illustrative purposes only and forms no part of the claimed design. The surface(s) or portion(s) of the article not shown in the drawing or described in the specification form(s) no part of the claimed design.

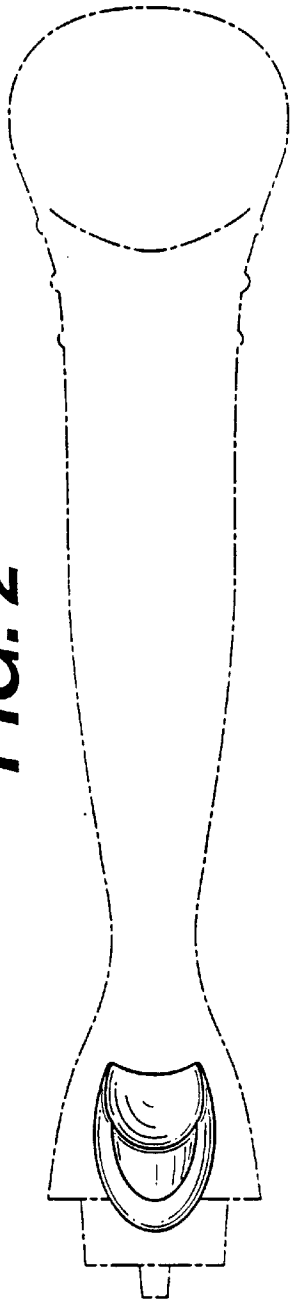

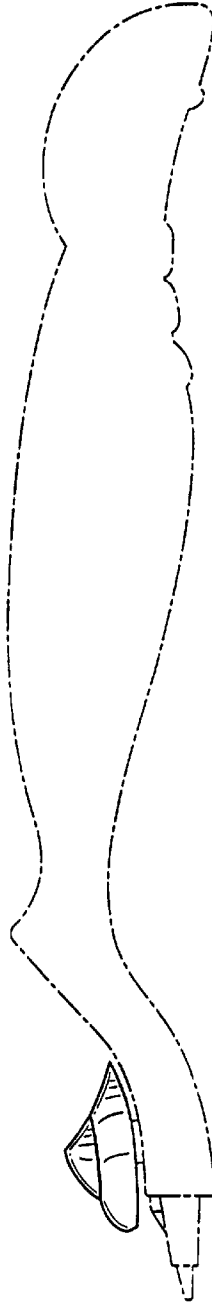
