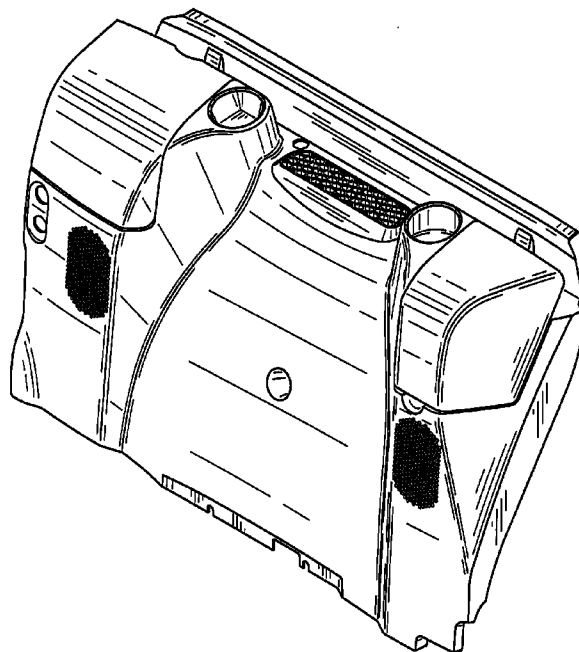
(57) **CLAIM**

We claim the ornamental design for a rear tray for construction machinery, as shown and described.

DESCRIPTION

FIG. 1 is a front, top and right side perspective view of a rear tray for construction machinery showing our/my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a left side elevational view thereof; FIG. 5 is a right side elevational view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof.

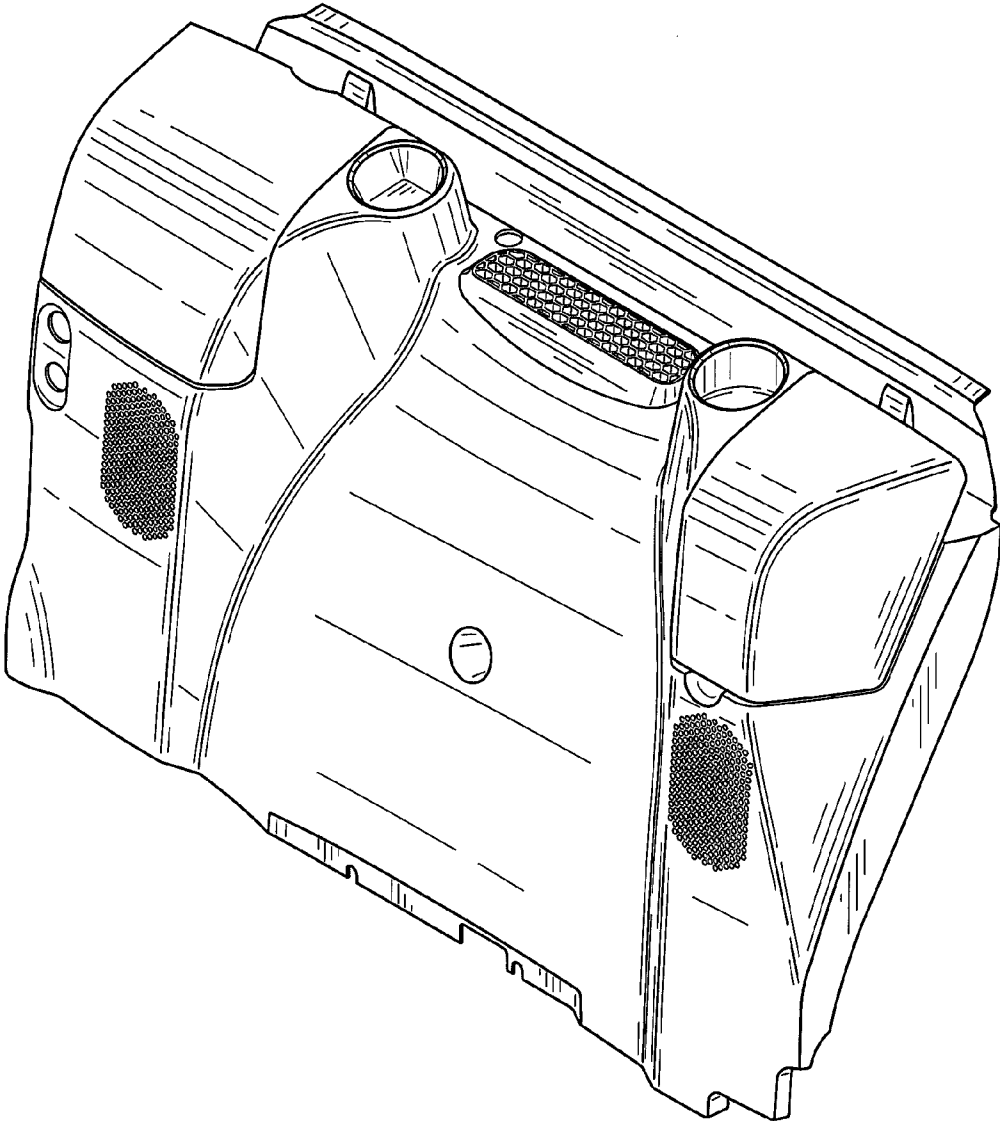

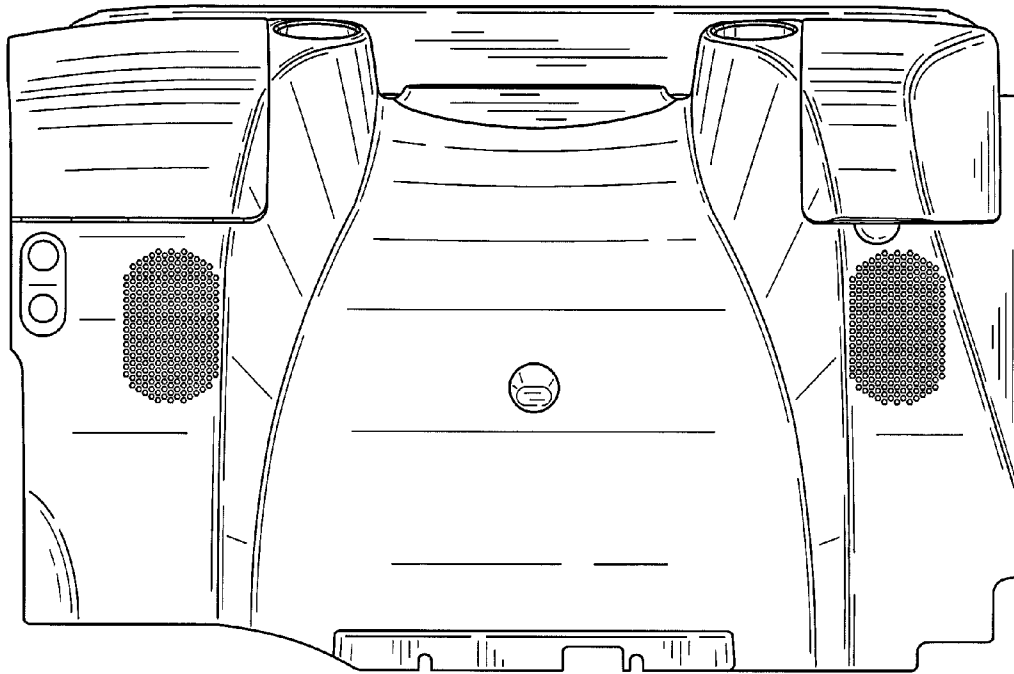

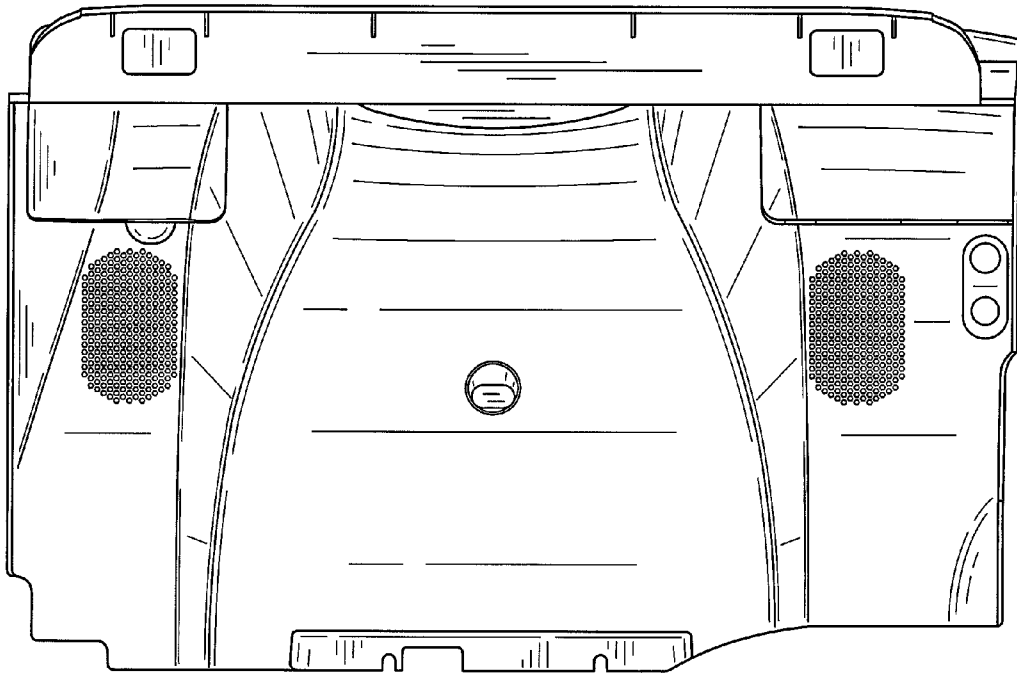

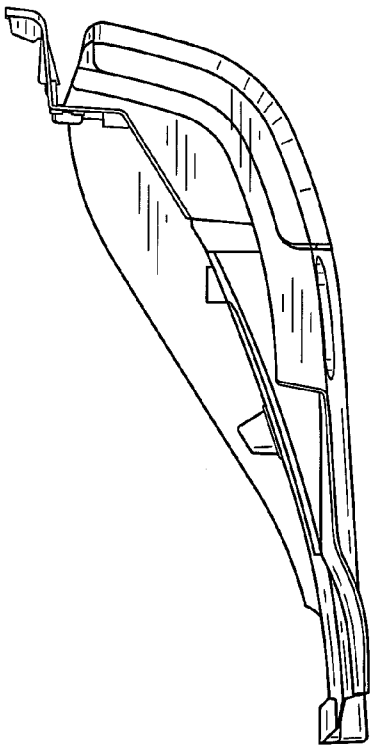

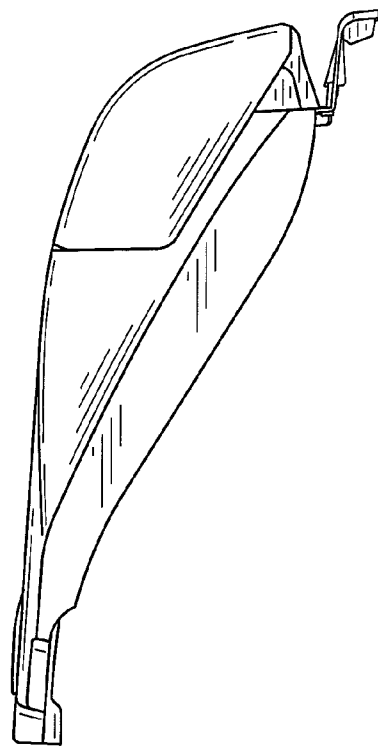

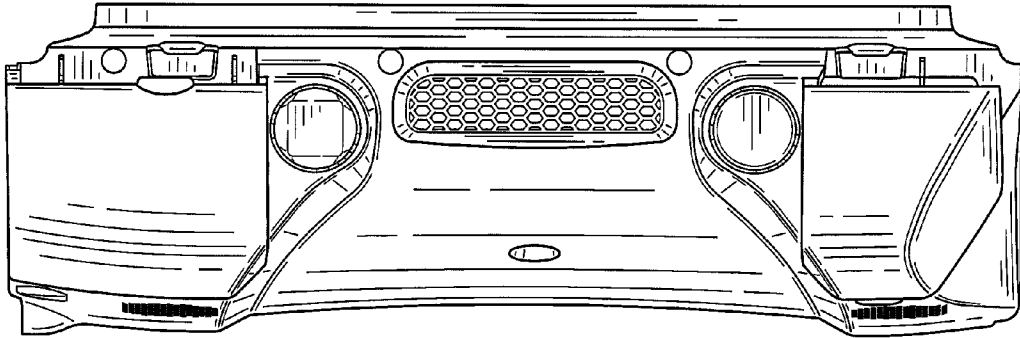

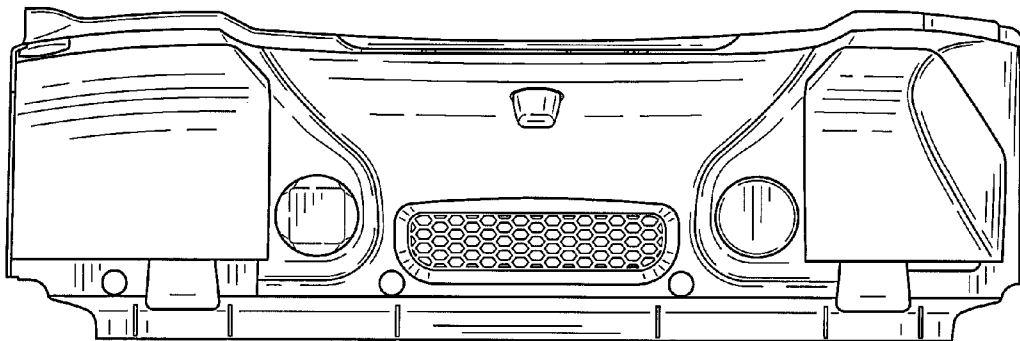
