The ornamental design for an opening mechanism for a package, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of an opening mechanism for a package showing our new design.

FIG. 2 is a front view of the design shown in FIG. 1;

FIG. 3 is a right side view of the design shown in FIG. 1;


FIG. 4 is a left side view of the design shown in FIG. 1;












