We claim the ornamental design for a power tool blade guard, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a power tool blade guard in accordance to our invention.

FIG. 2 is a left side view of the power tool blade guard of FIG. 1.

FIG. 3 is a right side view of the power tool blade guard of FIG. 1.

FIG. 4 is a front view of the power tool blade guard of FIG. 1.


FIG. 5 is a rear view of the power tool blade guard of FIG. 1.














