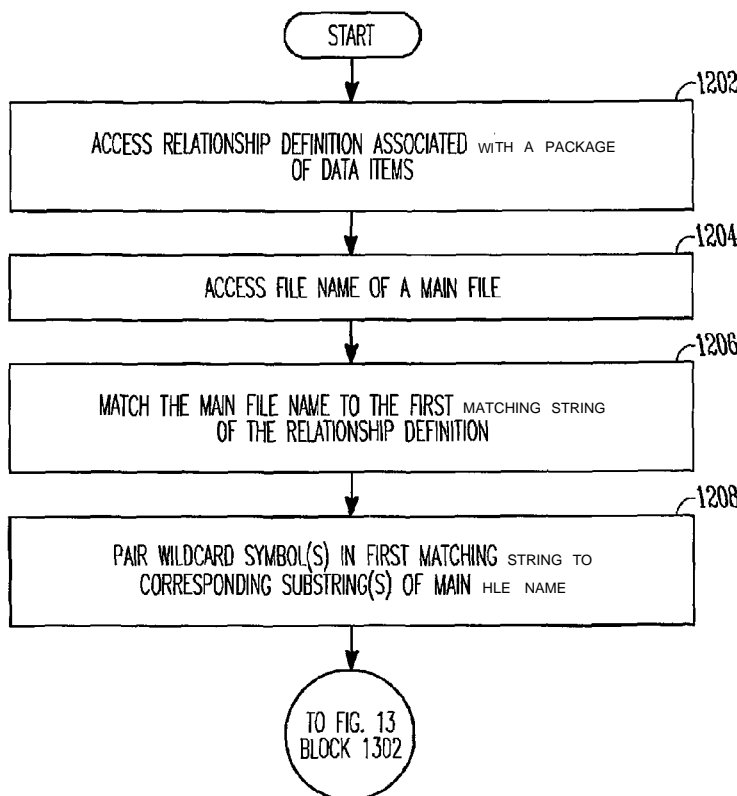

(54) **Title:** PATTERN-BASED FILE RELATIONSHIP INFERENCE



(57) **Abstract:** In an example embodiment, a method comprising accessing a relationship definition associated with a package of data items, the relationship definition including a template string and a first pattern string including a first wildcard symbol, accessing a main file name of a main file, matching the main file name to the first pattern string including associating the first wildcard symbol with a substring of the main file name, and deriving a second pattern string from the template string.
