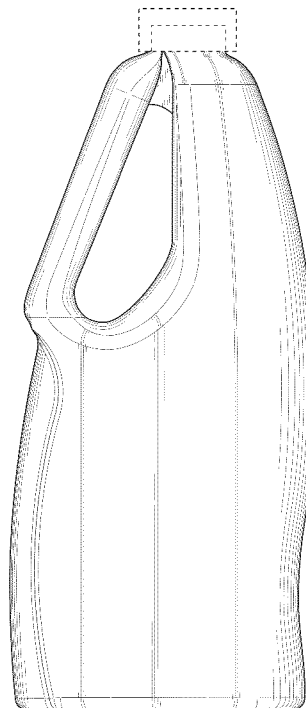
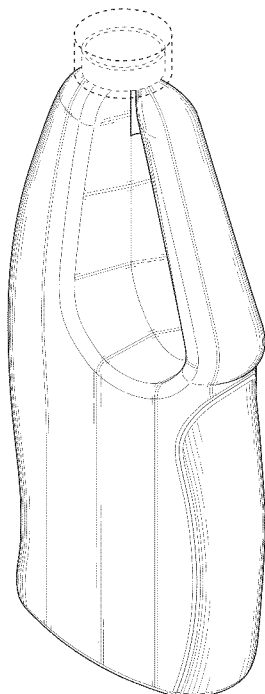
(57) **CLAIM**

I claim the ornamental design for a bottle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a bottle showing the new design;
FIG. 2 is a front view thereof, with the rear view of the design being a mirror image of the front;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top view thereof; and,
FIG. 6 is a bottom view thereof.

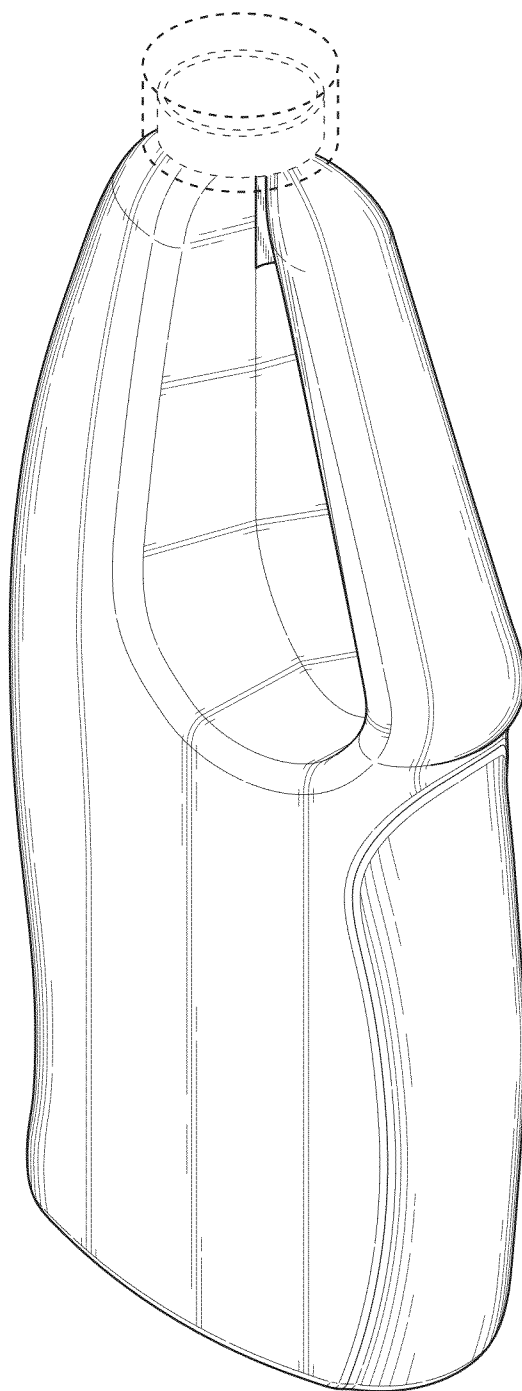

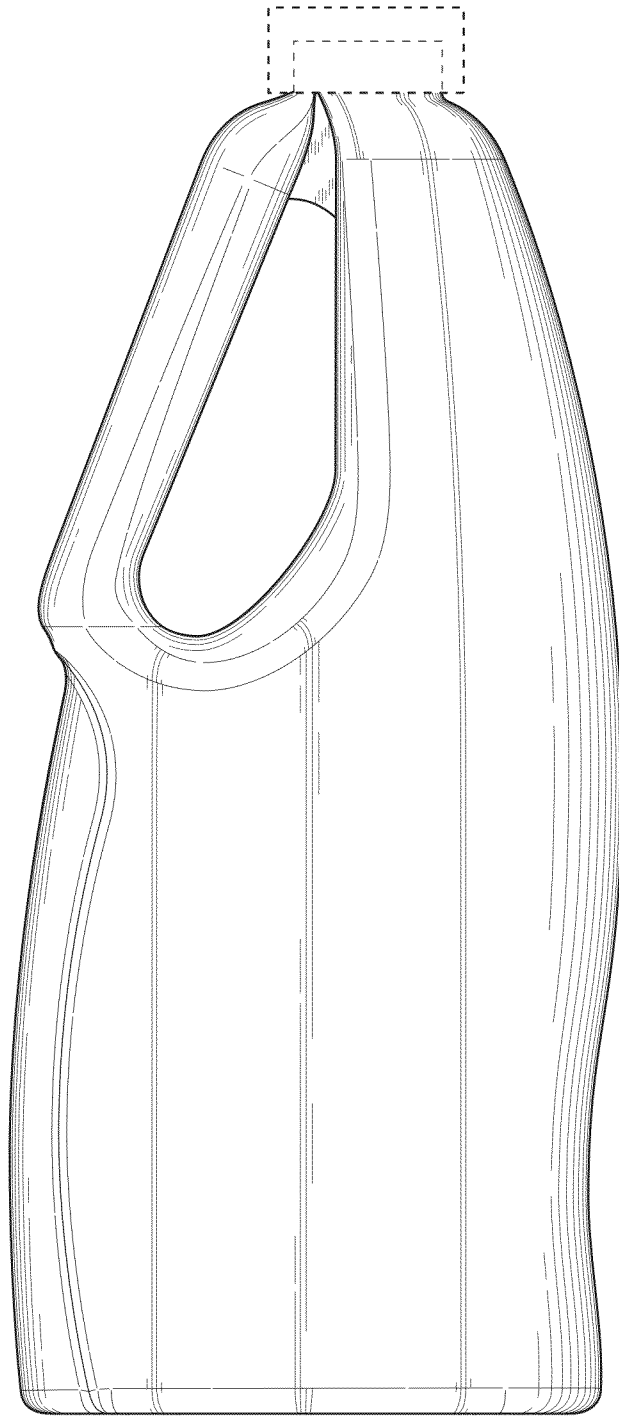

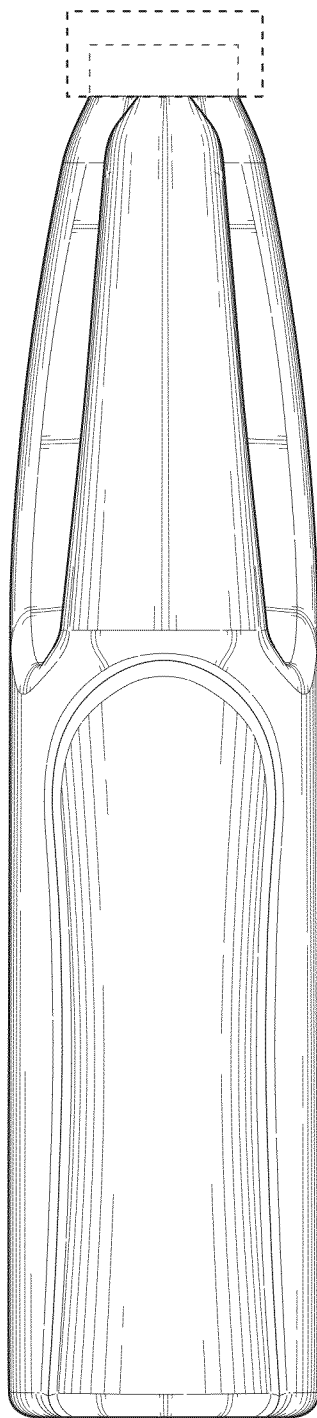

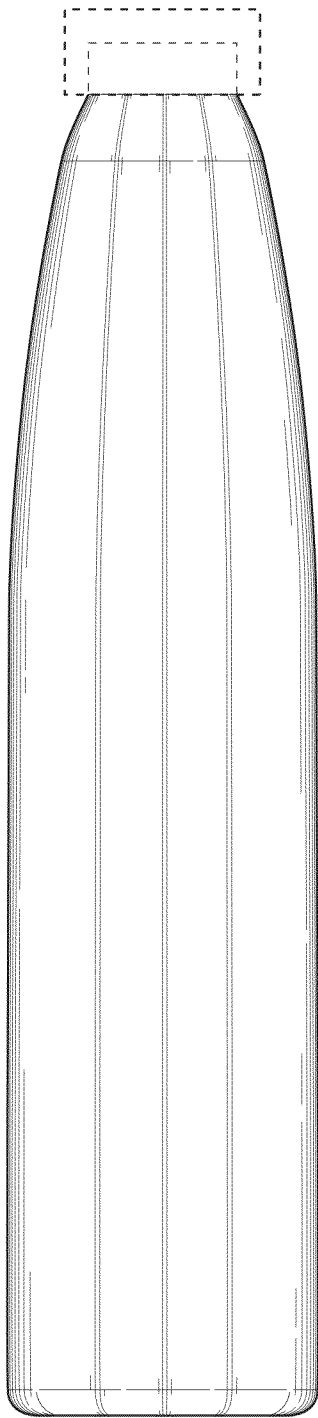

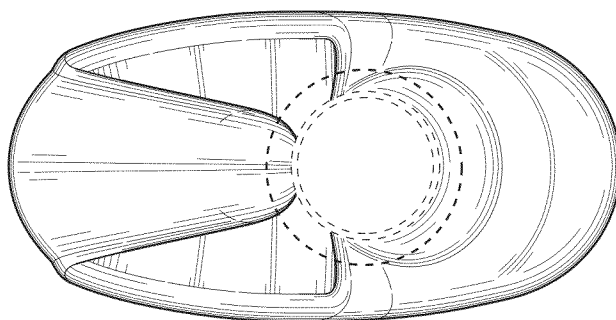

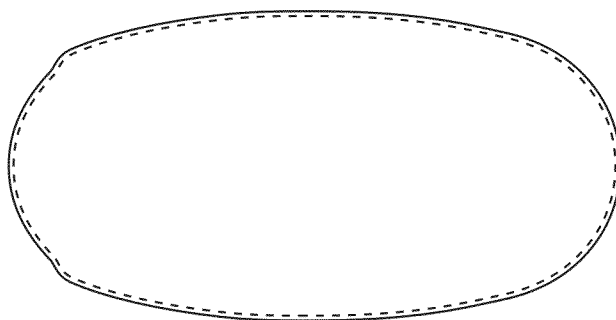
