

The ornamental design for an electric power generation arrangement, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an electric power generation arrangement showing our new design; FIG. 2 is a right side view thereof; FIG. 3 is a left side view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a bottom plan view thereof; FIG. 6 is a front elevation view thereof; FIG. 7 is a rear elevation view thereof; FIG. 8 is an enlarged perspective view of the control tower portion thereof, shown separated for ease of illustration; FIG. 9 is right side view thereof; FIG. 10 is left side view thereof; FIG. 11 is front elevation view thereof; FIG. 12 is a rear elevation view thereof; FIG. 13 is a bottom plan view thereof; FIG. 14 is a top plan view thereof; FIG. 15 is an enlarged perspective view of the cable duct portion thereof, shown separated for ease of illustration; FIG. 16 is a front elevation view thereof; FIG. 17 is a rear elevation view thereof; FIG. 18 is a left side view thereof; FIG. 19 is a right side view thereof; FIG. 20 is a top plan view thereof; and, FIG. 21 is a bottom plan view thereof. 








































