DESCRIPTION

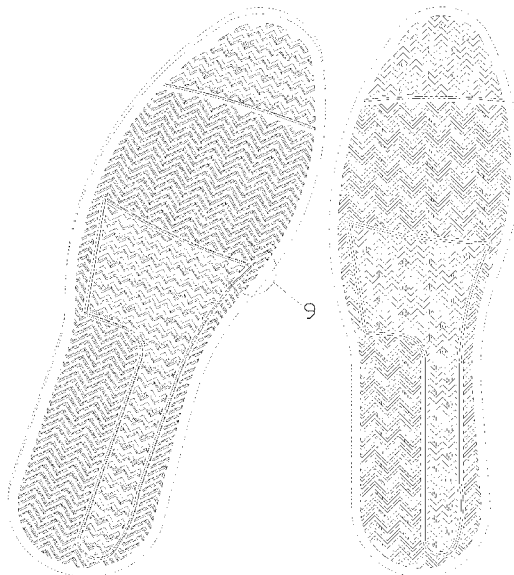
FIG. 1 is a perspective view of an outsole showing my new design;

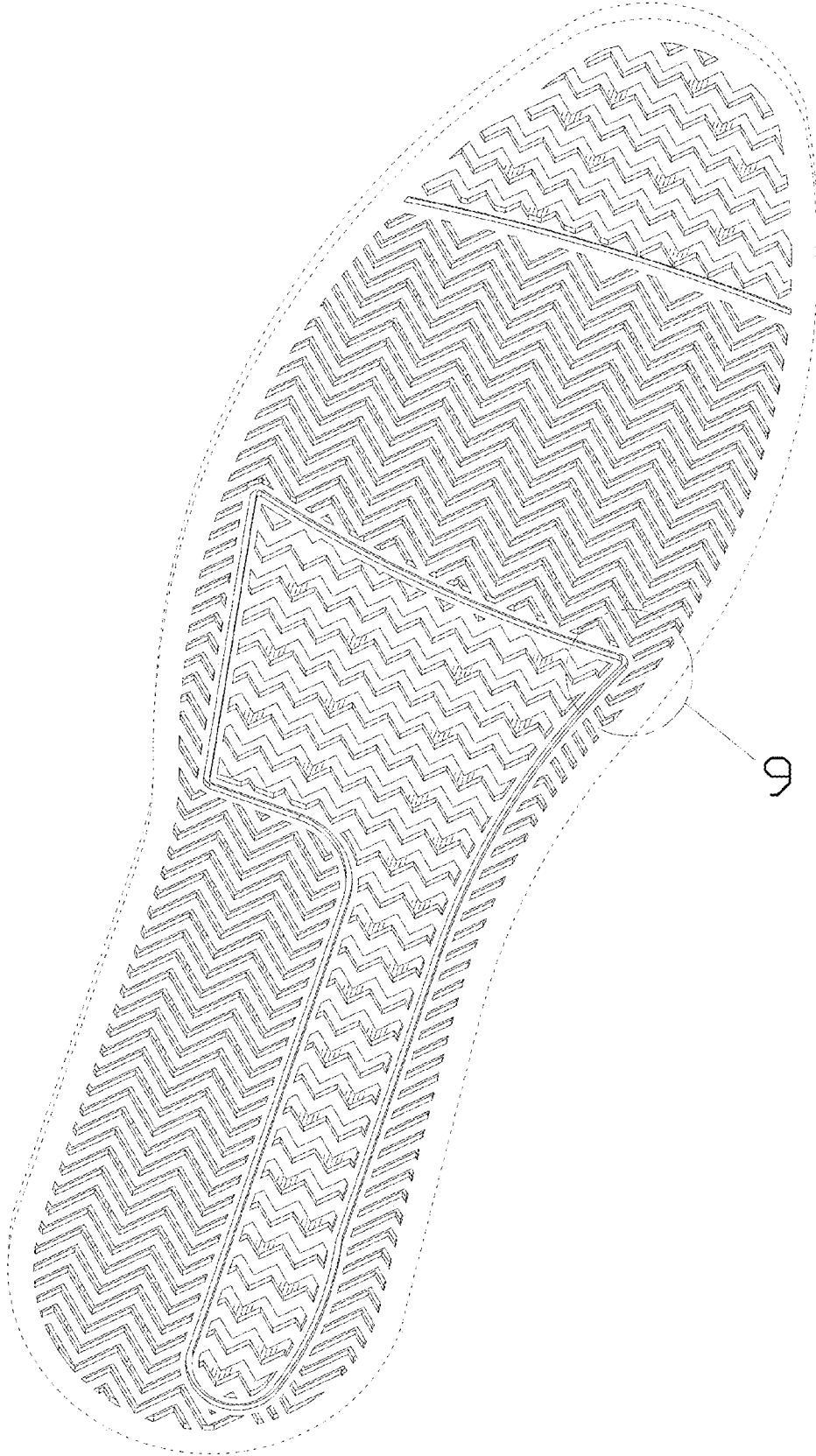

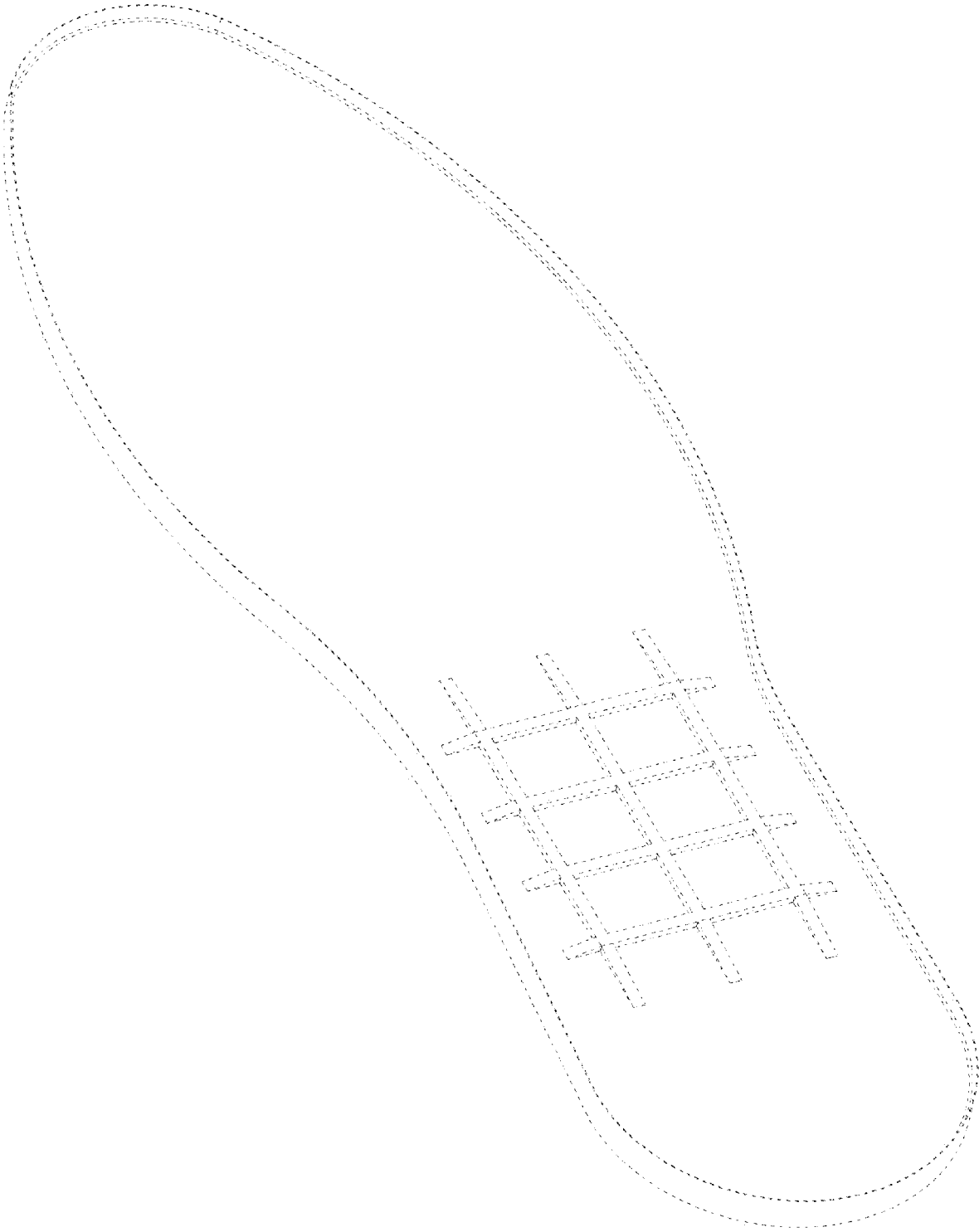

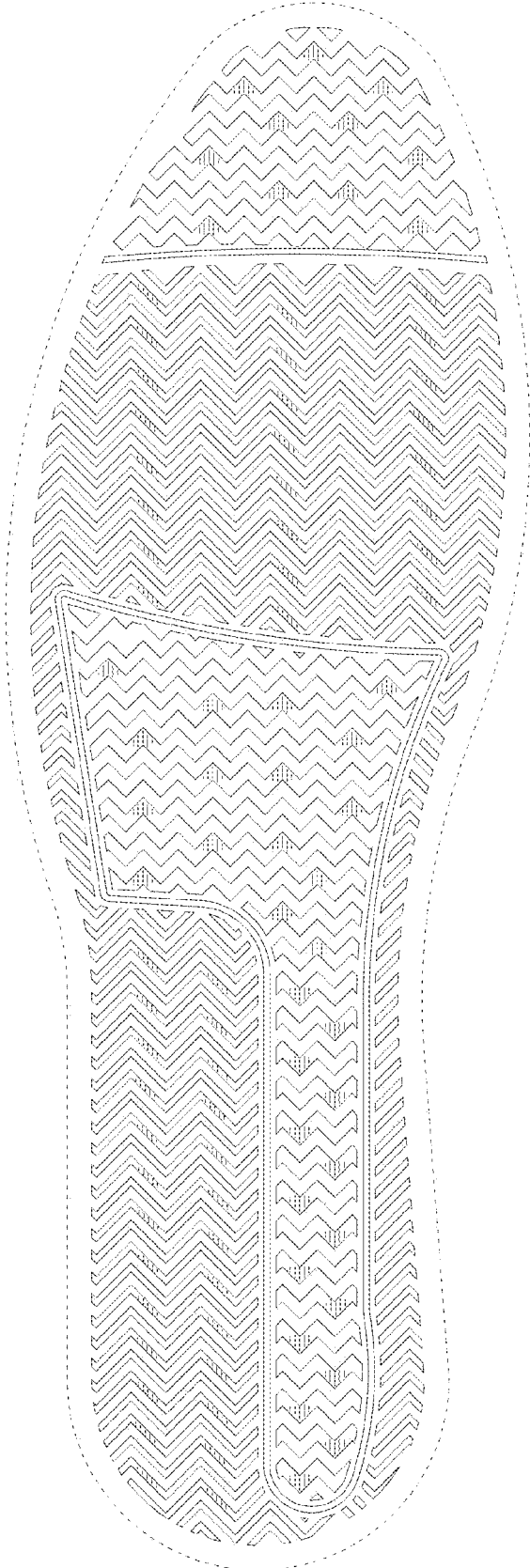

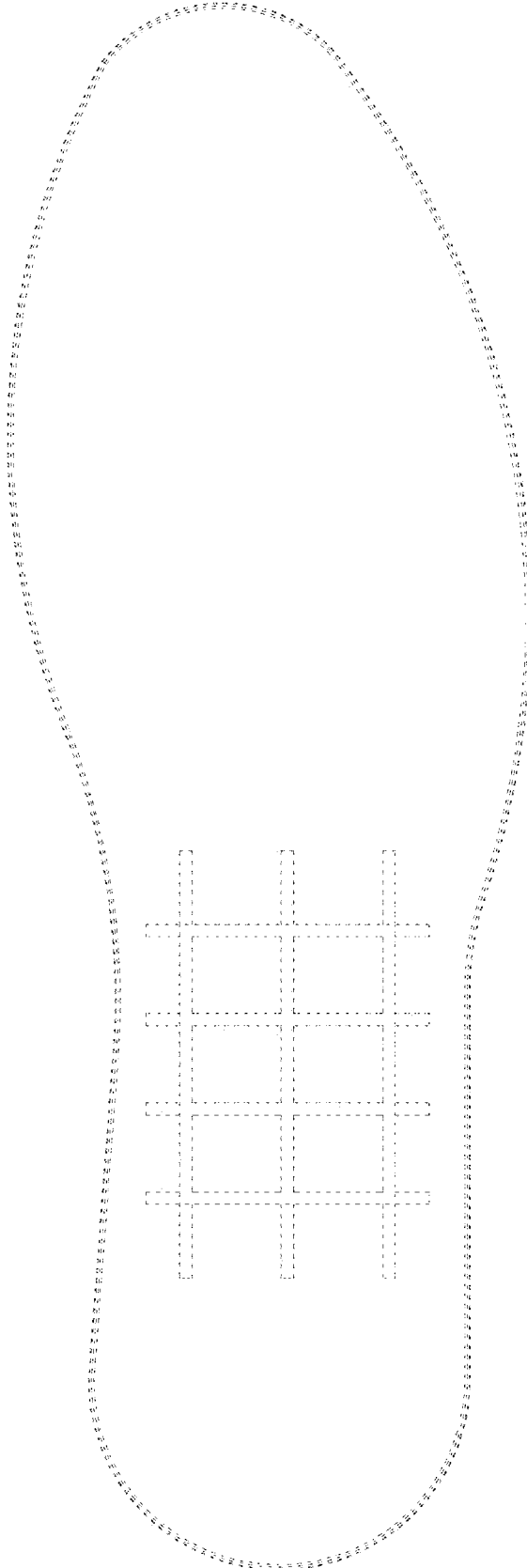

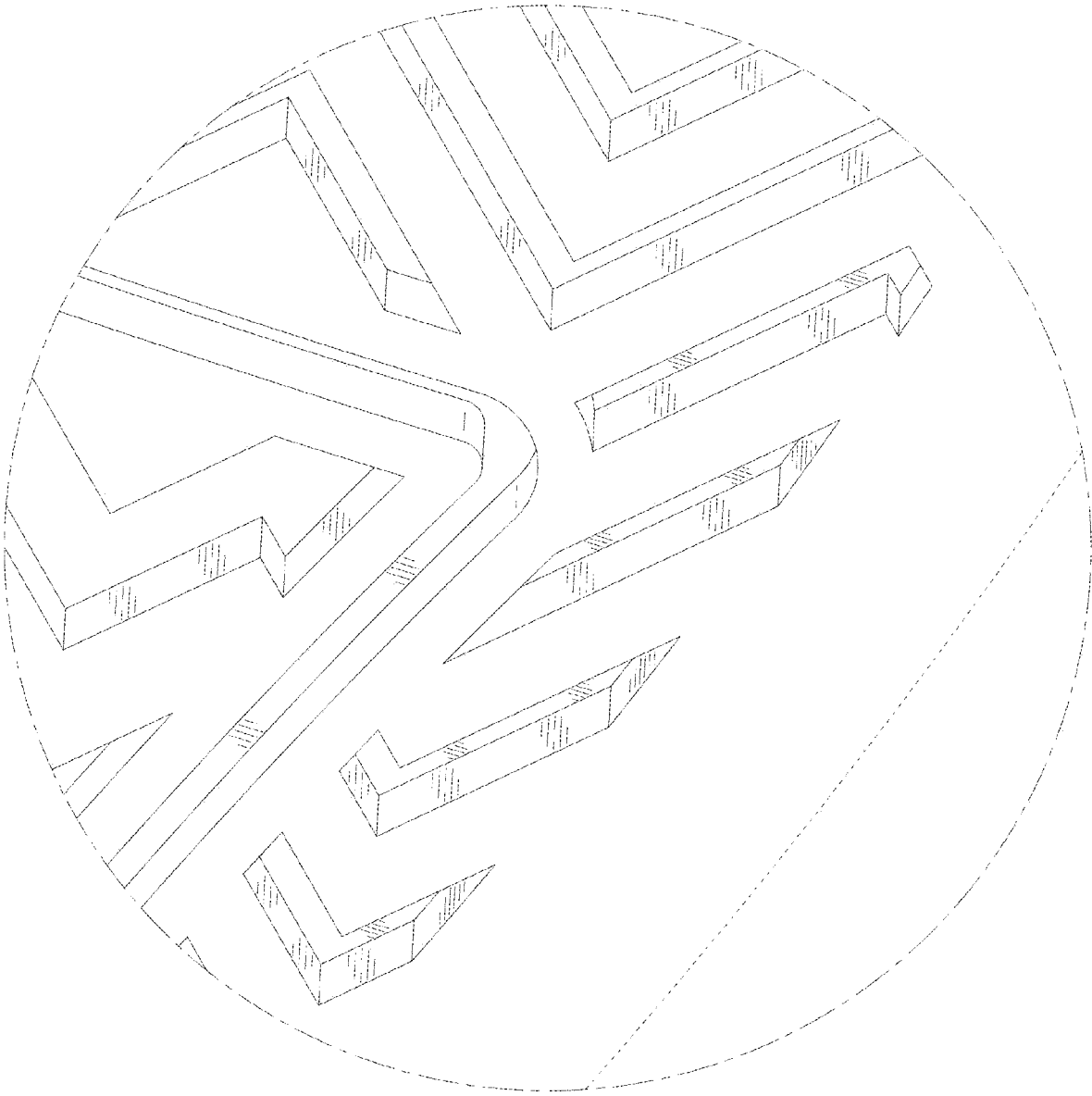
