(57) **CLAIM**

We claim the ornamental design for an electric hair clipper, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of an electric hair clipper of the present invention;

FIG. 2 is a rear perspective view thereof;

FIG. 3 is a front view thereof;

FIG. 4 is a first side view thereof;

FIG. 5 is a top view thereof;

FIG. 6 is a rear view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is a second view thereof;

FIG. 9 is a cross-sectional view taken along the line 9-9 of FIG. 3 with the internal parts being omitted;

FIG. 10 is a front perspective view without an attachment thereof; and,

FIG. 11 is a rear perspective view without an attachment thereof.

The dash dot broken lines along the upper rear and upper sides of the clipper in FIGS. 6, 10 and 11 illustrate the bounds of the claim. The remaining broken lines illustrate portions of the article. None of the broken lines forms part of the claimed design.

The attachment has been removed in FIGS. 10 and 11 for convenience of illustration.






















