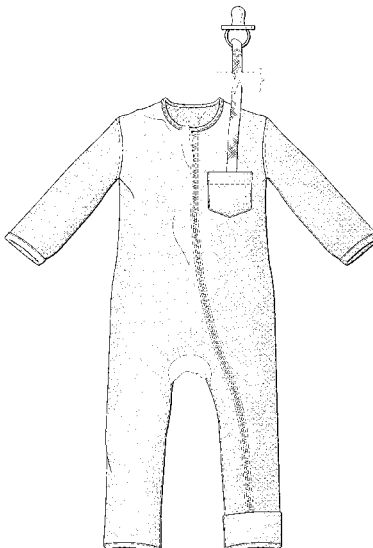
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front perspective view of the baby apparel of the present invention; and,

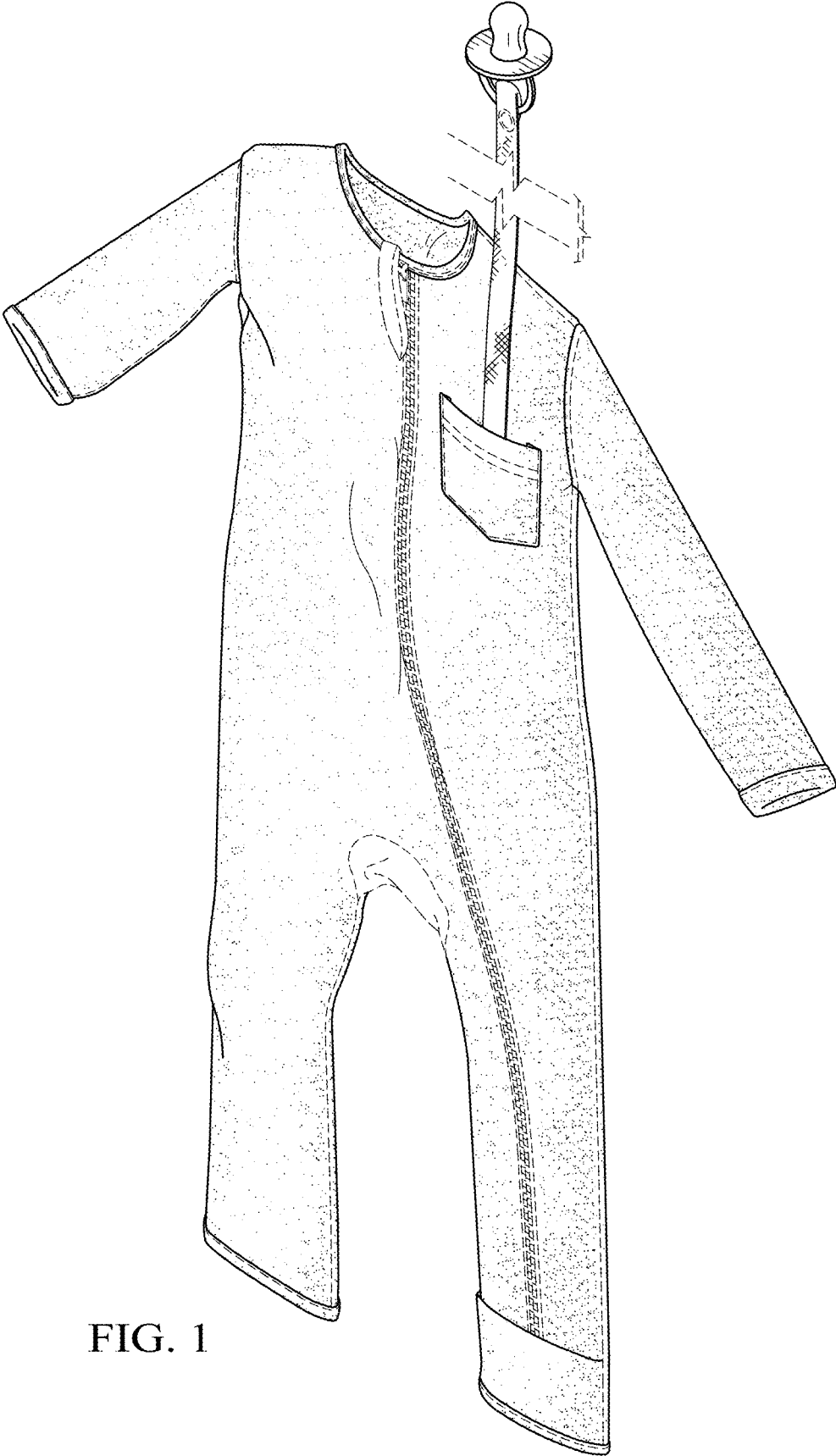

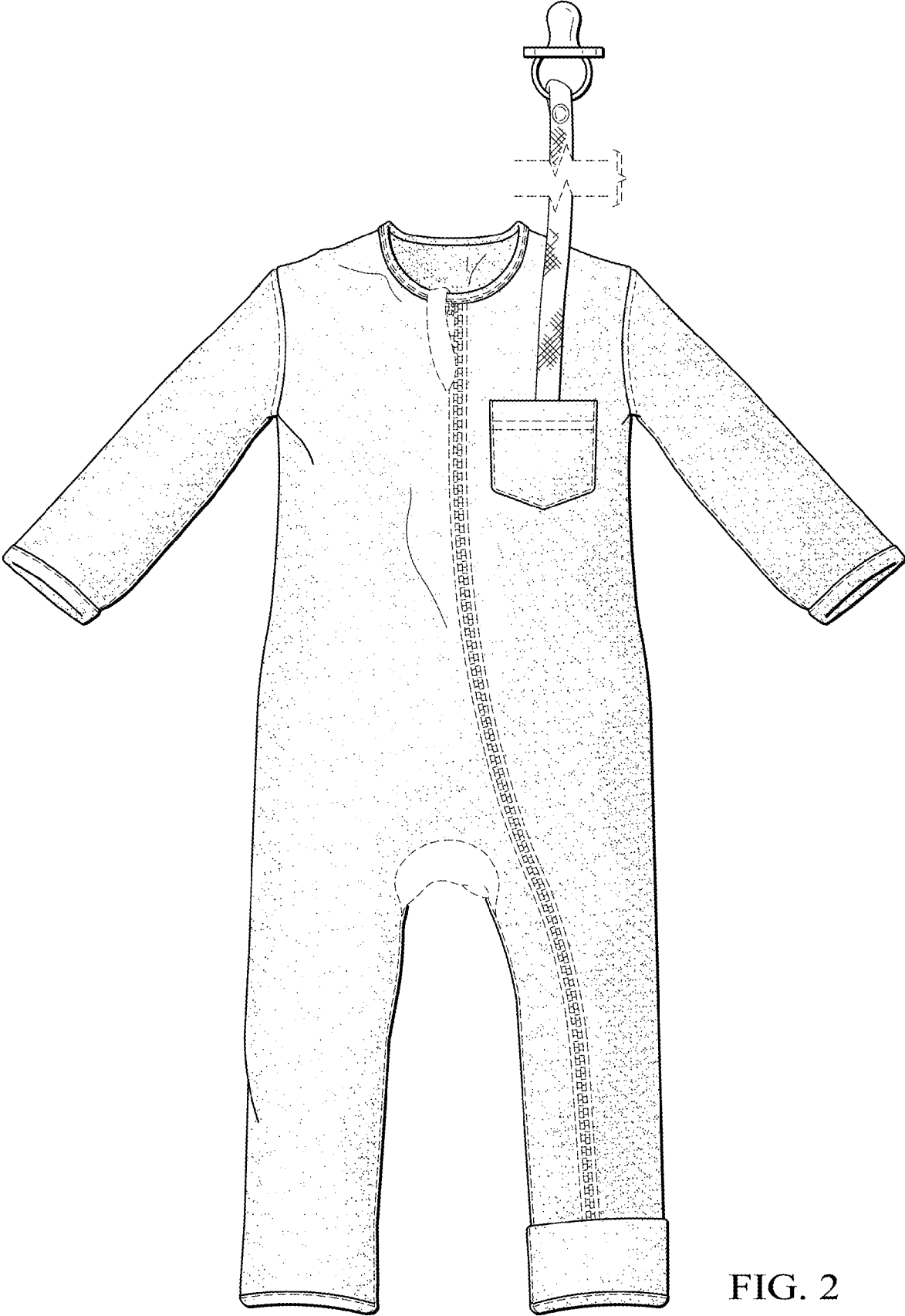
