(57) **CLAIM**


The ornamental design for a molded edger with sculpted face, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a molded edger having a sculpted face showing our new design; FIG. 2 is a front view thereof; FIG. 3 is a right side view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view thereof.

The broken lines in the drawing figures are included for the purpose of illustrating portions of the molded edger with sculpted face that form no part of the claimed design.









