

(57) **CLAIM**

The ornamental design for a portable device holder for dash,  
as shown and described.

**DESCRIPTION**

FIG. 1 is a front, right, top, perspective view of a portable  
device holder for dash showing our design therefor;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a right side elevational view thereof;  
FIG. 5 is a left side elevational view thereof;  
FIG. 6 is a top plan view thereof;
















