(57) **CLAIM**

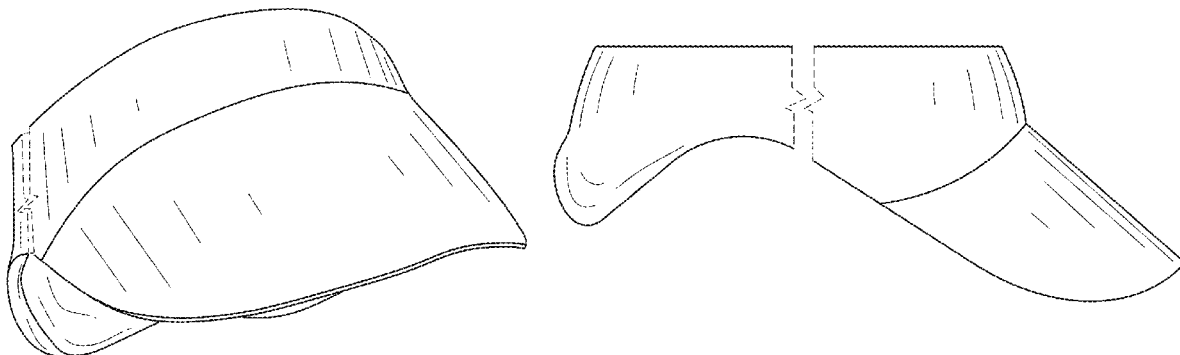
The ornamental design for a reversible visor cap, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the reversible visor cap showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof, the right side elevation view being a mirror image thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.
The reversible visor cap is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design. The symbolic break lines rendered by broken lines along the length of the visor form no part of the claimed design.

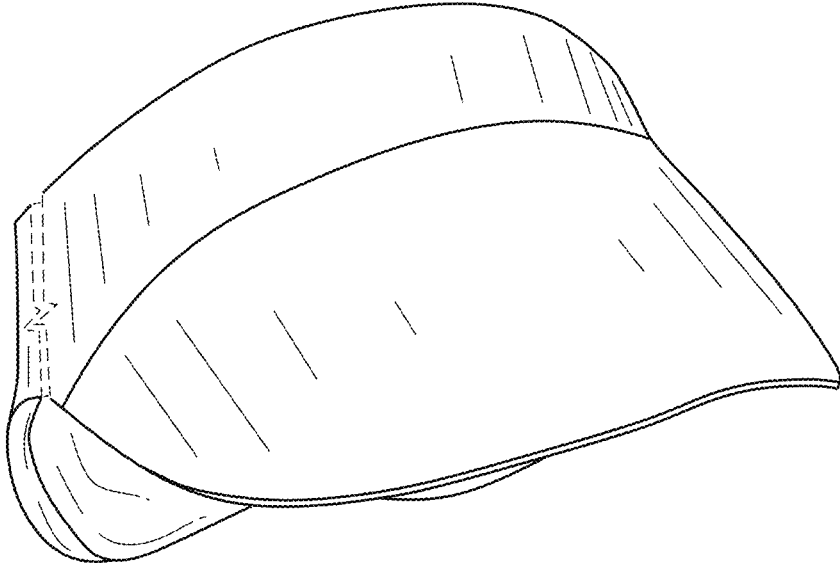

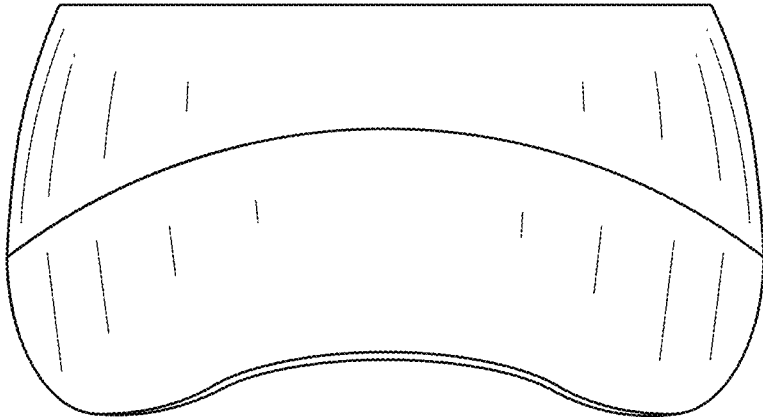

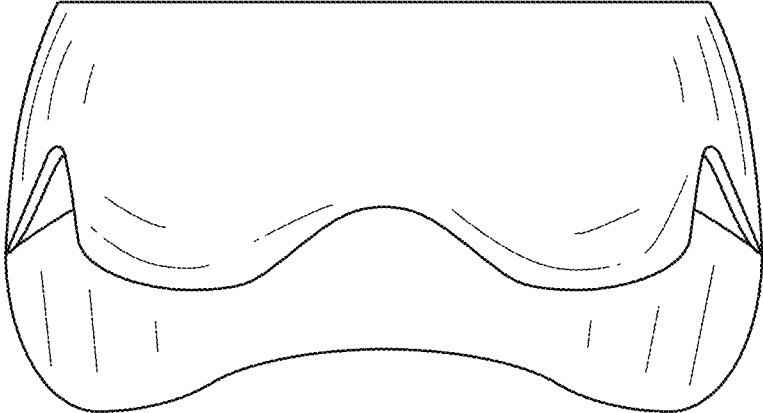

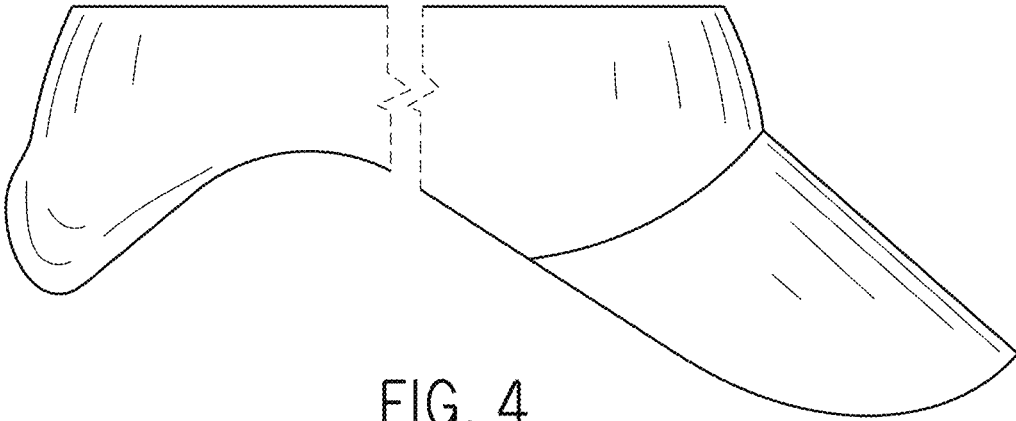

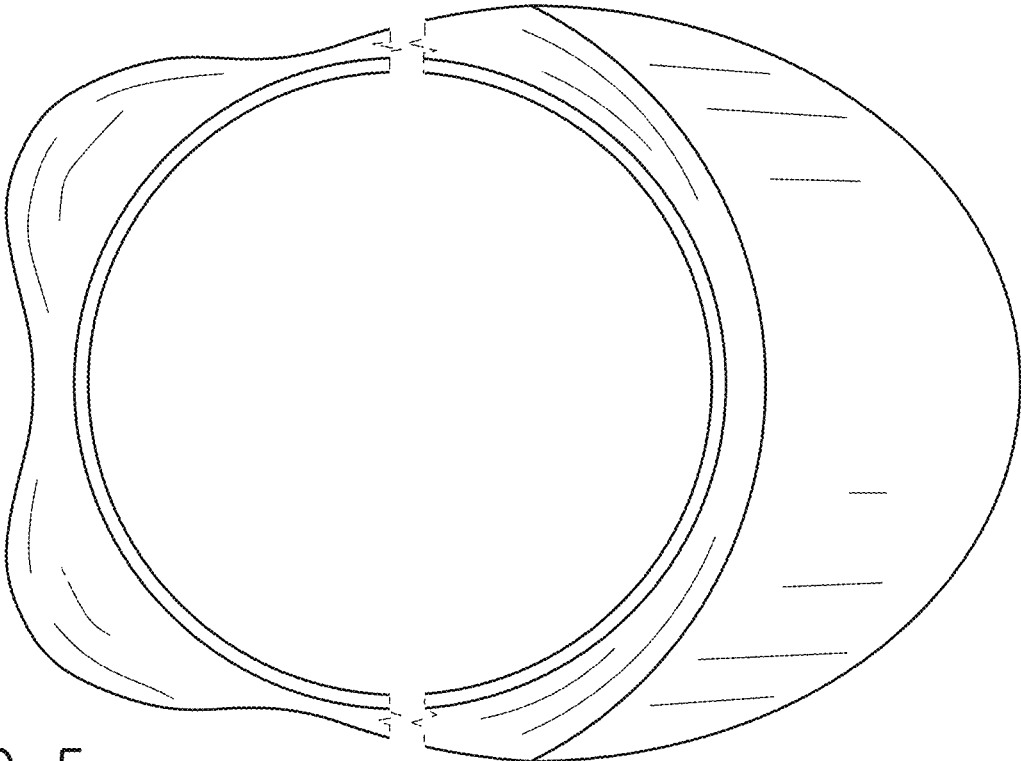

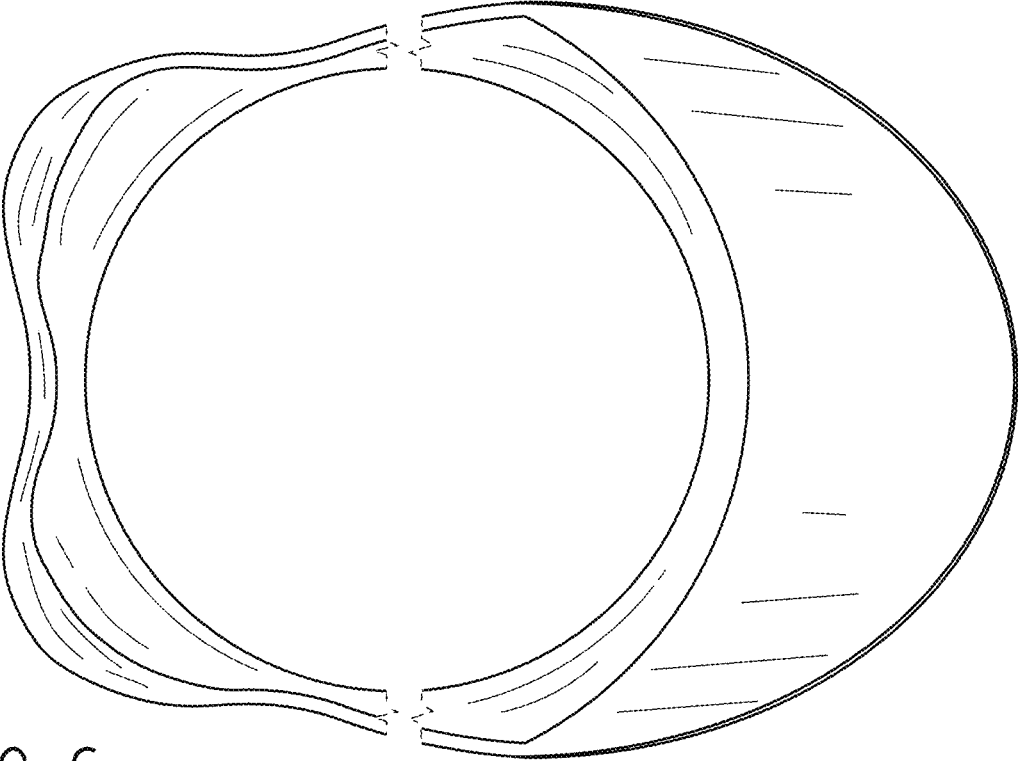
