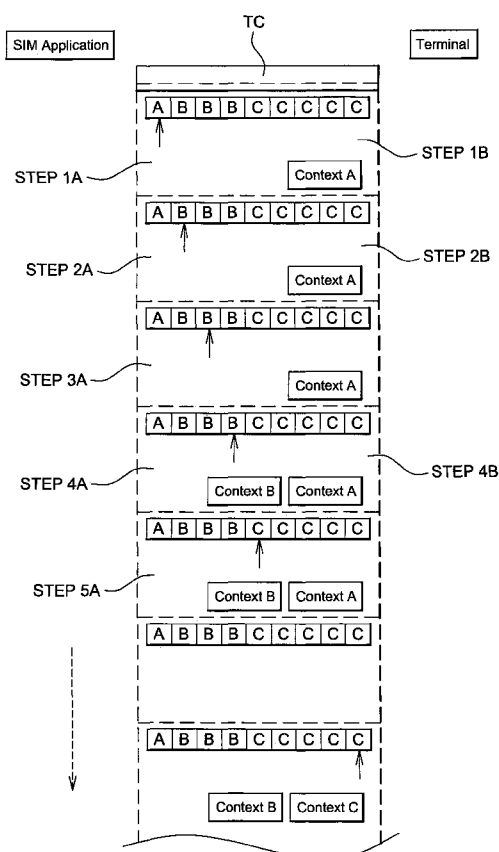

(54) Title: A THREAD CONTROLLER FOR SIMULTANEOUS PROCESS OF DATA TRANSFER SESSIONS IN A PERSONAL TOKEN



(57) Abstract: The invention relates to a personal token running a series of applications (A, B, C, D, E), characterized in that it comprises a thread controller (TC) which transmits data from the applications (A, B, C, D, E) to an external device (TS) in a cyclic way, a cycle being constituted of a series of data transfers (1A, 2A, 3A...) from the applications (A, B, C, D, E) and to the external device (TS), a cycle comprising a respective number of data transfers dedicated to each respective application (A, B, C, D, E) which is different according to the respective application (A, B, C, D, E), the number of data transfers for a respective application (A, B, C, D, E) in a cycle corresponding to a priority level of the application (A, B, C, D, E) as taken into account by the thread controller (TC).
