

(57) Abstract: The present invention provides gaming machine systems and methods that enable outsourced printing and generation of printed credit devices for use with a gaming machine. The ability to employ outsourced gaming printing services providers increases the number and sophistication of printed credit devices that may be manufactured and distributed to potential customers.
