The ornamental design for a food container, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view showing my new design for a food container, including a base and a lid.

FIG. 2 is a top perspective view of the food container shown in FIG. 1, with the lid separated from the base.

FIG. 3 is bottom perspective view of the food container shown in FIG. 1, with the lid separated from the base.

FIG. 4 is a side view of the food container shown in FIG. 1.

FIG. 5 is a side view of the food container shown in FIG. 1, with the lid separated from the base.

FIG. 6 is an end view of the food container shown in FIG. 1.

FIG. 7 is an end view of the food container shown in FIG. 1, with the lid separated from the base.

FIG. 14 is a side view of the food container shown in FIG. 10, with the lid separated from the base.


FIG. 15 is an end view of the food container shown in FIG. 10.





































