
(57) **CLAIM**

The ornamental design for a pushover trailer axle jack stand, as shown and described.

DESCRIPTION

FIG. 1 is a side exploded perspective view of a pushover trailer axle jack stand of the claimed design; FIG. 2 is front exploded perspective of FIG. 1; FIG. 3 is another front exploded perspective view thereof; FIG. 4 is a rear exploded perspective view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a front view thereof; FIG. 7 is a rear view thereof; FIG. 8 is a left side view thereof; and, FIG. 9 is a top view thereof. The peg is not shown in FIGS. 5 through 9 for convenience of illustration.


















