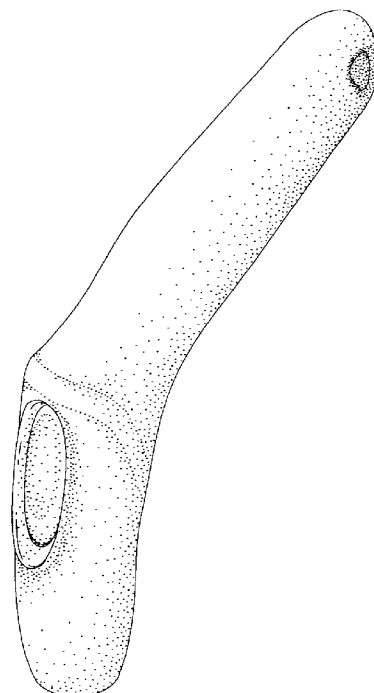

The ornamental design for a handle grip, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a handle grip, embodying our new design;
FIG. 2 is a side elevational view with the opposite side being a mirror image thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a back elevational view thereof; and,
FIG. 6 is a bottom view thereof.

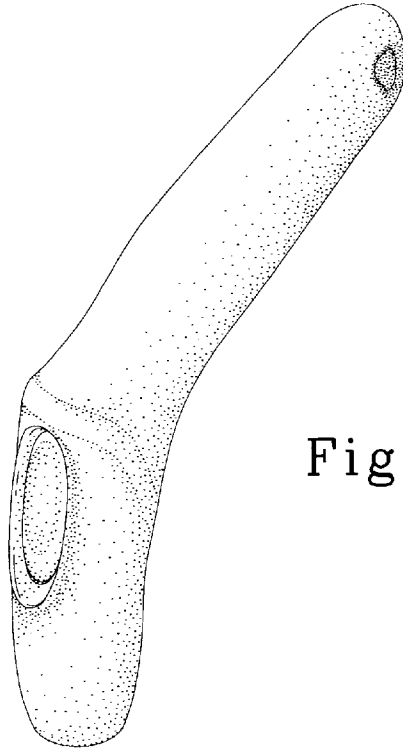

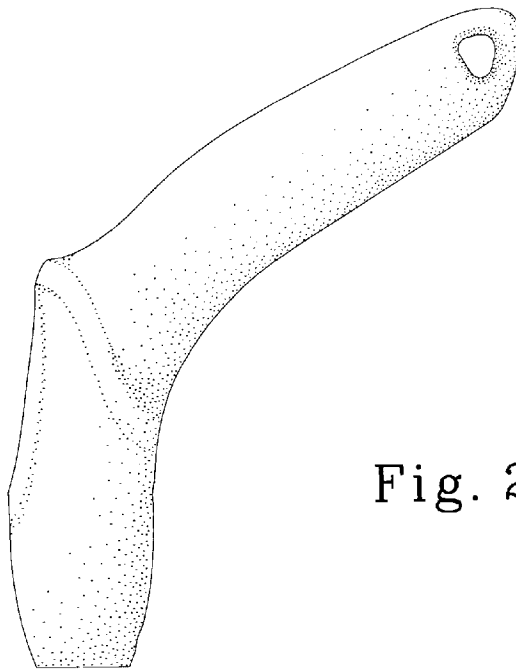

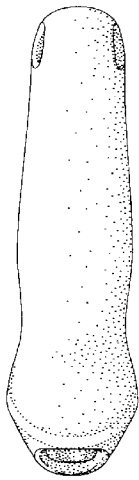

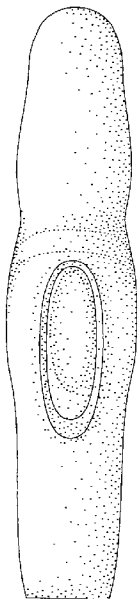

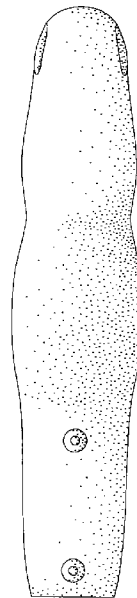

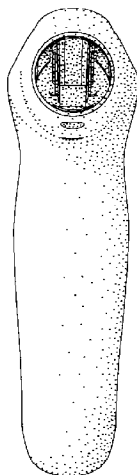
