(57) **CLAIM**

The ornamental design for a supporter for monitor/television, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a supporter for monitor/television showing our new design;

FIG. 2 is a front elevational view thereof;

FIG. 3 is a perspective view thereof in the lift-up position;

FIG. 4 is a front elevational view thereof in the lift-up position;

FIG. 5 is a right side elevational view thereof in the lift-up position;

FIG. 6 is a left side elevational view thereof in the lift-up position;

FIG. 7 is a top plan view thereof in the lift-up position; and,

FIG. 8 is a bottom plan view thereof.

The broken line showing of parts of the supporter for monitor/television is included for the purpose of illustrating portions of the article and forms no part of the claimed design.















