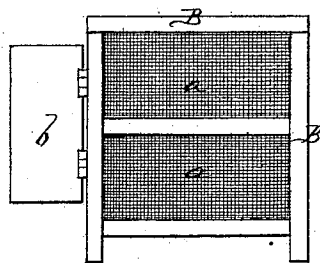
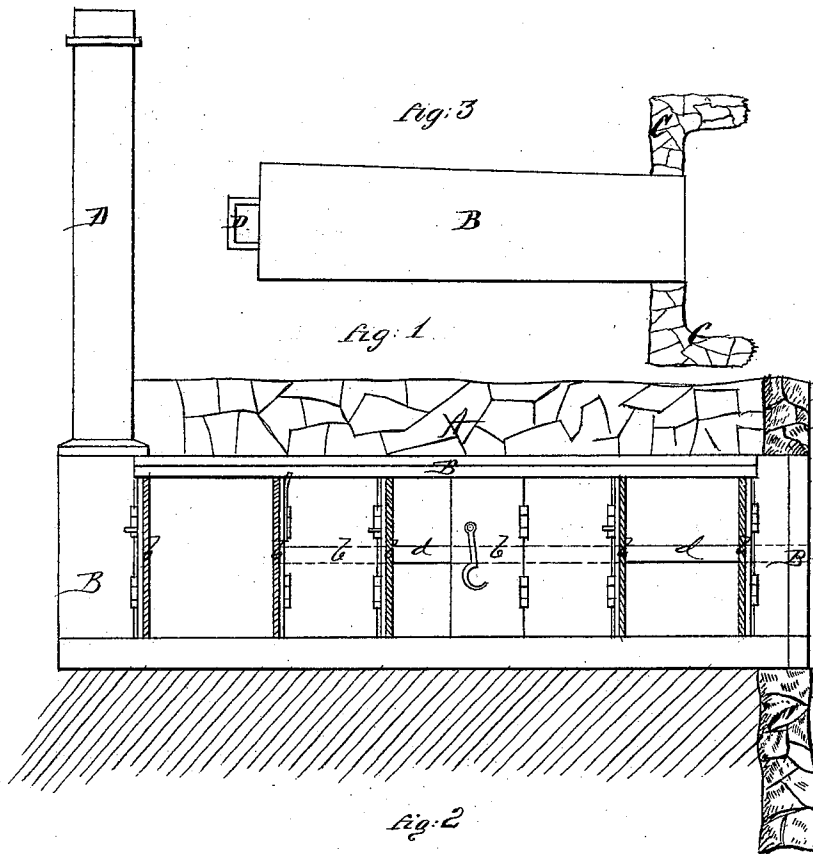

HENRY PEREGOY, OF MOUNT CARMEL, MARYLAND.

Letters Patent No. 110,784, dated January 3, 1871.

## IMPROVEMENT IN MILK-HOUSES.

The Schedule referred to in these Letters Patent and making part of the same.

*To all whom it may concern:*

Be it known that I, HENRY PEREGOY, of Mount Carmel, in the county of Baltimore, and in the State of Maryland, have invented certain new and useful Improvements in Air-Dairy; and do hereby declare that the following is a full, clear, and exact description thereof, reference being had to the accompanying drawing and to the letters of reference marked thereon, making a part of this specification.

The nature of my invention consists in the construction and arrangement of an "air-dairy," to be placed in a well-house, as will be hereinafter fully set forth.

In order to enable others skilled in the art to which my invention appertains to make and use the same, I will now proceed to describe its construction and operation, referring to the annexed drawings, in which—

Figure 1 is a front view of my air-dairy, with a section of the wall of the well;

Figure 2 is a view of that end of the dairy which is inserted in the well; and

Figure 3 is a section of the well showing the end of the dairy.

A represents the walls of a well-house, usually sunk a few feet into the ground.

In this well-house is placed an oblong box, B, of suitable dimensions, one end of said box being open and covered with wire-cloth, *a*.

This end of the box B is inserted through the wall of the well C, so that the wire-cloth will be flush, or nearly flush, with the inside of the well.

At the other end of the box B is a chimney, D, extending up through the roof of the well-house a suitable distance above ground.

The front side of the box B is provided with a number of doors, *b*, and inside of the box are one or more horizontal shelves, *d*.

The milk-pans are to be placed on the bottom and shelves of the box B, and the doors closed, when the milk will soon be cooled and kept at the proper temperature.

Having thus fully described my invention,

What I claim as new, and desire to secure by Letters Patent, is—

The arrangement within a well-house of the rectangular box B, provided with shelves and doors, as described, one end of said box having wire-cloth *a*, and inserted in the side of the well, while the other end has a chimney passing up through the top of the well-house, as herein set forth.
