(57) **CLAIM**

The designs for a food grater, as shown and described.

FIG. 1 is a top perspective view of the design for a food grater of the invention;

FIG. 2 is top plan view of a first embodiment of the food grater of FIG. 1;

FIG. 3 is a left side elevational view, viewing FIG. 2, of the food grater of FIG. 1;

FIG. 4 is right side elevational view, viewing FIG. 2, of the food grater of FIG. 1;

FIG. 5 is a left end elevational view, viewing FIG. 3, of the food grater of FIG. 1;

FIG. 6 is a right end elevational view, viewing FIG. 3, of the food grater of FIG. 1;

FIG. 7 is a bottom plan view of the food grater of FIG. 1;

FIG. 8 is top perspective view of a second embodiment of the food grater of the invention having the same end and side designs of the foregoing embodiment described with reference to FIGS. 1-7;

FIG. 9 is a top plan view of a second embodiment of the food grater of the invention;


FIG. 10 is a top plan view of the second embodiment of FIG. 8 of the food grater of the invention;






















