The ornamental design for a universal valve for foley type urinary catheter, as shown and described.

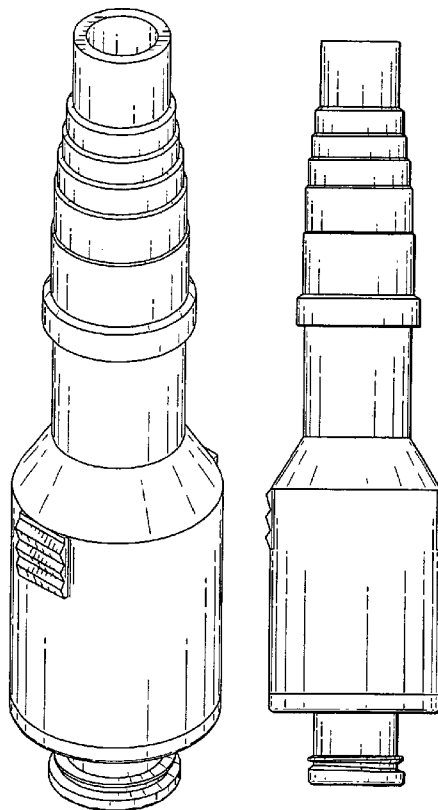

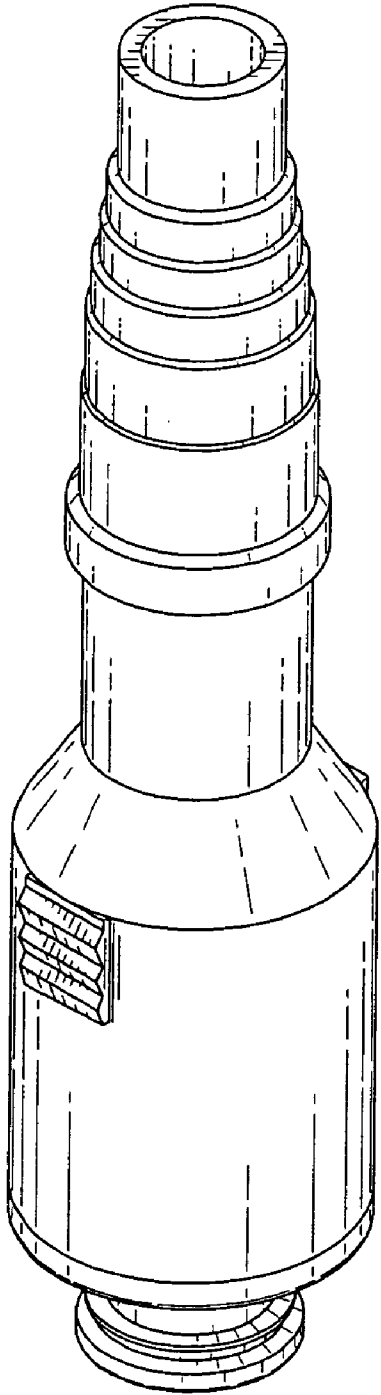

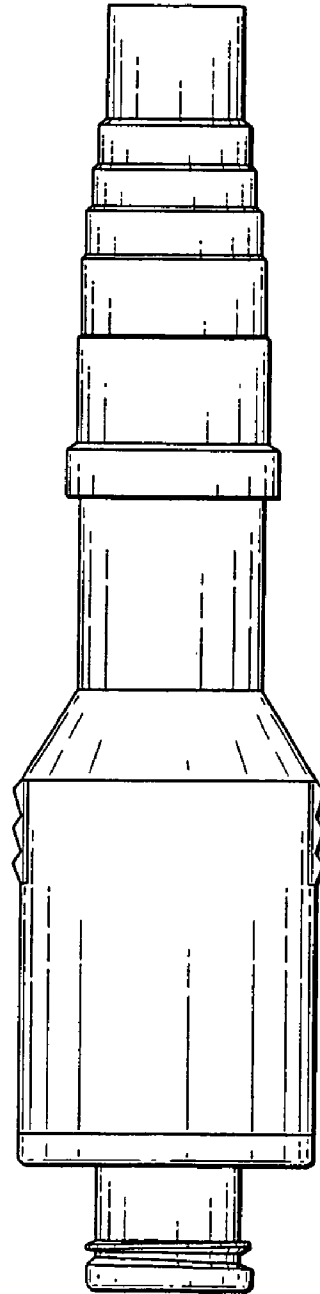

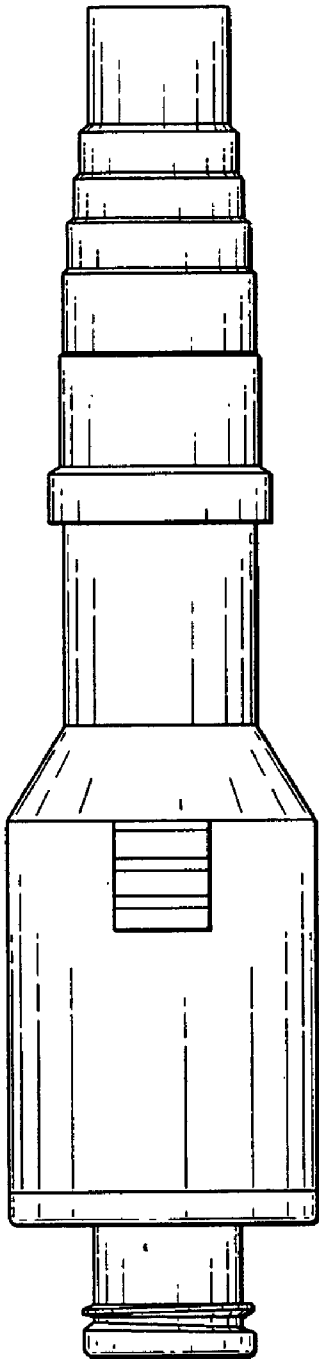

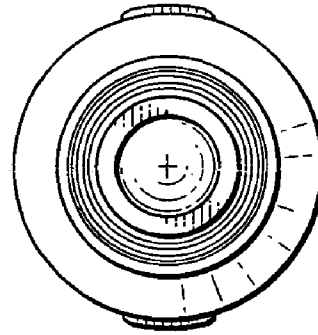
