

Process for making up the skin (P), comprising the steps consisting in: a) applying a foundation composition (1), and b) a corrective composition (81), the corrective composition comprising visible substances (4) that give it an inhomogeneous appearance, the said visible substances (4) preferable being coloured fibres (indepdenedent claim 27). A kit comprising at least said (a) foundation composition (1), (b) a device (40) for locally removing and/or moving foundation (1) deposited on the skin, and c) optionally, a screen (50) with holes, and d) optionally, a system (210) for spraying material (independent claim 50).
