DESCRIPTION

FIG. 1 is a front, side and top perspective view of a cooling stand showing my new design;

FIG. 2 is a back, side and top perspective view thereof;

FIG. 4 is a back elevational view thereof;


FIG. 5 is a left side elevational view thereof; The right side elevational view is a mirror image of the left side; and,












