The ornamental design for a wrist rest, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the wrist rest.

FIG. 2 is a top view of the wrist rest.

FIG. 3 is a front view of the wrist rest.

FIG. 4 is a back view of the wrist rest.

FIG. 5 is a left side view of the wrist rest.

FIG. 6 is a right side view of the wrist rest; and,

FIG. 7 is a bottom view of the wrist rest.

The broken lines shown in FIG. 1 are included for the purpose of illustrating environmental structure and form no part of the claimed design.








