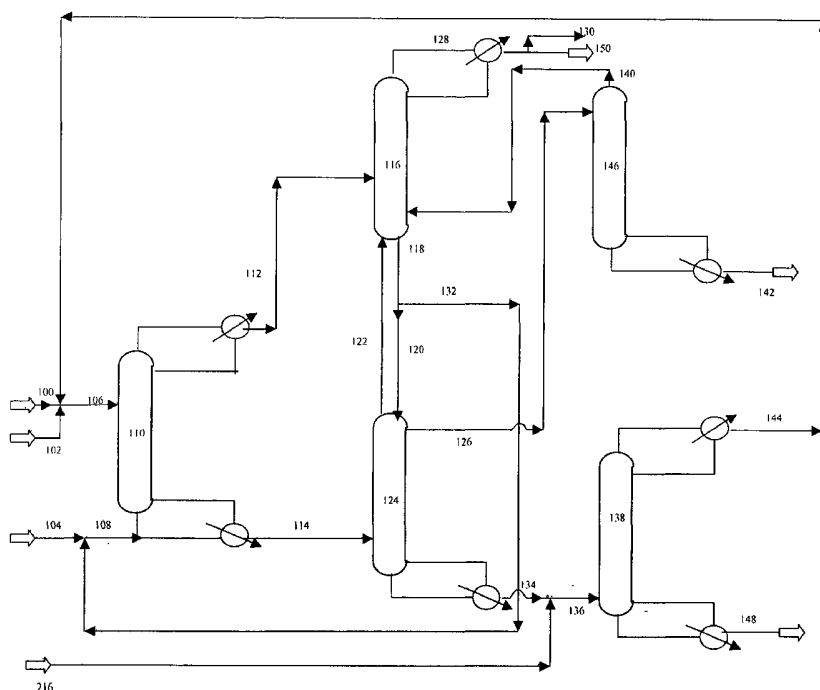

(54) Title: METHOD AND APPARATUS FOR WASTE STREAM RECOVERY



(57) Abstract: A method for recovering a product mixture from a waste stream in a diaryl carbonate manufacturing process comprising reacting the waste stream with an alkyl alcohol to form a reaction mixture, and separating the product mixture from the reaction mixture.
