The ornamental design for a shoe outsole, as shown and described.

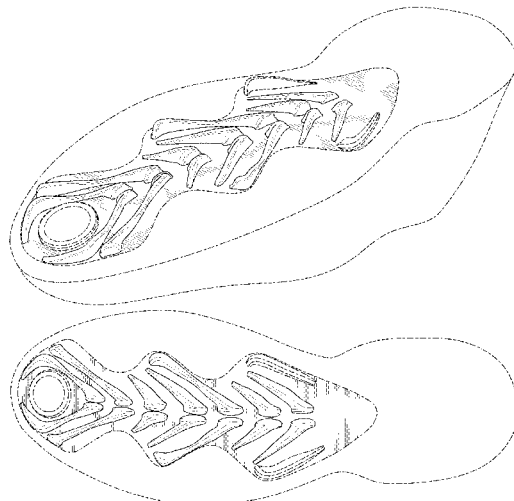
**DESCRIPTION**

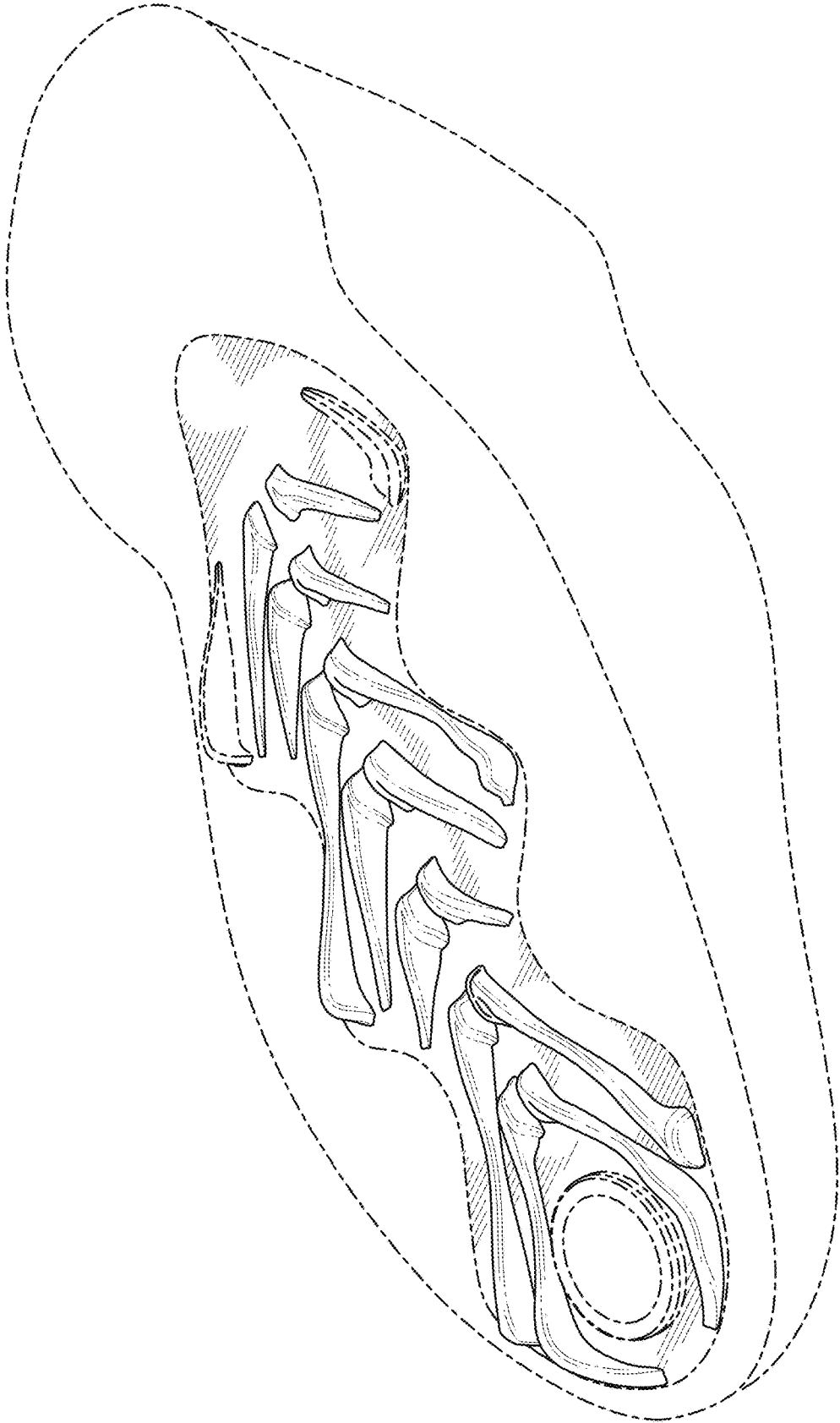

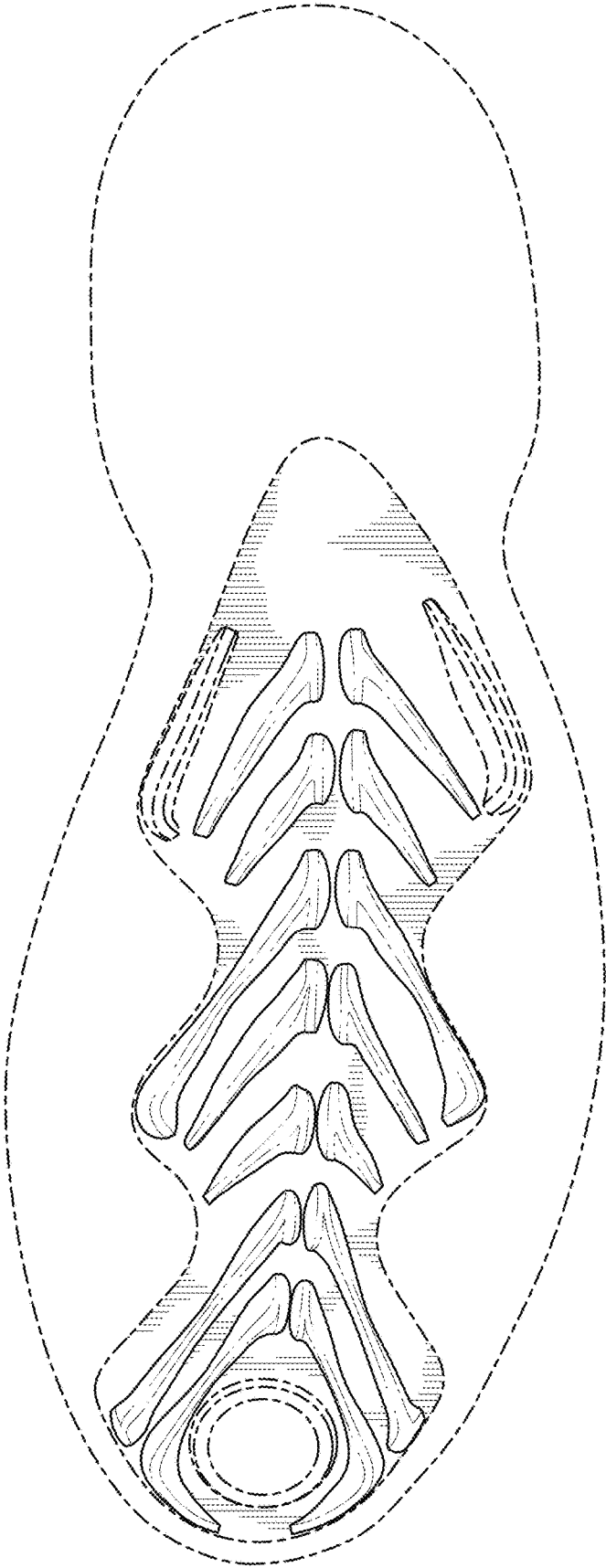

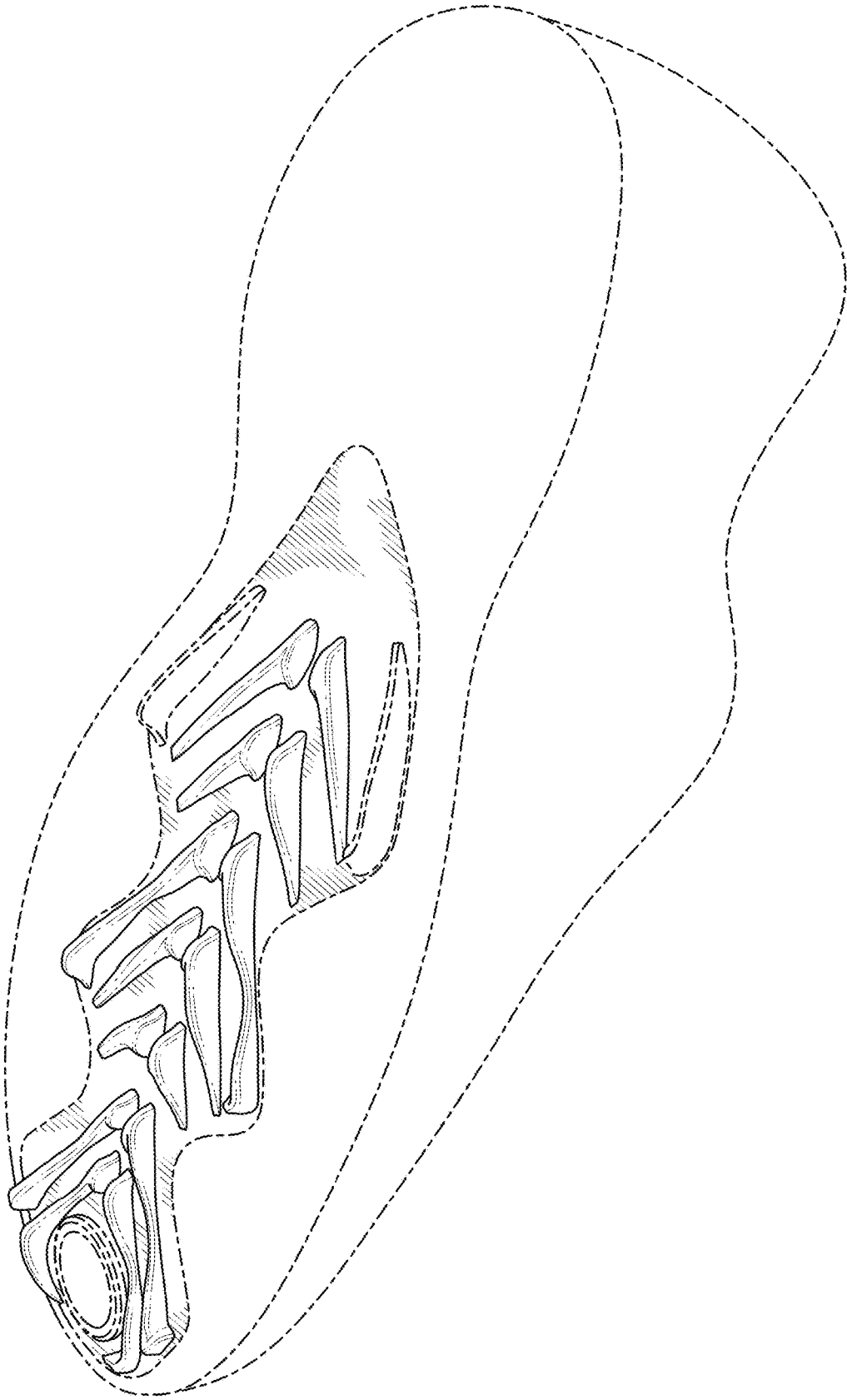
