(57) **CLAIM**


The ornamental design for a surgical guide, substantially as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a surgical guide configured in accordance with the present invention;  
 FIG. 2 is another perspective view thereof, shown in the context of a tibia;  
 FIG. 3 is yet another perspective view thereof, also shown in the context of a tibia;  
 FIG. 4 is a front view thereof;  
 FIG. 5 is a rear view thereof;  
 FIG. 6 is a right side view thereof;  
 FIG. 7 is a left side view thereof;  
 FIG. 8 is a top view thereof; and,  
 FIG. 9 is a bottom view thereof.

The broken line showing of the surgical guide is included for the purpose of illustrating portions of the “surgical guide” and forms no part of the claimed design.


















