
[57] **CLAIM**

The ornamental design for a batter bowl, as shown and described.

DESCRIPTION

FIG. 1 is a top, rear and side perspective view of a batter bowl showing my new design;
FIG. 2 is an exploded perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevation view thereof;
FIG. 6 is a rear elevation view thereof;
FIG. 7 is a right side view thereof;
FIG. 8 is a left side view thereof; and,
FIG. 9 is a cross-section view thereof, taken on line 9—9 in FIG. 3.
















