The ornamental design for a debossed chewing gum stick, as shown and described.

DESCRIPTION

FIG. 1 is a right perspective view of a debossed chewing gum stick showing our new design;

FIG. 3 is a rear elevation view of FIG. 1;

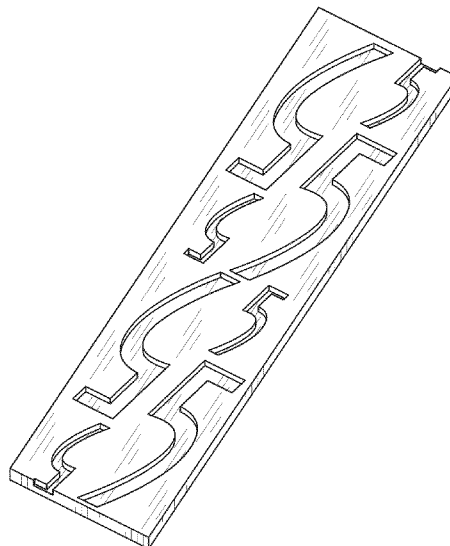
FIG. 4 is a left side elevation view of FIG. 1;

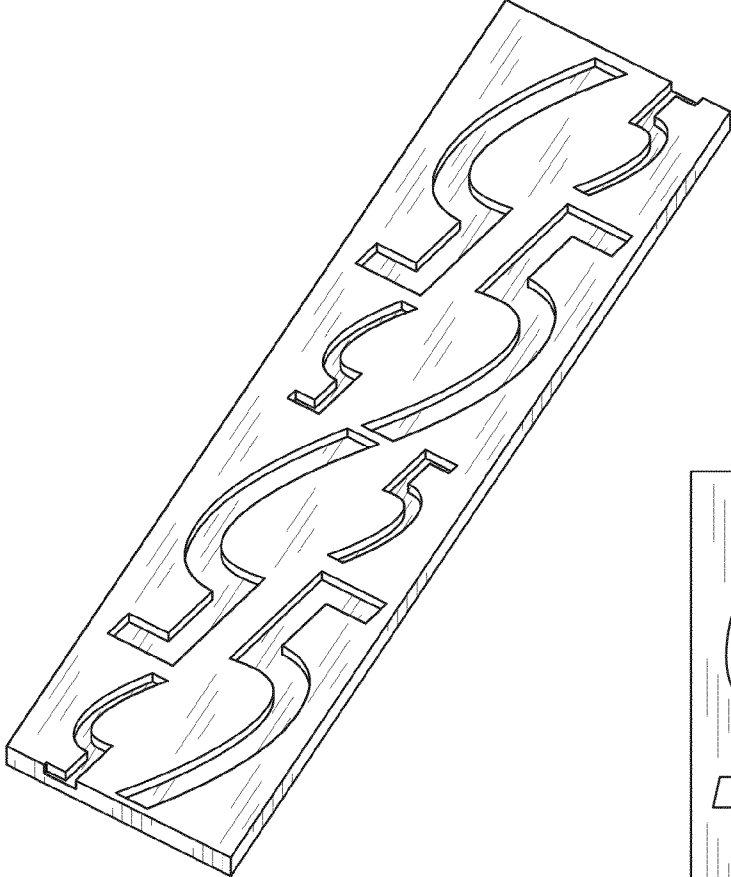

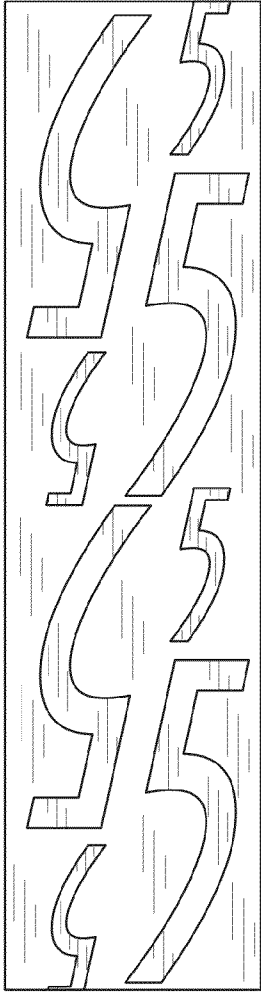

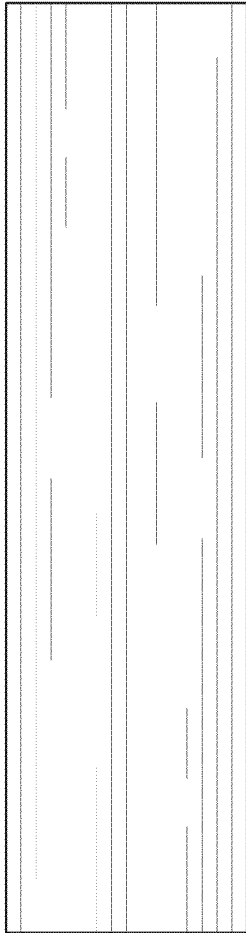
