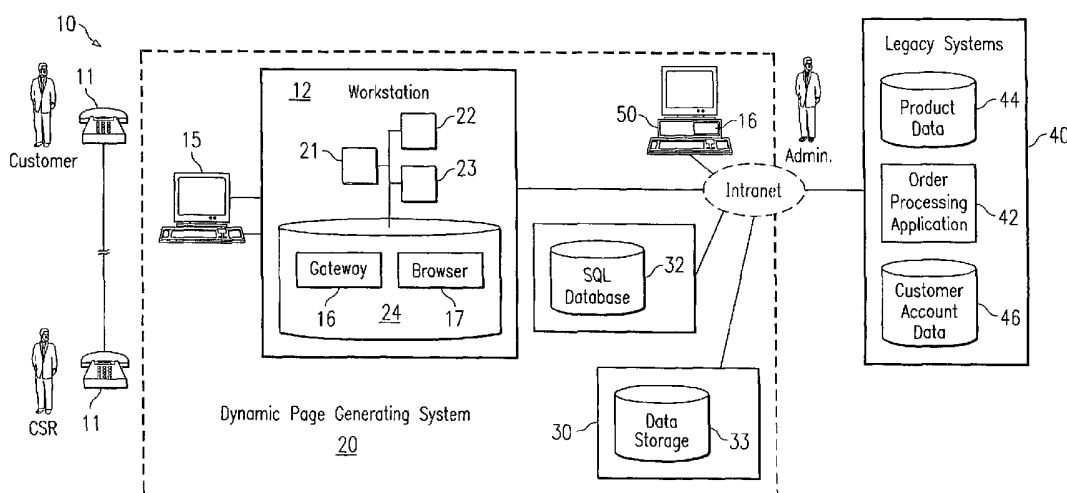

(54) Title: SYSTEM AND METHOD FOR DYNAMICALLY GENERATING CUSTOMIZED PAGES



(57) Abstract: A disclosed method provides for dynamic generation of pages for a user interface. Operations within the method may include retrieving a panel template and searching the panel template for links. In response to locating a link, a page generator may automatically attempt to locate a corresponding link condition. In response to locating the corresponding link condition, the page generator may automatically evaluate that link condition. In response to receiving an evaluation of true for the link condition, the page generator may automatically include the link in a customized page. However, in response to receiving an evaluation of false for the link condition, the page generator may automatically omit the link from the customized page. The customized page may then be displayed in a workstation. In an example embodiment, macros may be used to further customize the page.
