The ornamental design for a car stereo, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a car stereo, showing our new design;

FIG. 2 is a front perspective view thereof, shown with a portable phone in the environmental use;

FIG. 3 is a front elevation view thereof;

FIG. 4 is a rear elevation view thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof;


FIG. 7 is a left side elevation view thereof; and,

FIG. 8 is a right side elevation view thereof.

The car stereo has a front chamber for holding a portable phone which can transfer received calls to the car stereo except common functions.














