(57) **CLAIM**

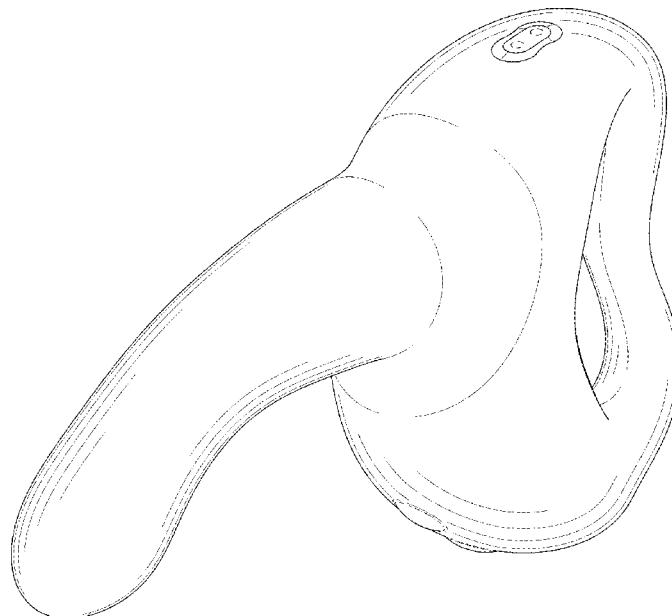
The ornamental design for an adult toy, as shown and described.

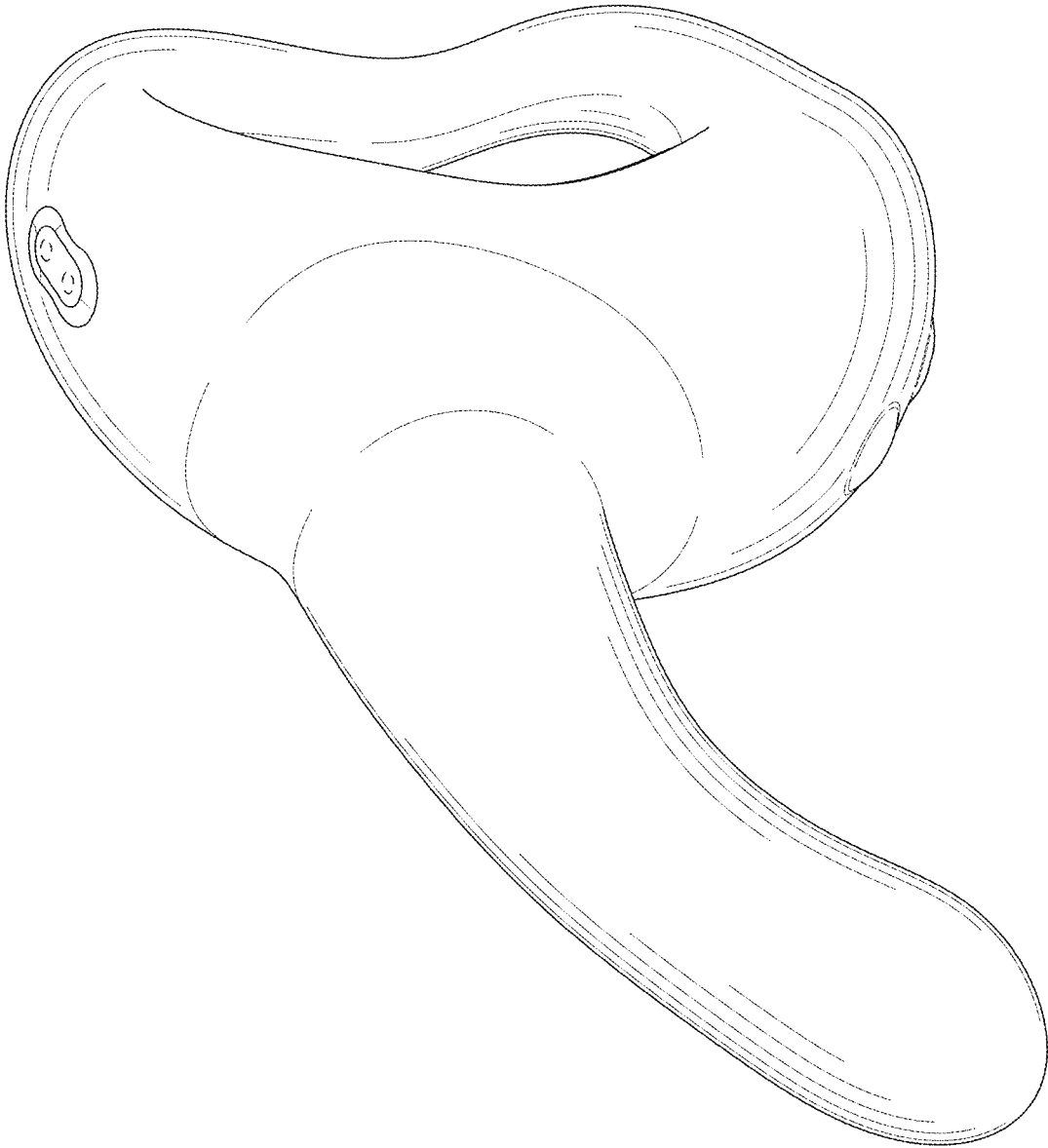

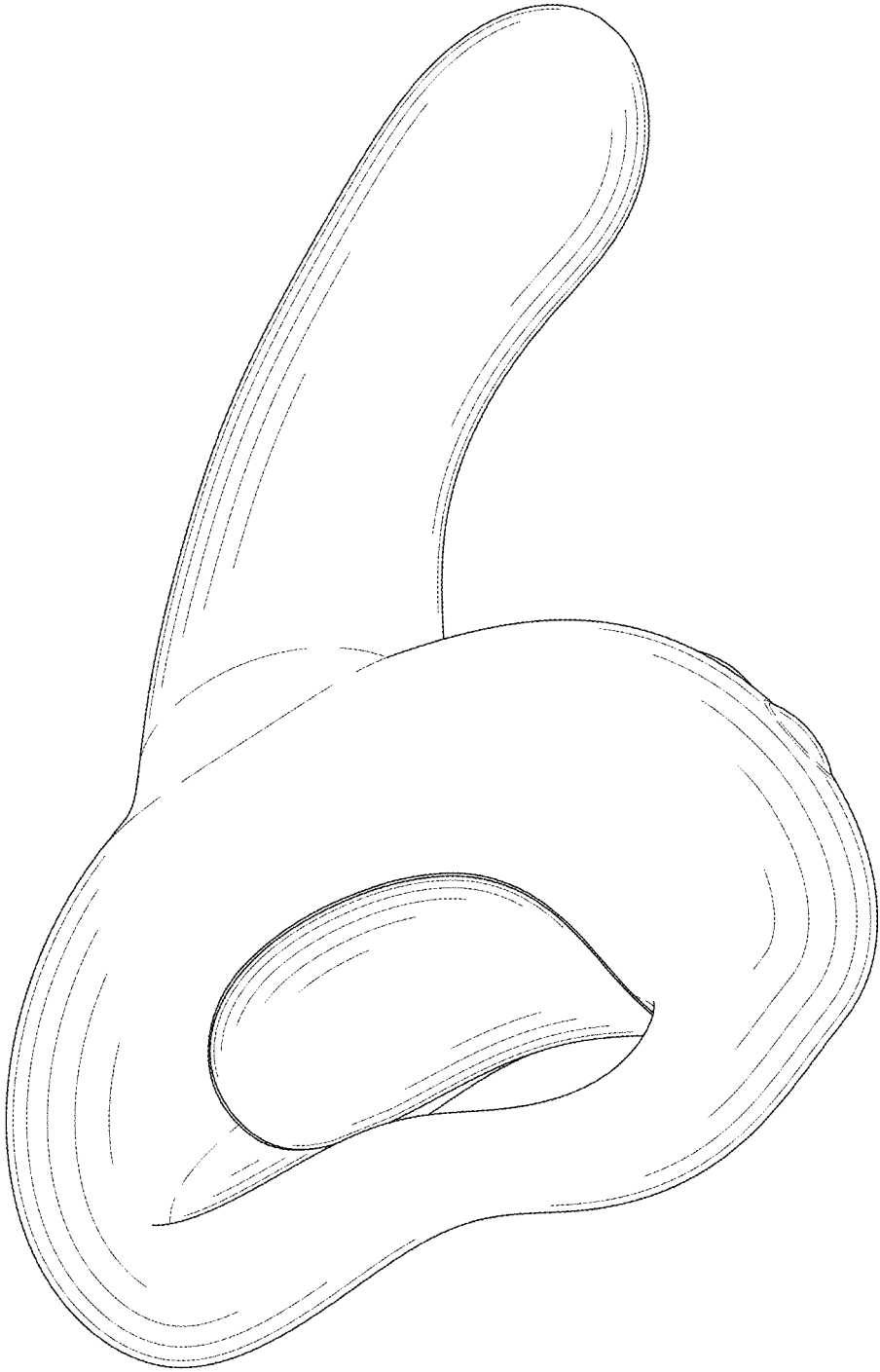

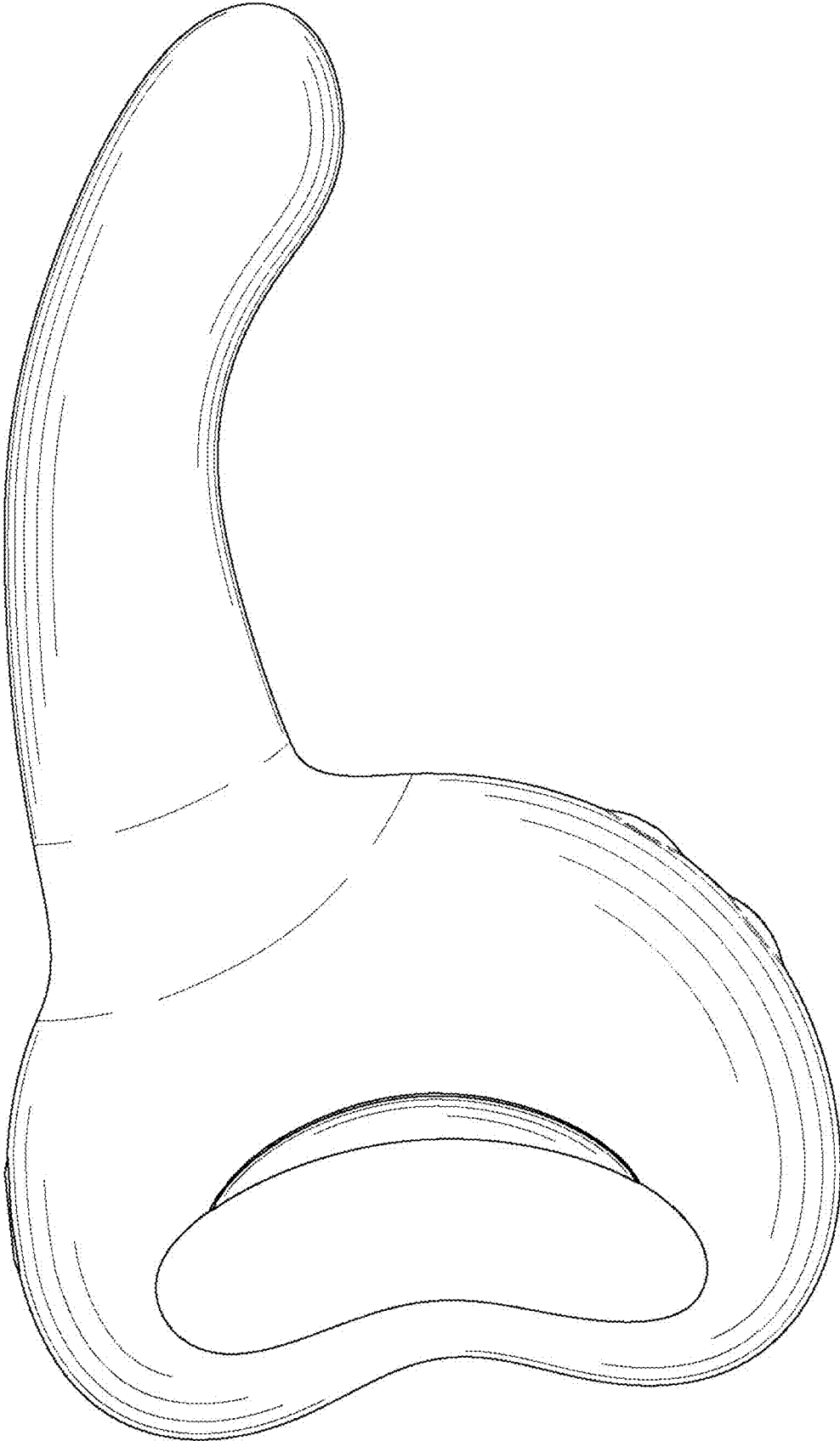

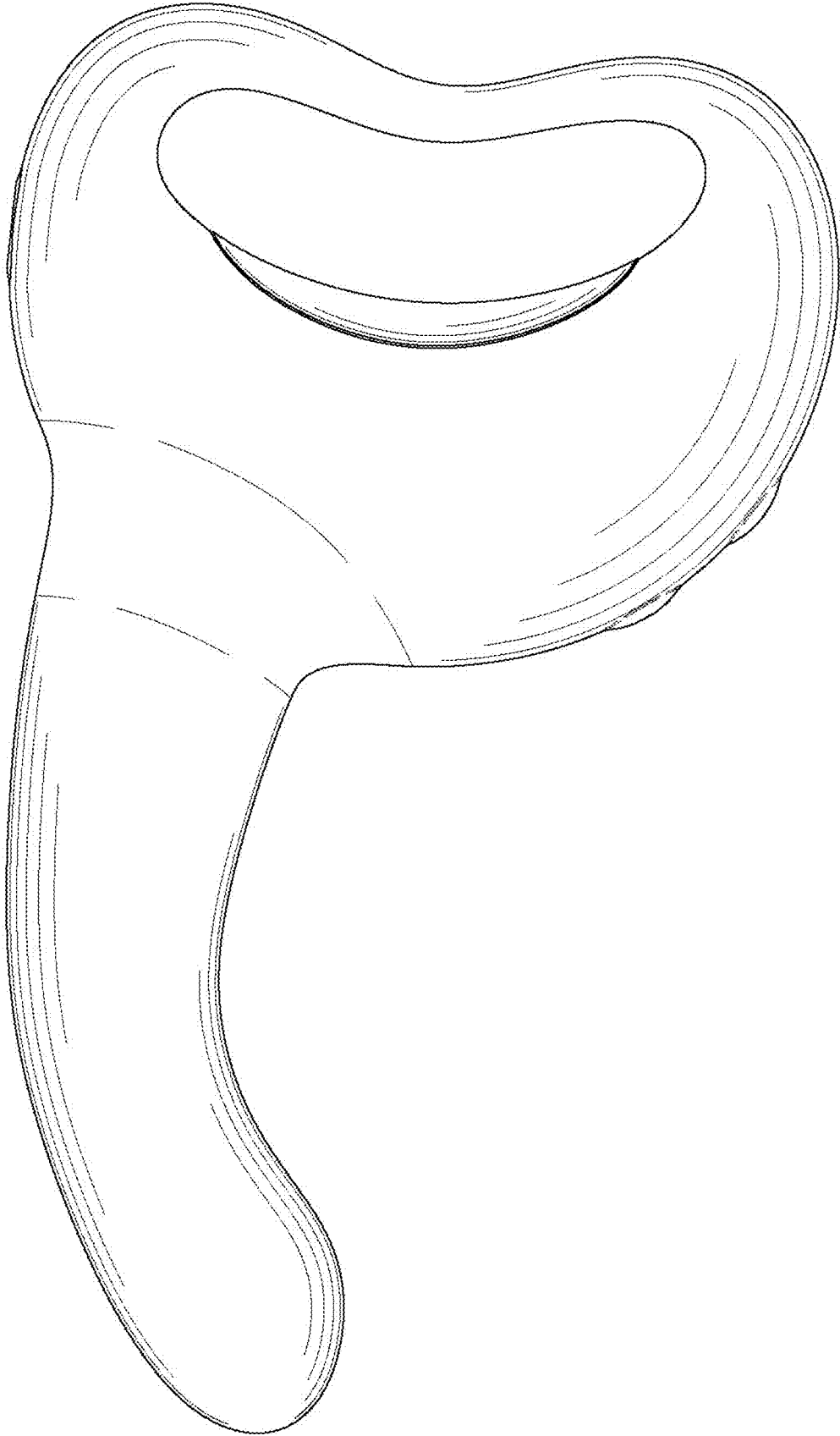

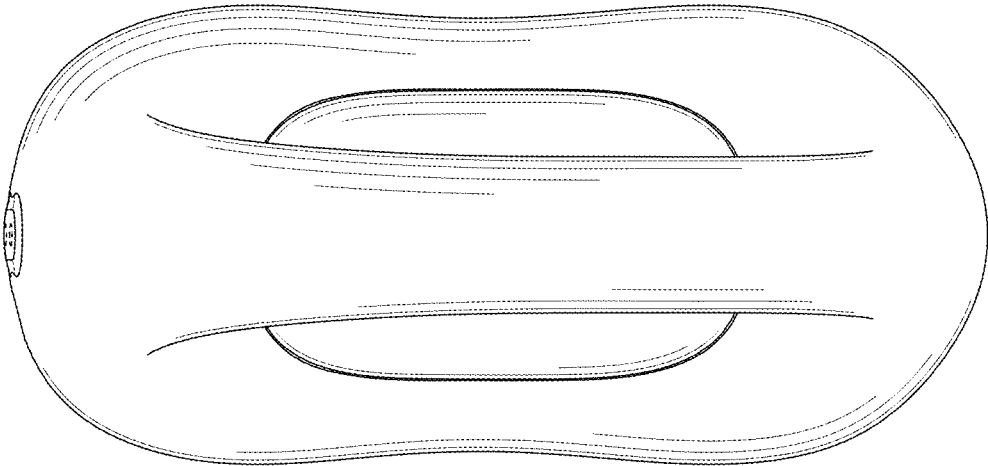

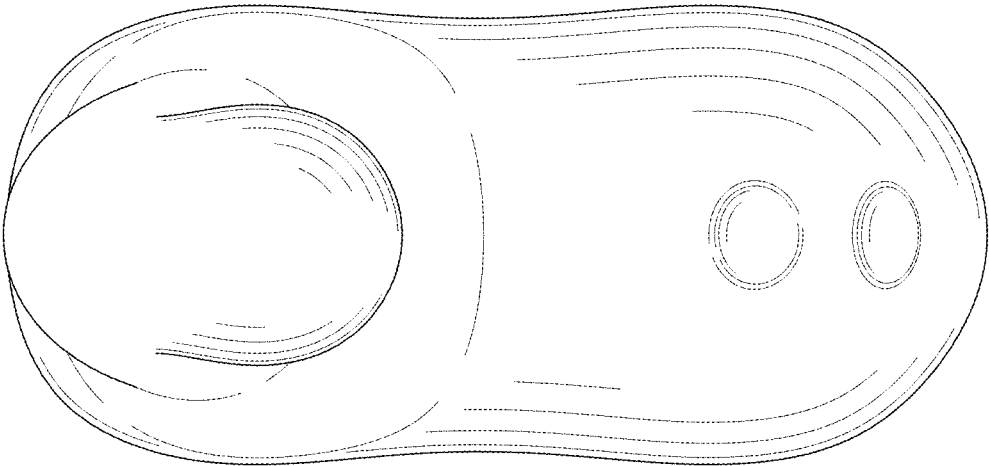

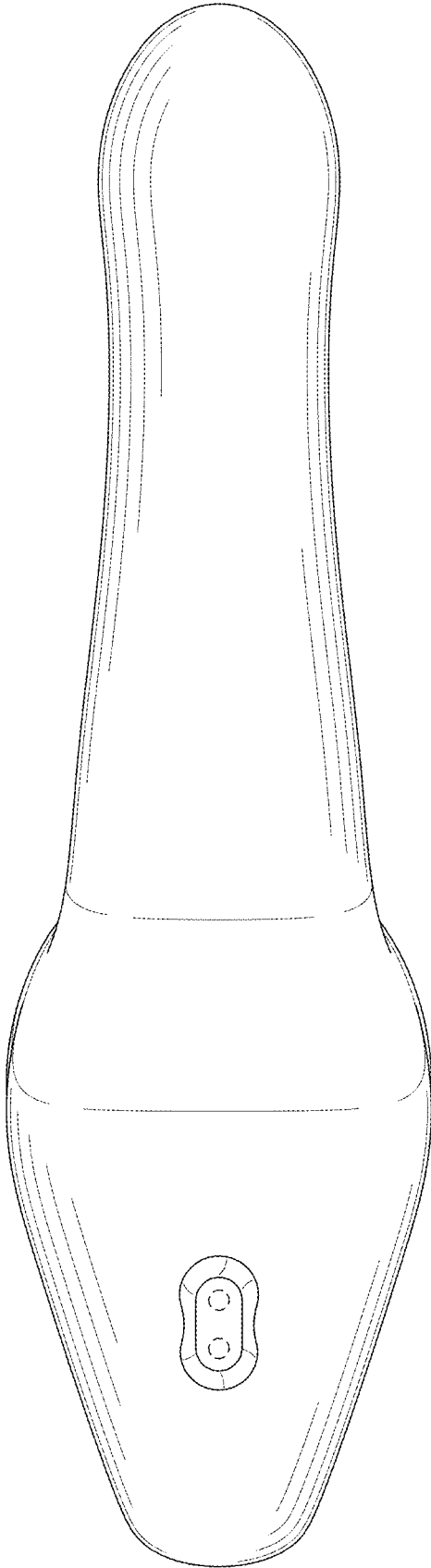

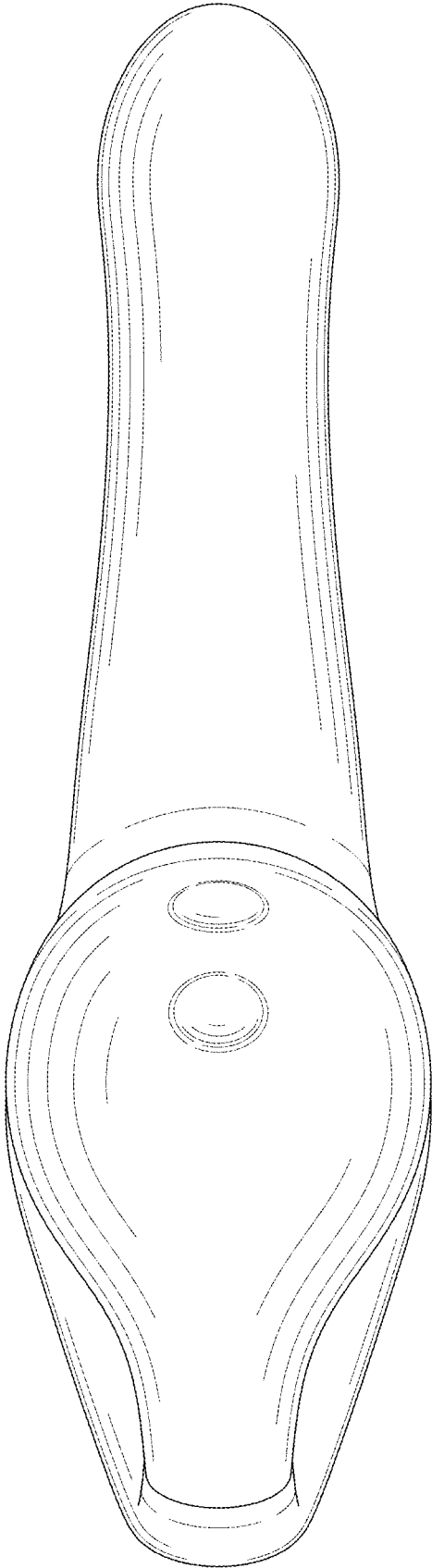
