(57) **CLAIM**

The ornamental design for an interchangeable lens for camera, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an interchangeable lens for camera showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a reduced perspective view of the interchangeable lens thereof.
The broken lines depicting a camera hood in FIG. 8 are shown to illustrate environment only and form no part of the claimed design.
















