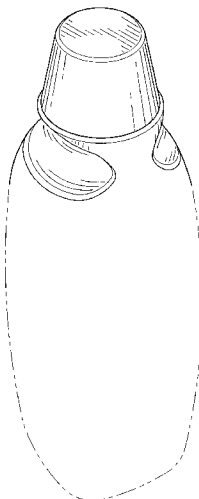
(57) **CLAIM**

The ornamental design for a top portion of a liquid dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the ornamental design top portion of a liquid dispenser showing our design; FIG. 2 is a front view top portion of a liquid dispenser; FIG. 3 is a side view top portion of a dispenser; and, FIG. 4 is a top view top portion of a dispenser. The broken lines shown in the drawings are for illustrative purposes only and forms no part of the claimed design.

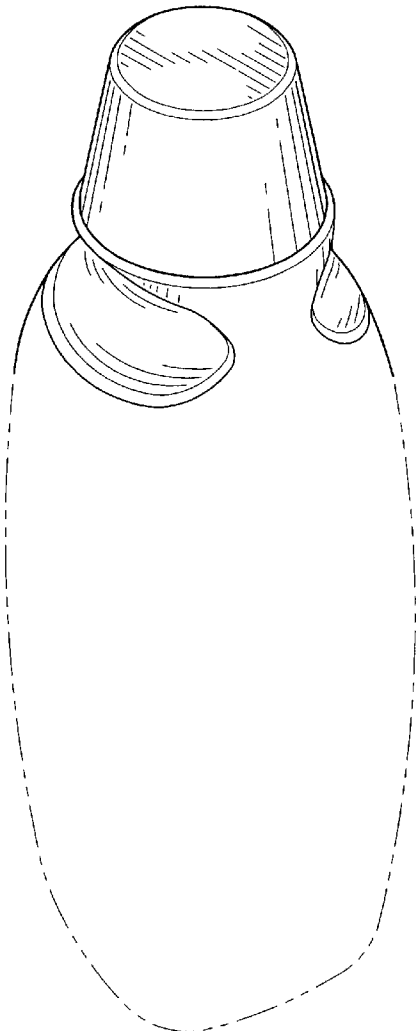

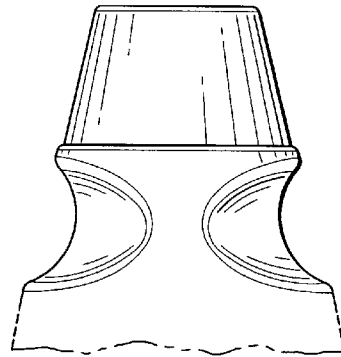

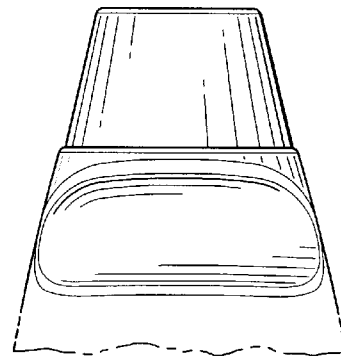

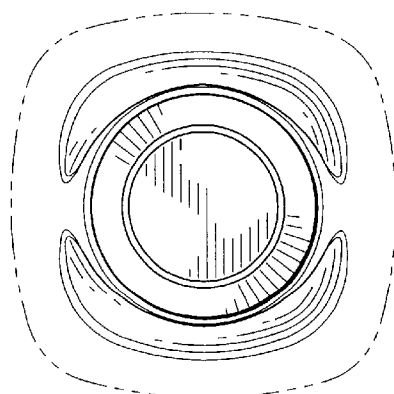
