(57) **CLAIM**

The ornamental design for a child’s chair, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the child’s chair showing our new design;

FIG. 2 is a front perspective view thereof;


FIG. 3 is a side elevation view thereof;

FIG. 4 is a top plan view thereof; and,

FIG. 5 is a rear elevation view thereof wherein the broken lines represent stitching.










