DESCRIPTION

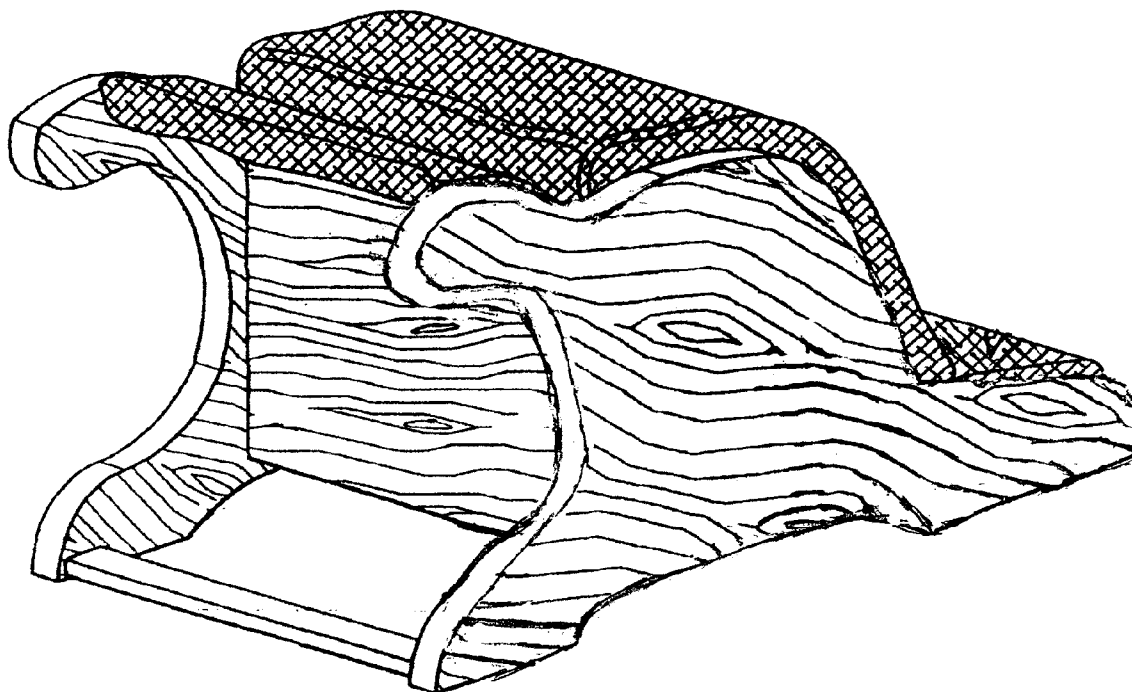
FIG. 1 is a front perspective view of our new design with

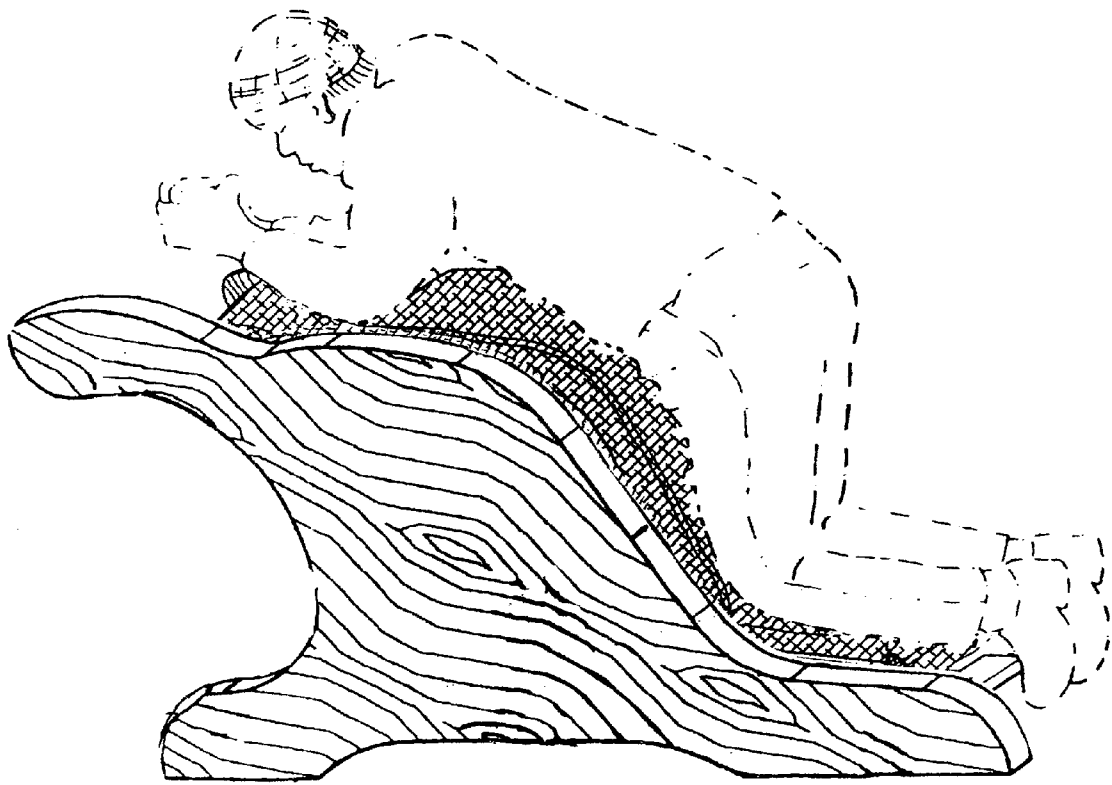

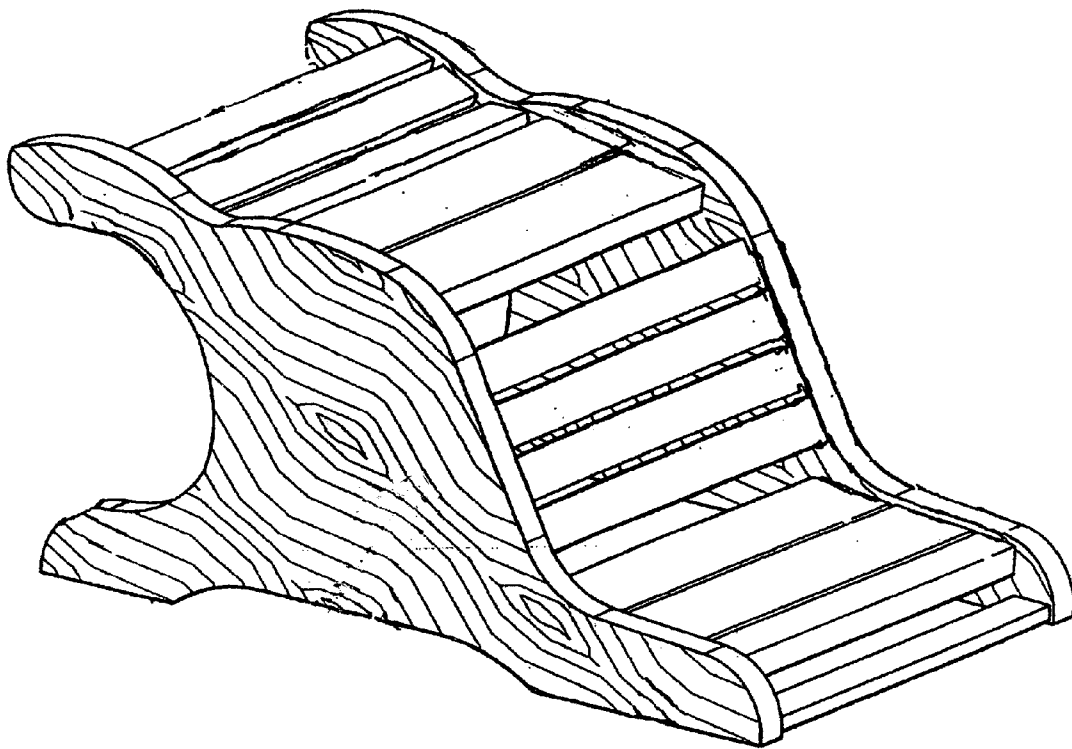

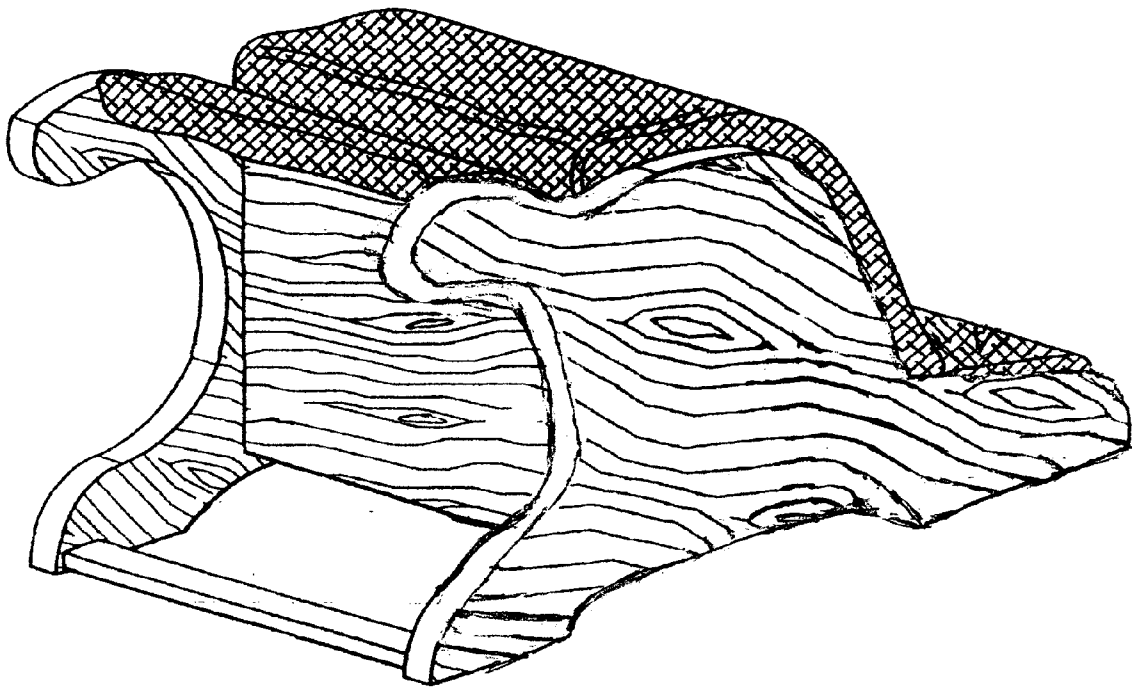
