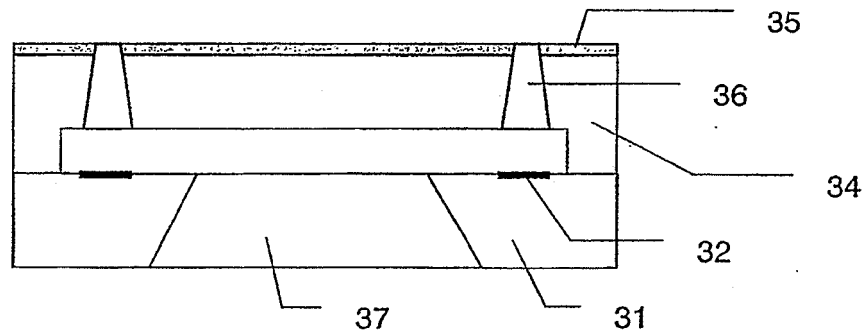

**(54) Ink jet head and its manufacture method**

(57) An ink jet head is formed with a nozzle surface having a liquid repellent characteristic. The nozzle surface comprises a condensation product made from a hy-

drolyzable silane compound having a fluorine containing group and a hydrolyzable silane compound having a cationic polymerizable group.
