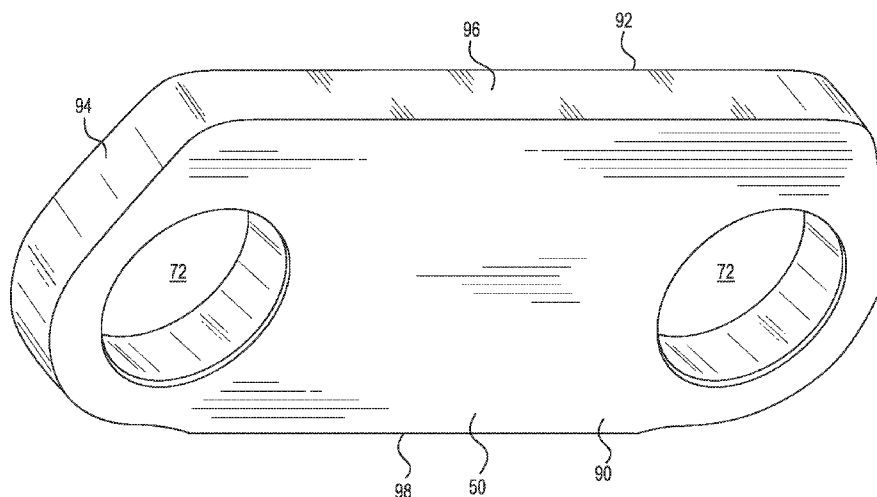

(57) Abstract: A track link (50, 52) has a link body. The link body of the track link may include a first substantially planar side surface (90), a second substantially planar side surface (92) opposite the first substantially planar side surface, a shoe face (98) extending between the first and second substantially planar side surfaces, and a roller rail (96) extending between the first and second substantially planar side surfaces opposite the shoe face.
