**CLAIM**


(57) The ornamental design for water slide, as shown and described.

**DESCRIPTION**

FIG. 1 is a front, left, and top perspective view of a water slide, showing my design.  
FIG. 2 is a rear, right, and bottom perspective view thereof.  
FIG. 3 is a front elevation view thereof.  
FIG. 4 is a rear elevation view thereof.  
FIG. 5 is a left side elevation view thereof.  
FIG. 6 is a right side elevation view thereof.  
FIG. 7 is a top plan view thereof.  
FIG. 8 is a bottom plan view thereof.  
FIG. 9 is a partial enlarged view of an area labeled 9 in FIG. 1 comprising a fixed ring; and,  
FIG. 10 is a partial enlarged view of an area labeled 10 in FIG. 1 comprising a fixed buckle.  
The broken lines shown in the drawings are included for the purpose of illustrating portions of the water slide that form no part of the claimed design.














