[57] **CLAIM**

The ornamental design for a safety gate, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a safety gate, illustrated in the retracted state, embodying the principles of the present invention;

FIG. 2 is a rear perspective view of a safety gate, illustrated in the retracted state;

FIG. 3 is a top view of the safety gate of FIG. 1;

FIG. 4 is a front view of the safety gate of FIG. 1;

FIG. 5 is a bottom view of the safety gate of FIG. 1;


FIG. 6 is a side view of the safety gate of FIG. 1, as viewed from the right hand side of FIG. 1;

FIG. 7 is a side view of the safety gate of FIG. 1, as viewed from the left hand side of FIG. 1;

FIG. 8 is a rear view of the safety gate of FIG. 1; and,

FIG. 9 is a front perspective view of the safety gate of FIG. 1, with the gate illustrated in the extended state.












