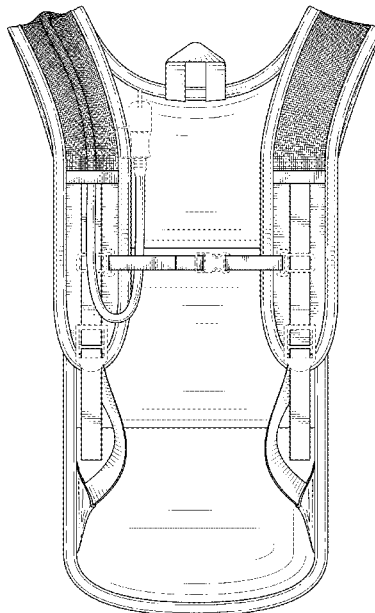
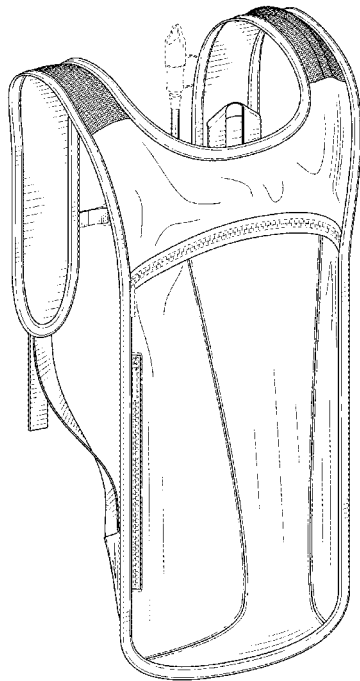
The ornamental design for a reflective hydration backpack, as shown and described.

**DESCRIPTION**

FIG. 1 is a top left front perspective view of the reflective hydration backpack showing the new design; FIG. 2 is a front elevational view of the reflective hydration backpack thereof; FIG. 3 is a rear elevational view of the reflective hydration backpack thereof; FIG. 4 is a left side elevational view of the reflective hydration backpack thereof; FIG. 5 is a right side elevational view of the reflective hydration backpack thereof; FIG. 6 is a top plan view of the reflective hydration backpack thereof; and, FIG. 7 is a bottom plan view of the reflective hydration backpack thereof.

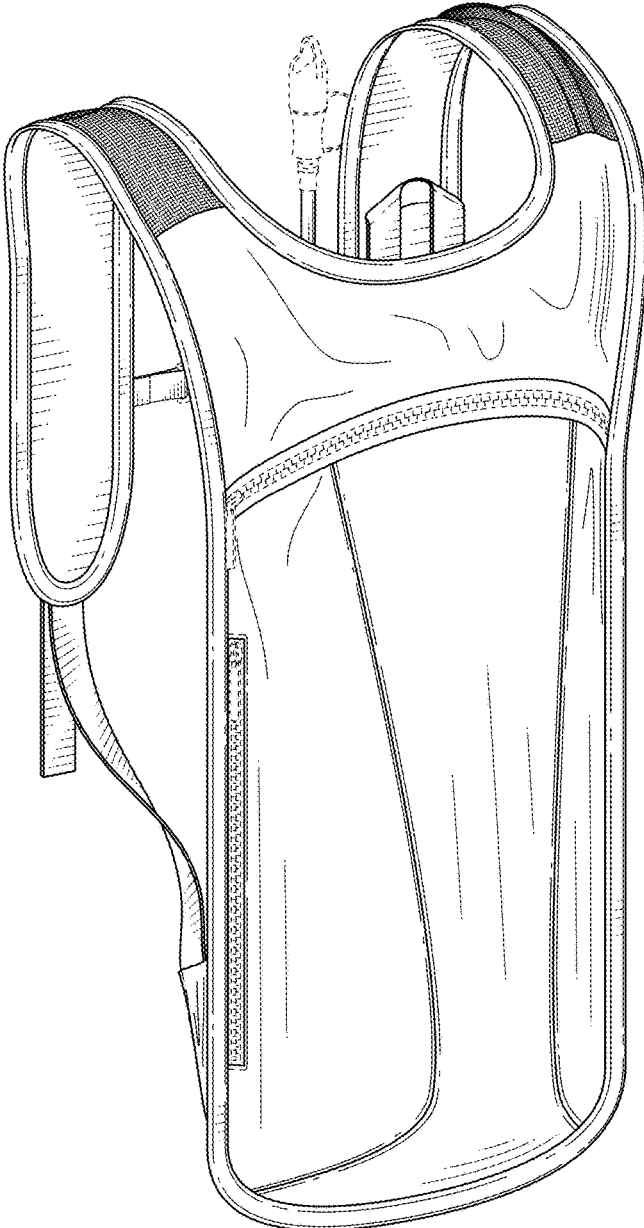

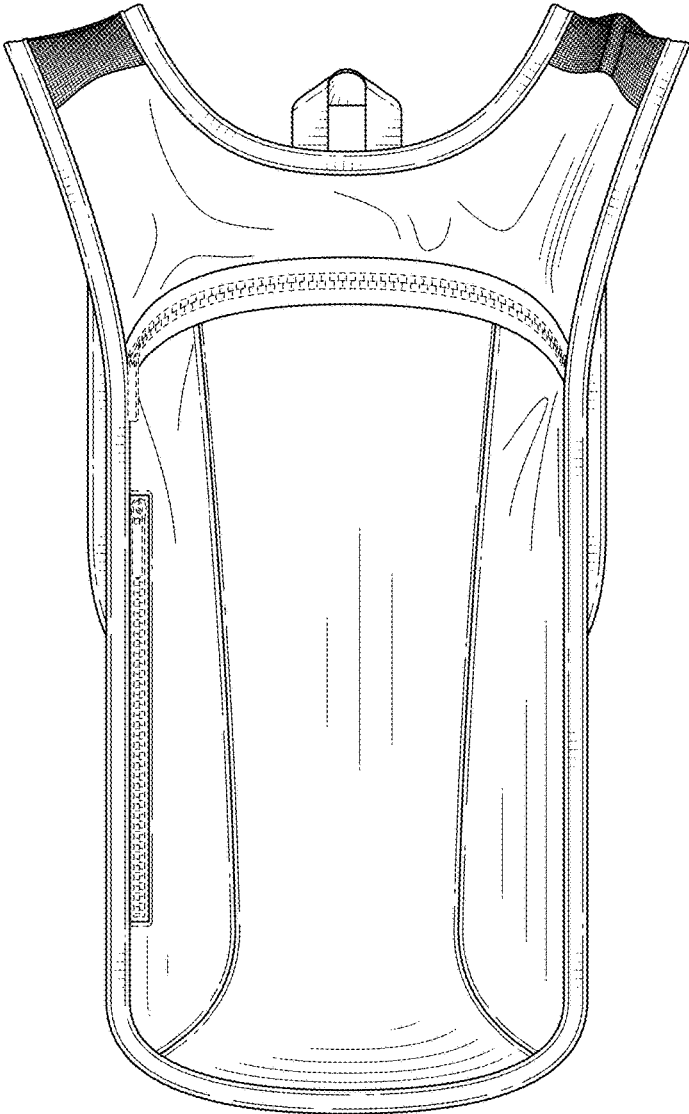

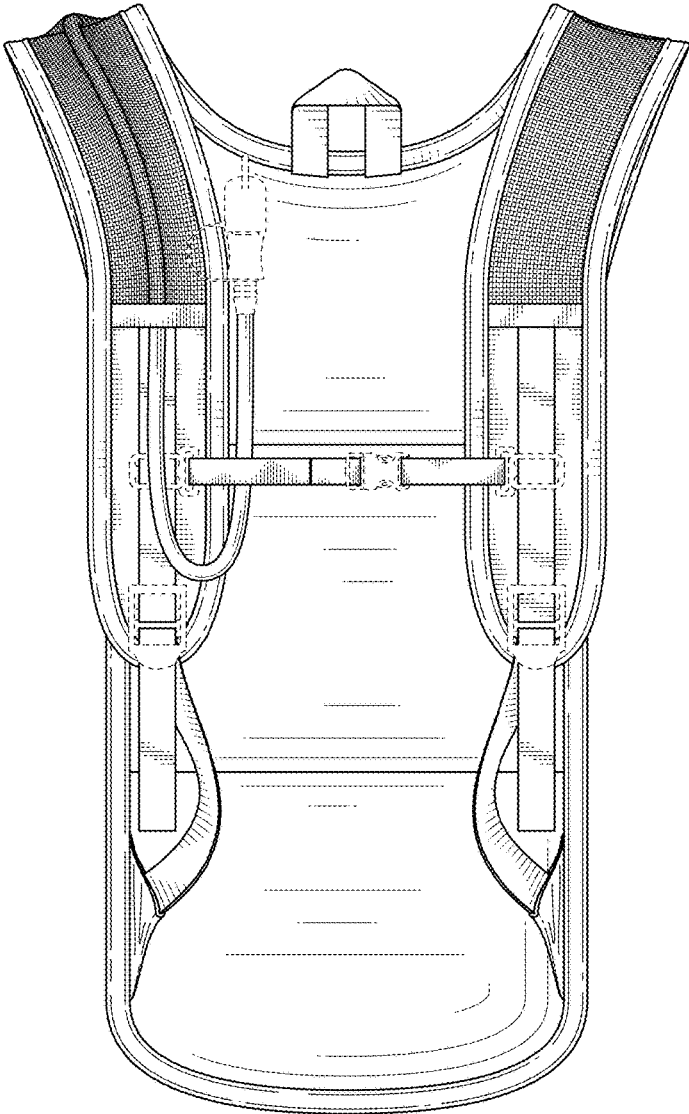

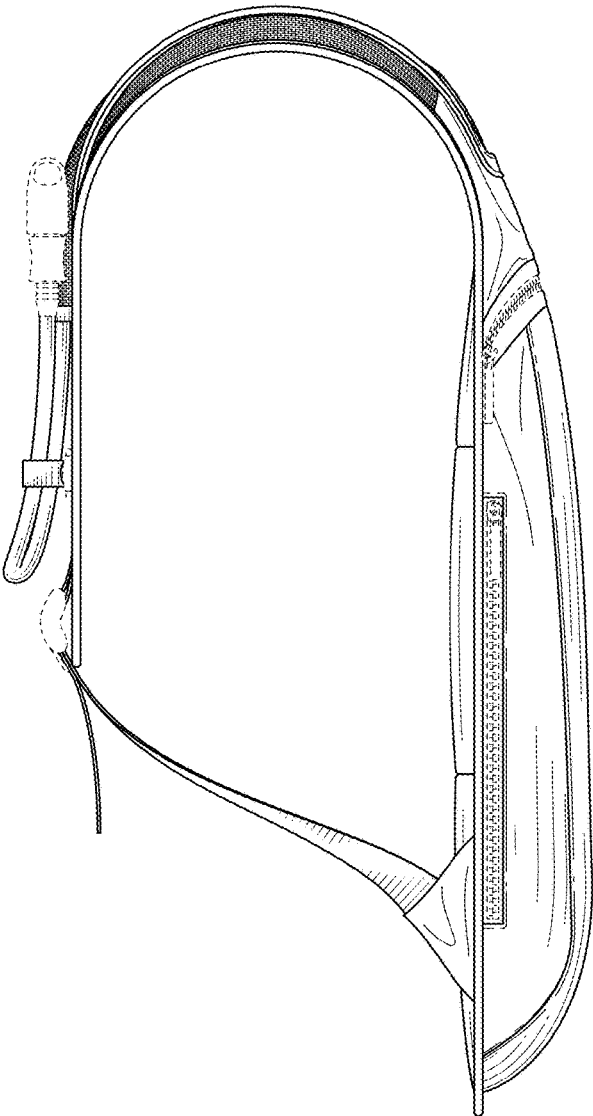

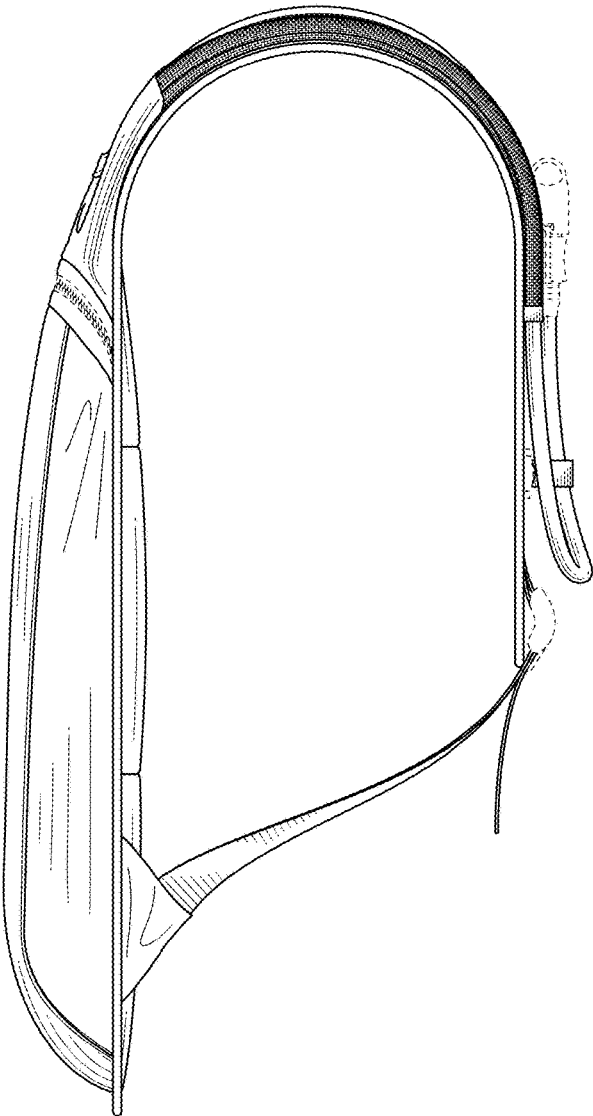

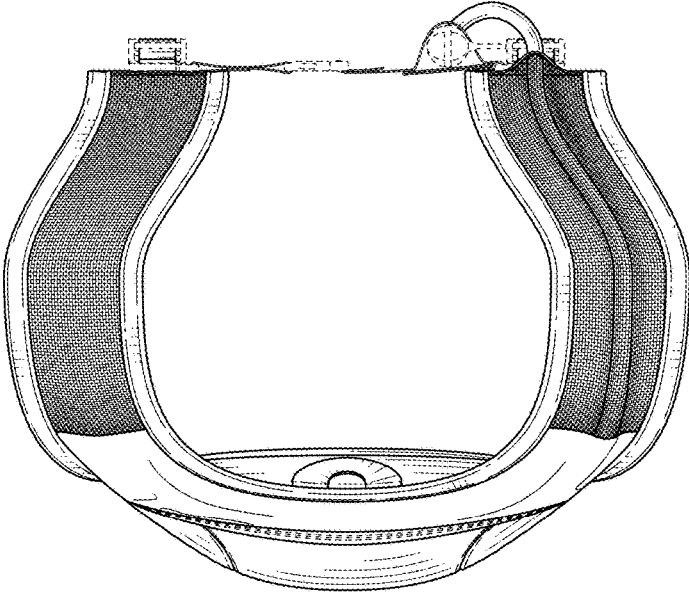

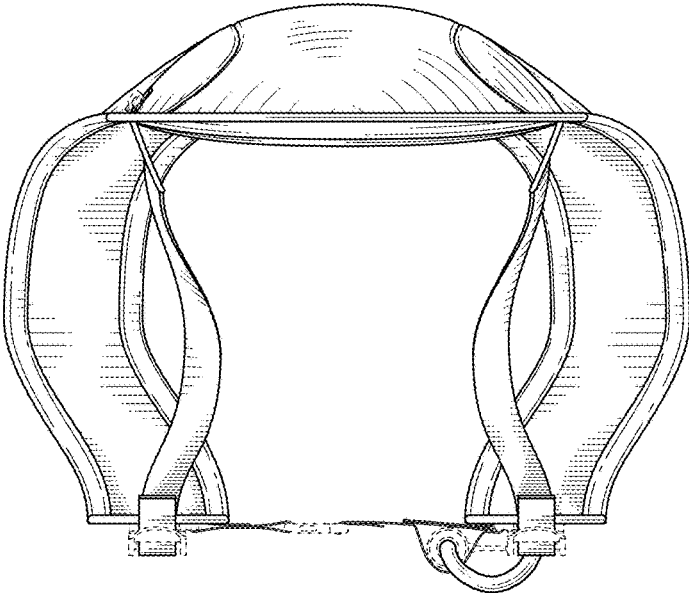
