DESCRIPTION

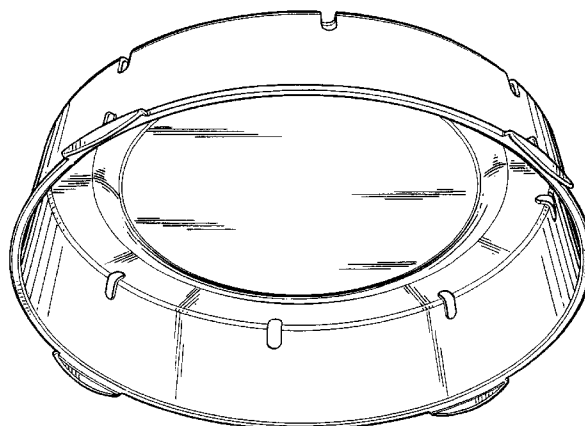
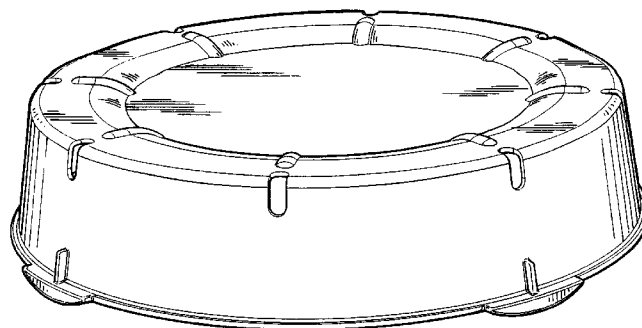
FIG. 1 is a perspective view of a tray cover emphasizing the top of the tray cover.

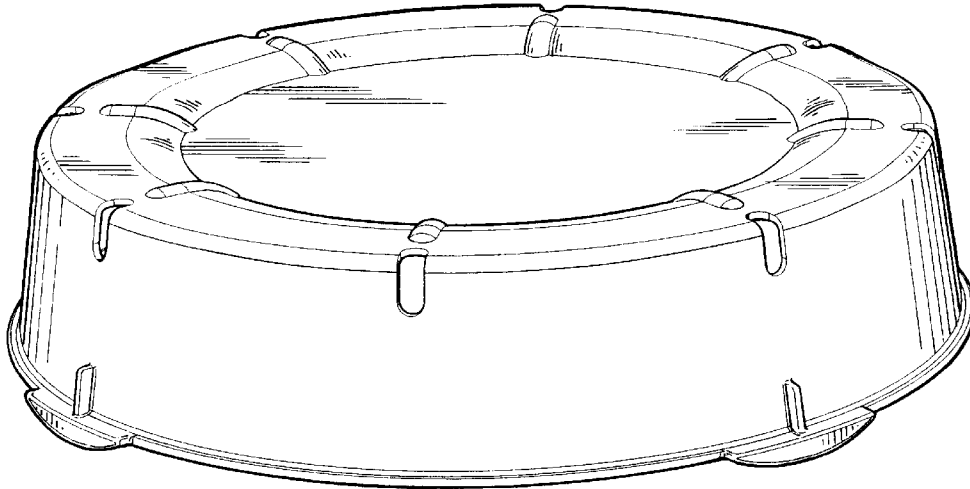

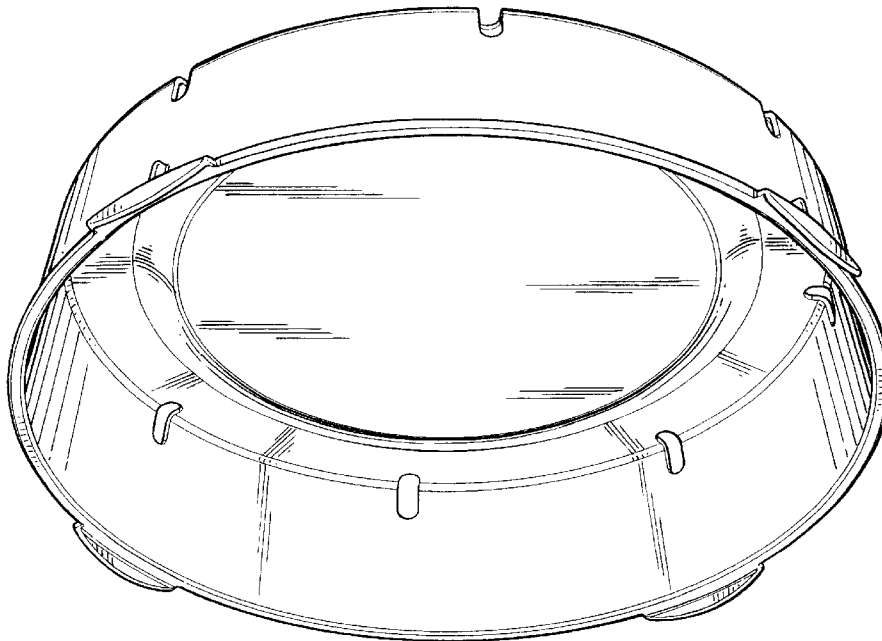

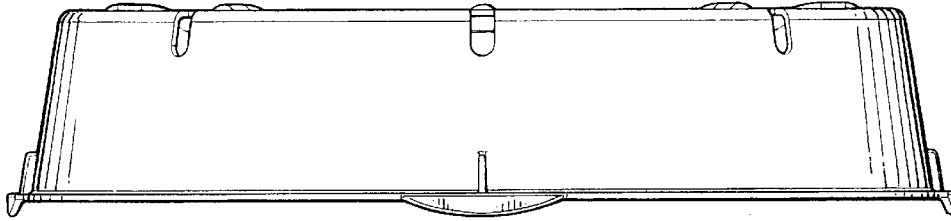

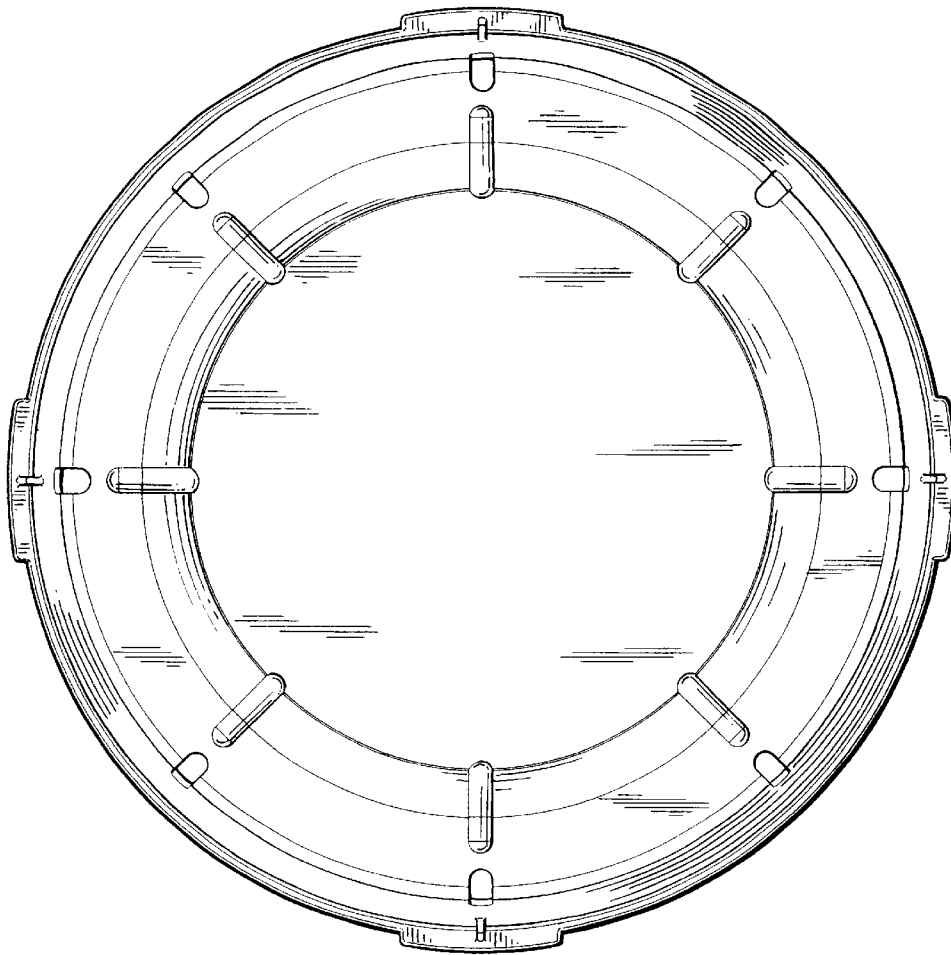
