(57) **CLAIM**

We claim the ornamental design for a handheld vacuum cleaner, as shown and described.

DESCRIPTION

FIG. 4 is a left side view of the handheld vacuum cleaner shown in FIG. 1.

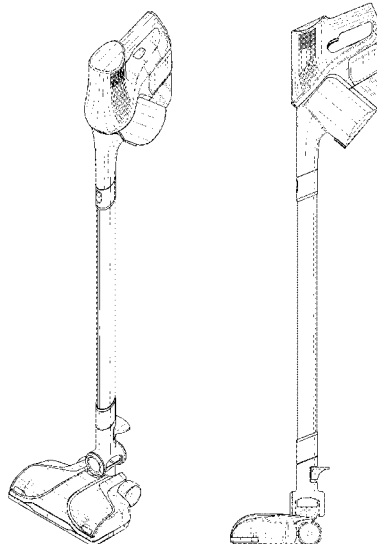
FIG. 5 is a right side view of the handheld vacuum cleaner shown in FIG. 1.

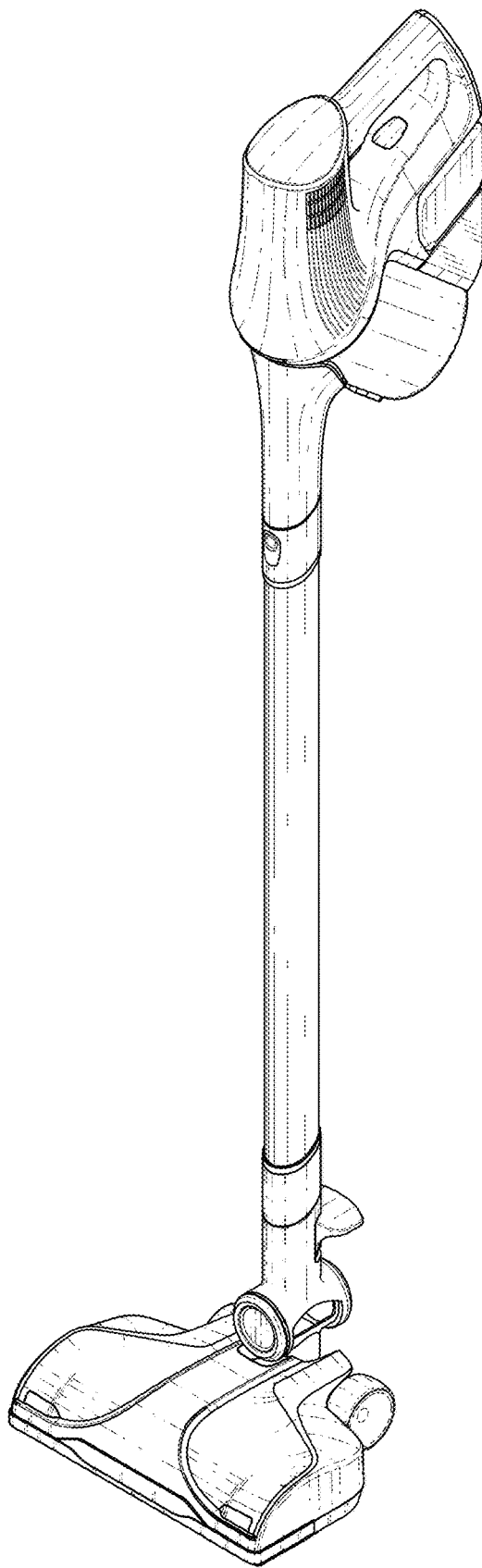

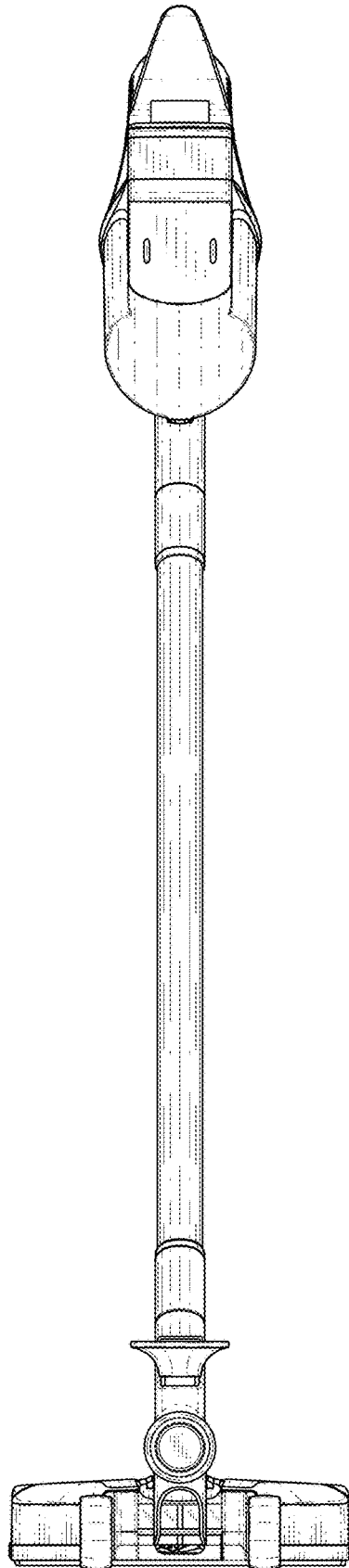

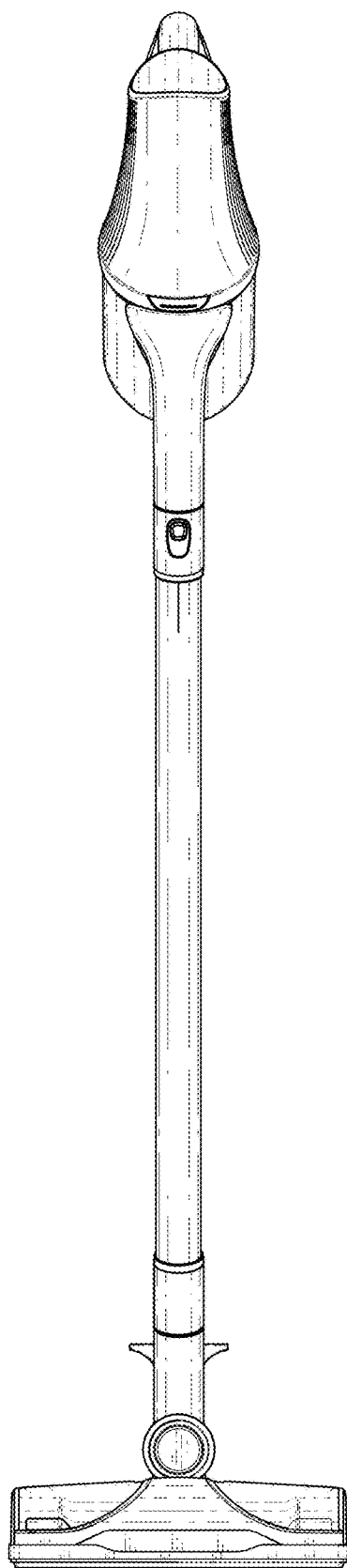

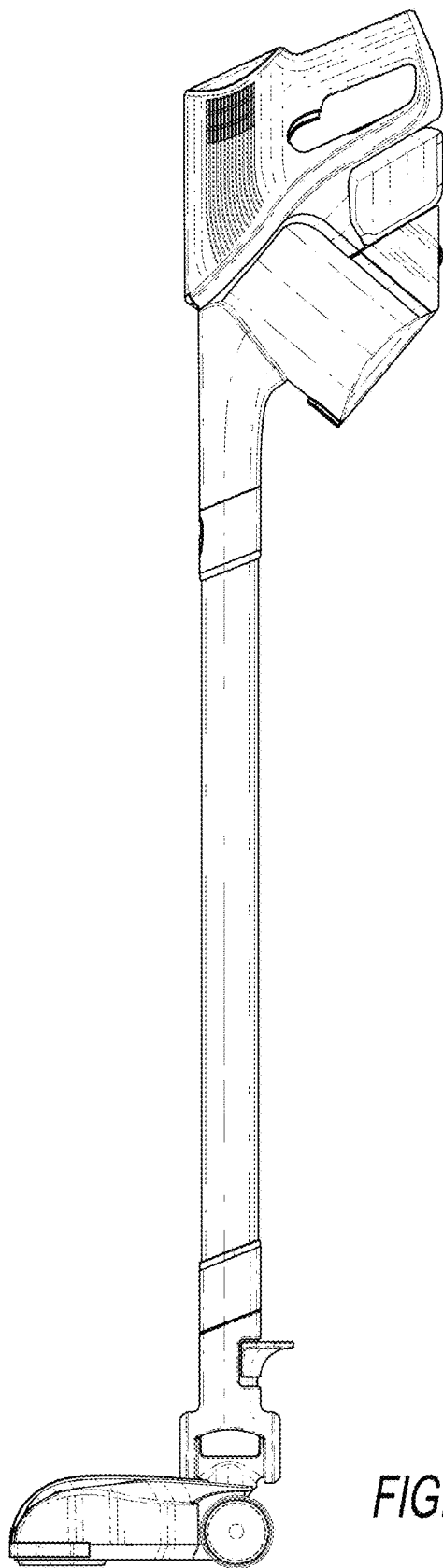

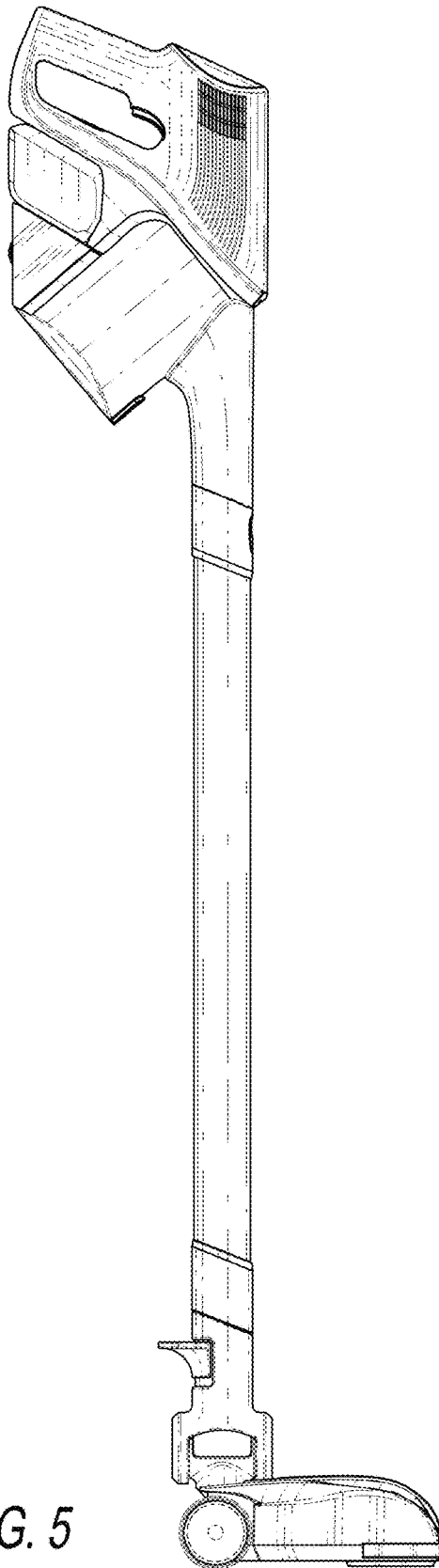

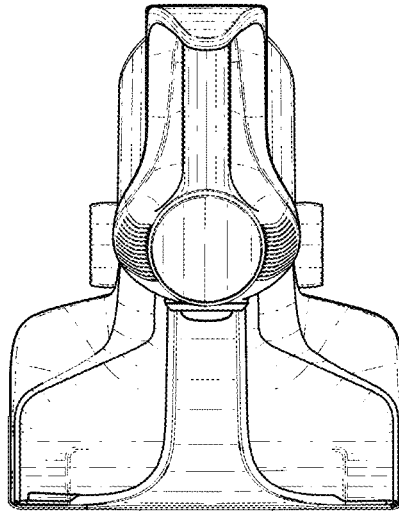

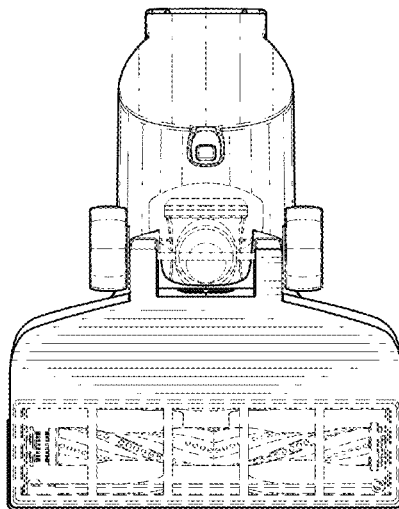
