
[57] **CLAIM**

The ornamental design for a packaged flash camera, as shown.

DESCRIPTION

FIG. 1 is a front, top, right-side perspective view of a packaged flash camera, showing our new design; FIG. 2 is a rear, bottom, left-side perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left-side elevation view thereof; FIG. 6 is a right-side elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.
















