(57) **CLAIM**

The ornamental design for a phone case, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view showing the top, front, right sides as well as the inner interior surface of a phone case; FIG. 2 is a bottom perspective view showing the bottom, front, and left sides as well as the inner right interior surface of the phone case; FIG. 3 is a further bottom perspective view showing the bottom, front, and right sides as well as the inner left interior surface of the phone case; FIG. 4 is a further bottom perspective view showing the bottom, left, and back sides of the phone case; FIG. 5 is a front elevation view of the phone case; FIG. 6 is a rear elevation view of the phone case; FIG. 7 is a left side elevation view of the phone case; FIG. 8 is a right side elevation view of the phone case; FIG. 9 is a top plan view of the phone case; and, FIG. 10 is a bottom plan view of the phone case. The broken lines in the drawing figures represent portions of the phone case that form no part of the claimed design.

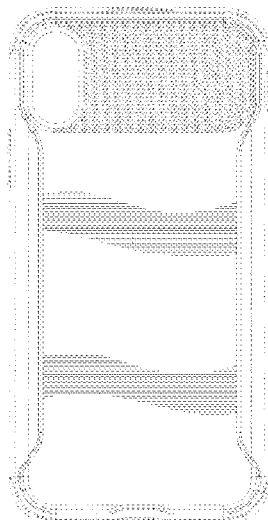

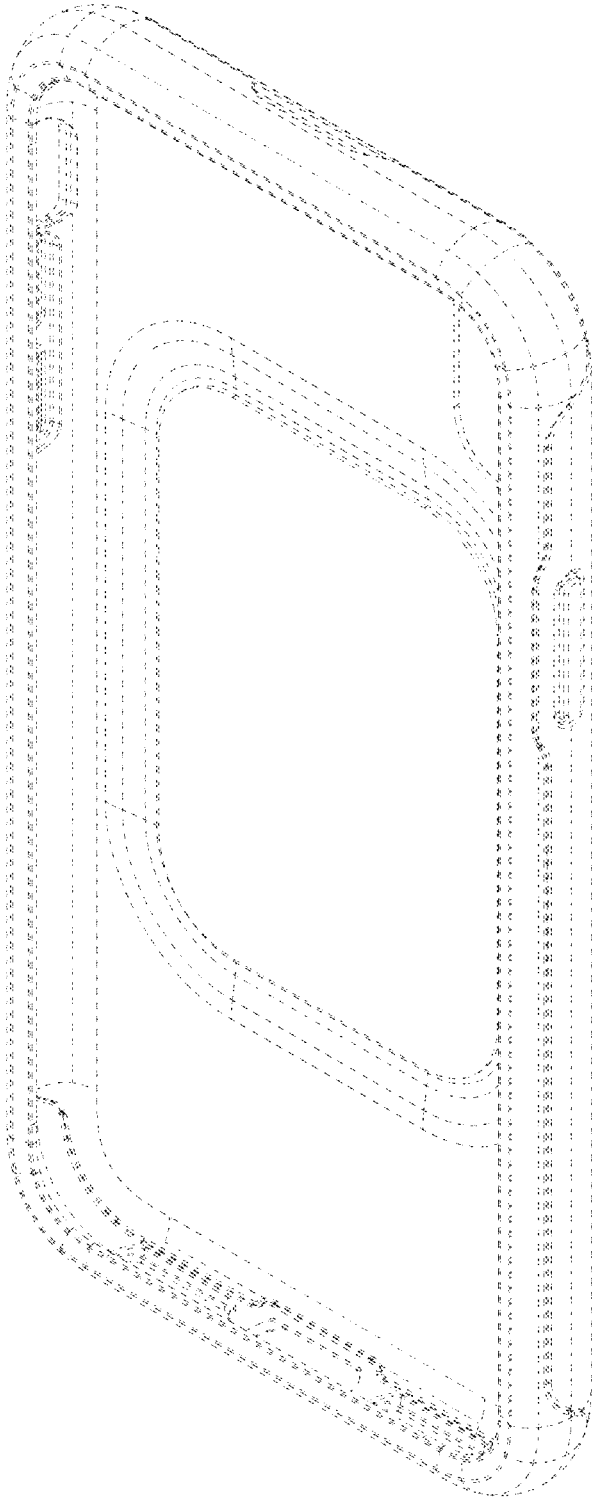

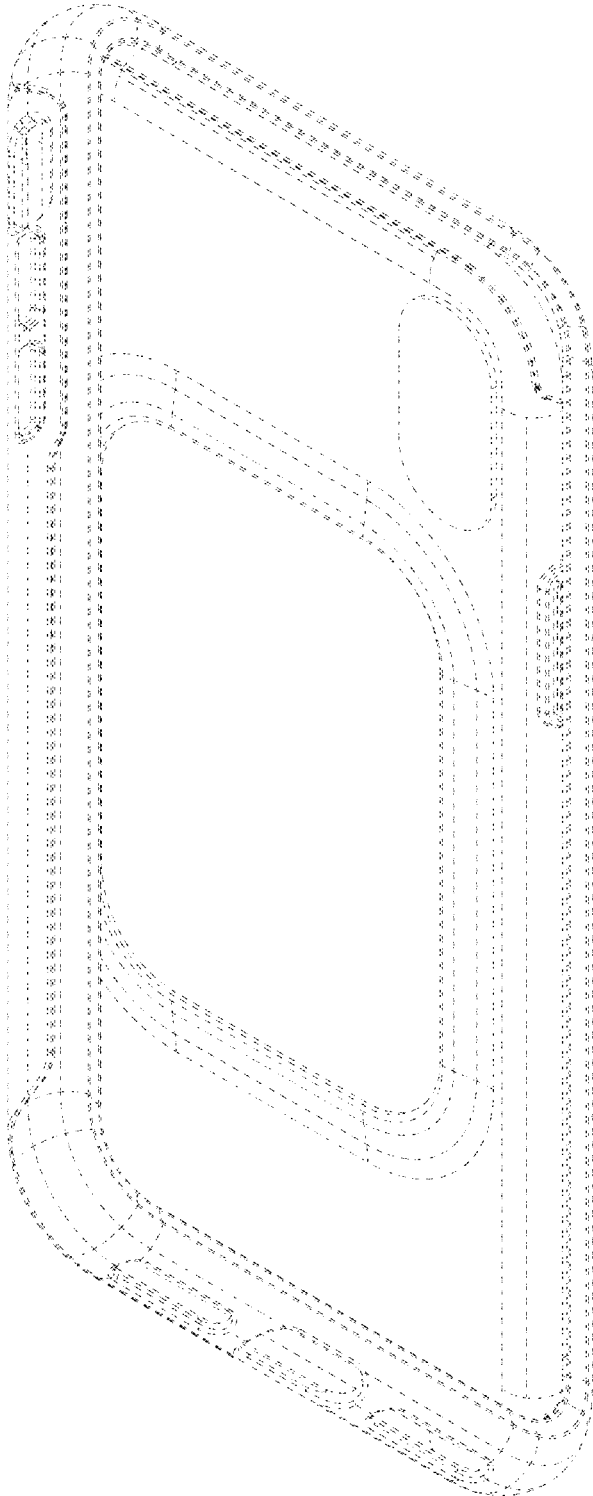

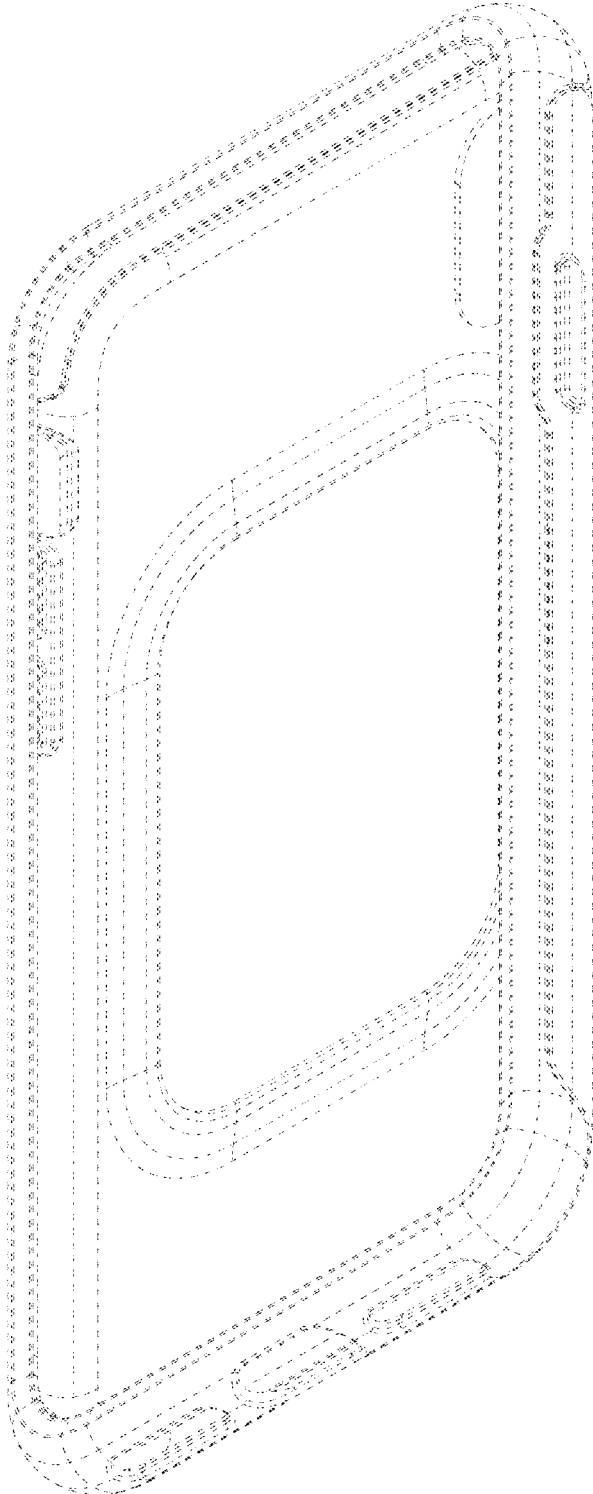

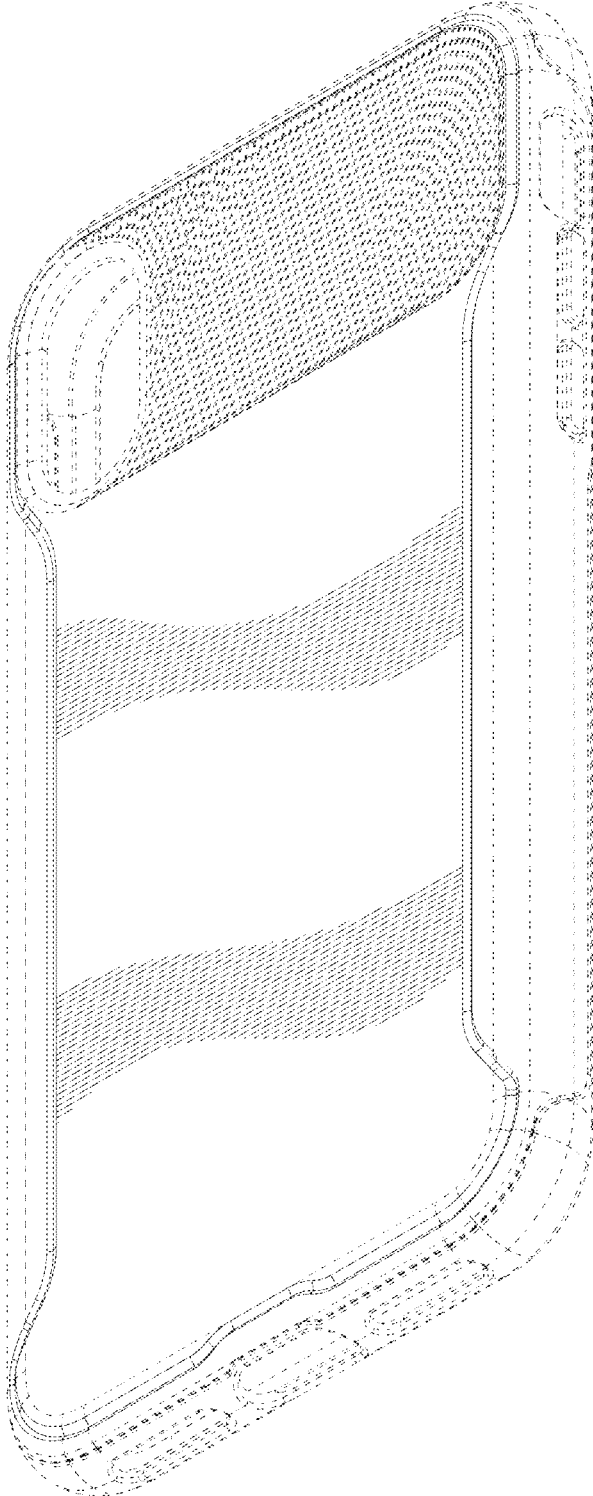

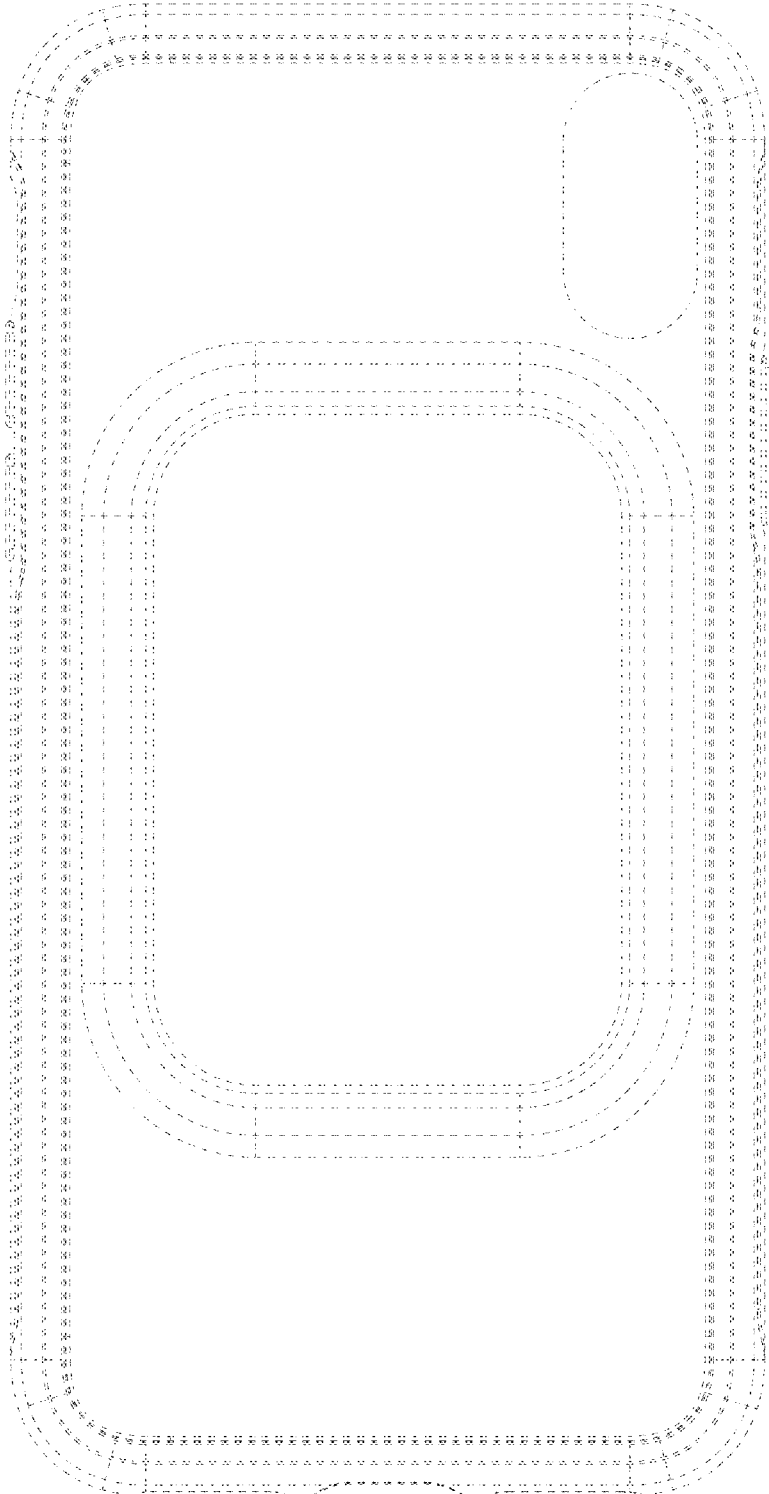

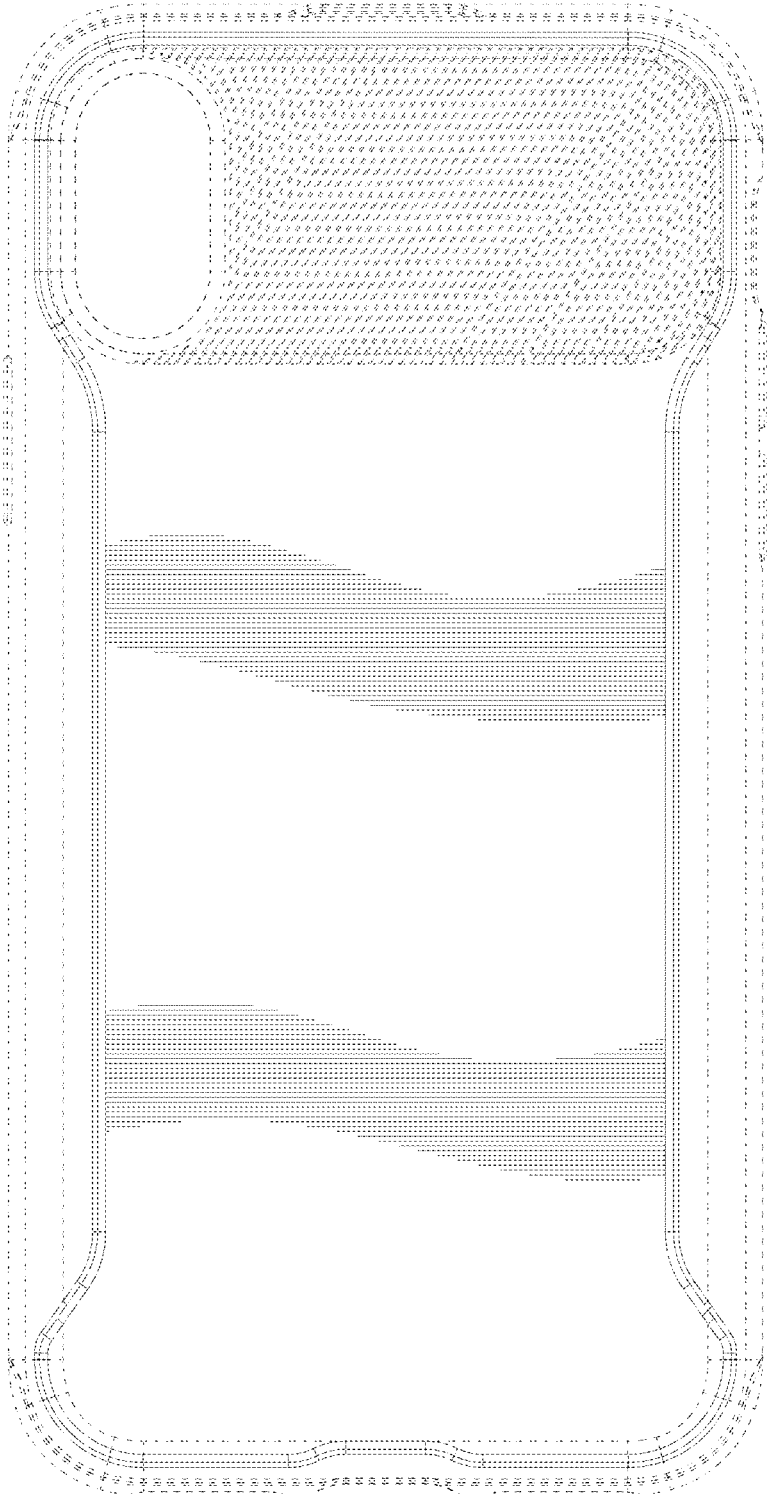

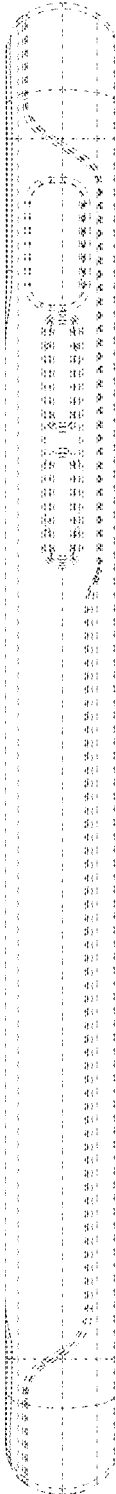

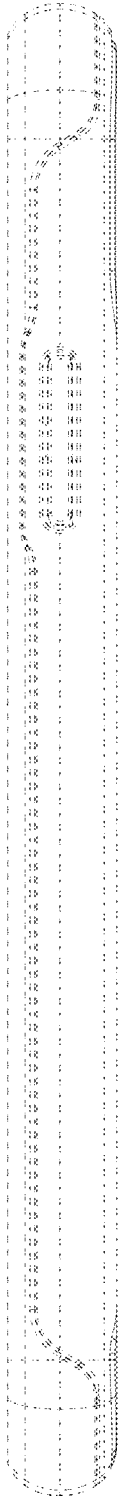

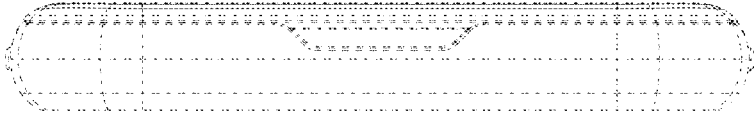
