**DESCRIPTION**

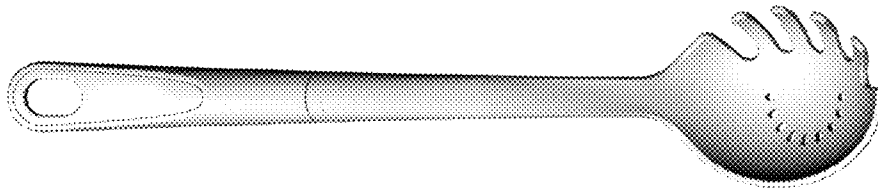

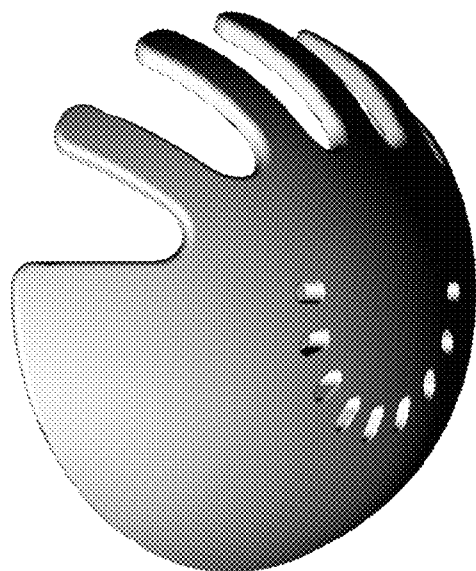

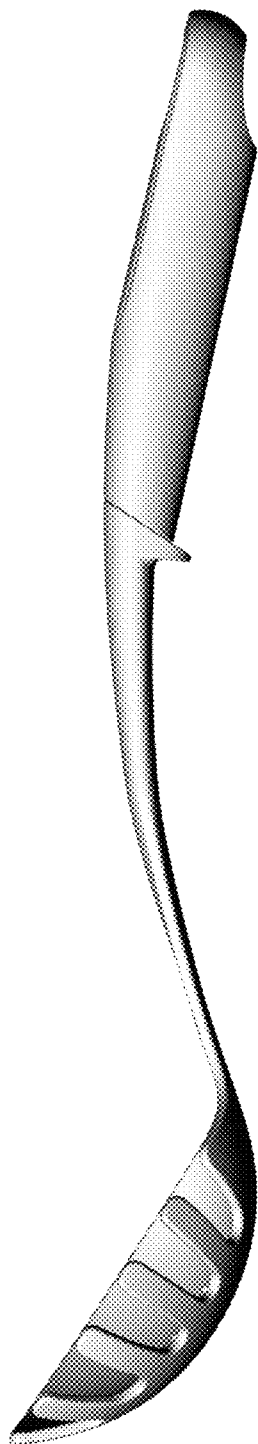

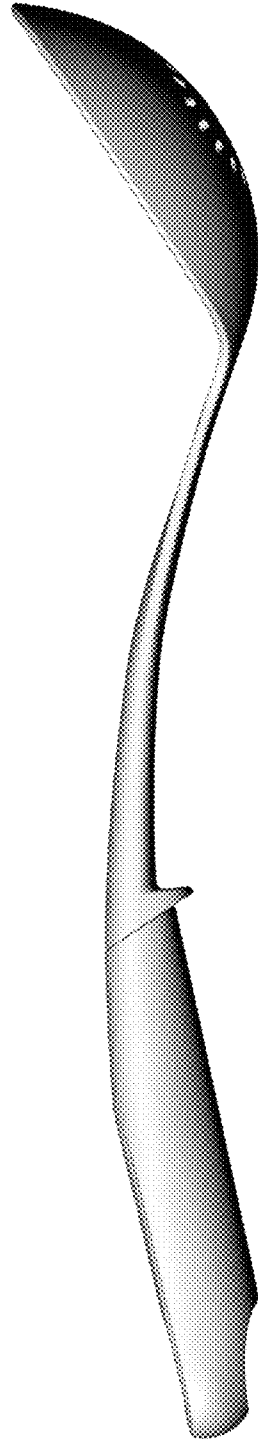
