DESCRIPTION

FIG. 4 is a second side elevational view of the fishing reel illustrated in FIG. 1;

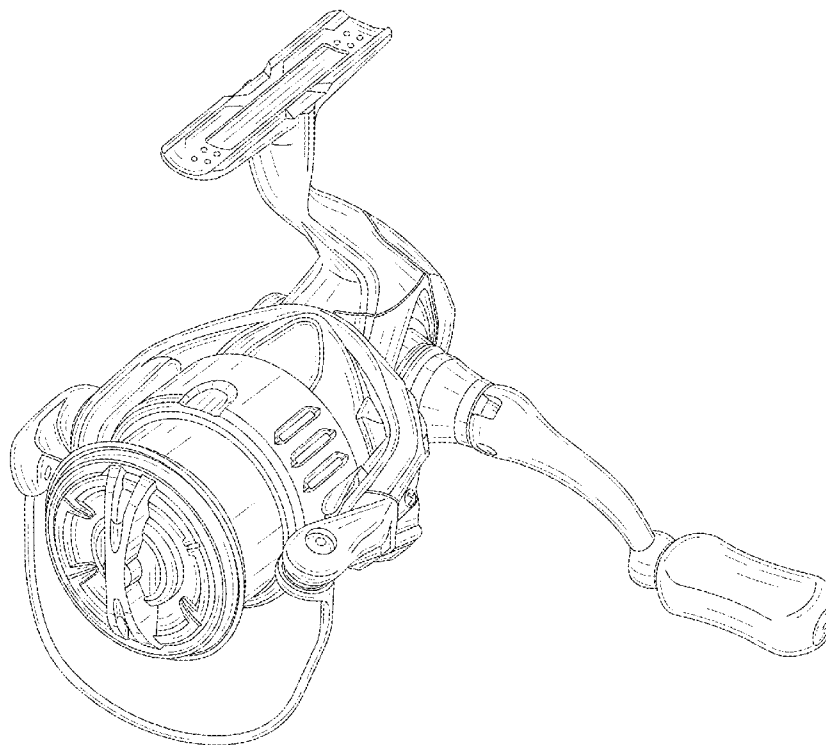
FIG. 5 is a top plan view of the fishing reel illustrated in FIG. 1;

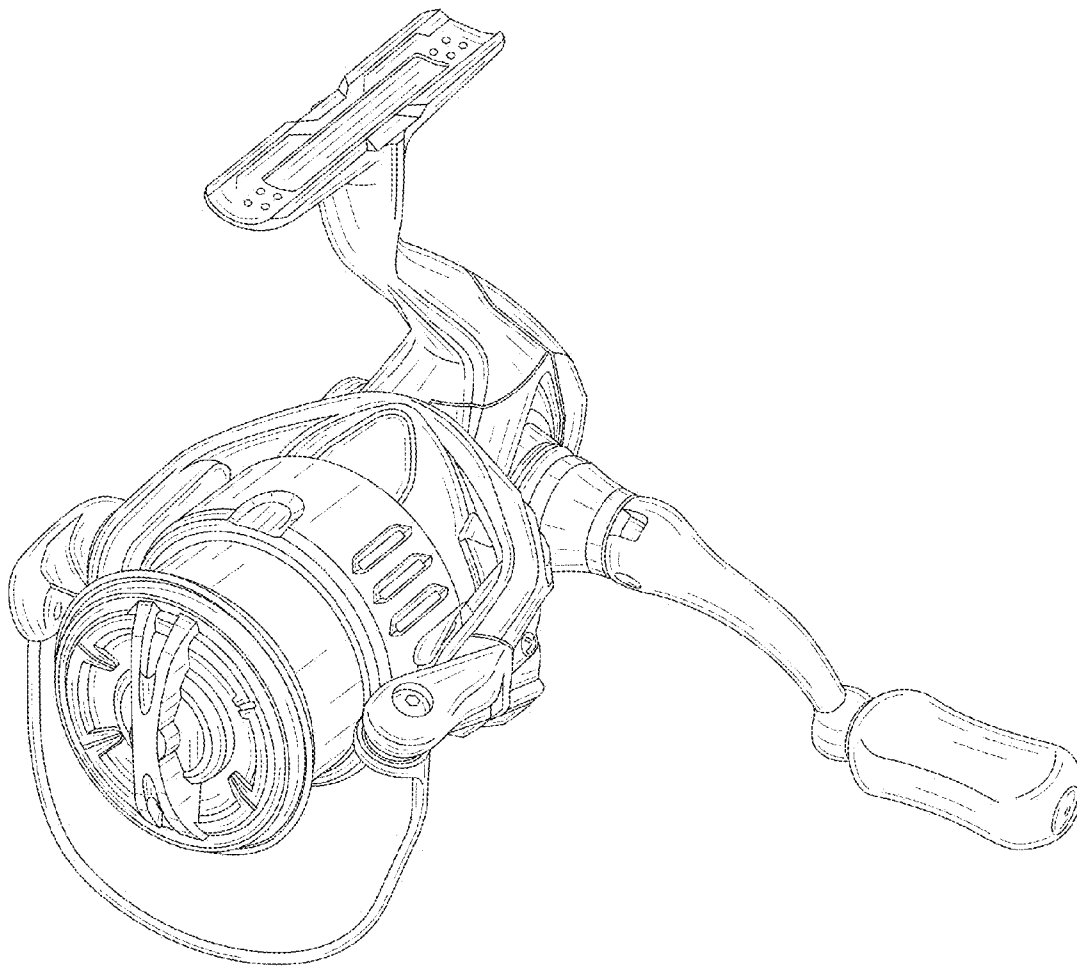

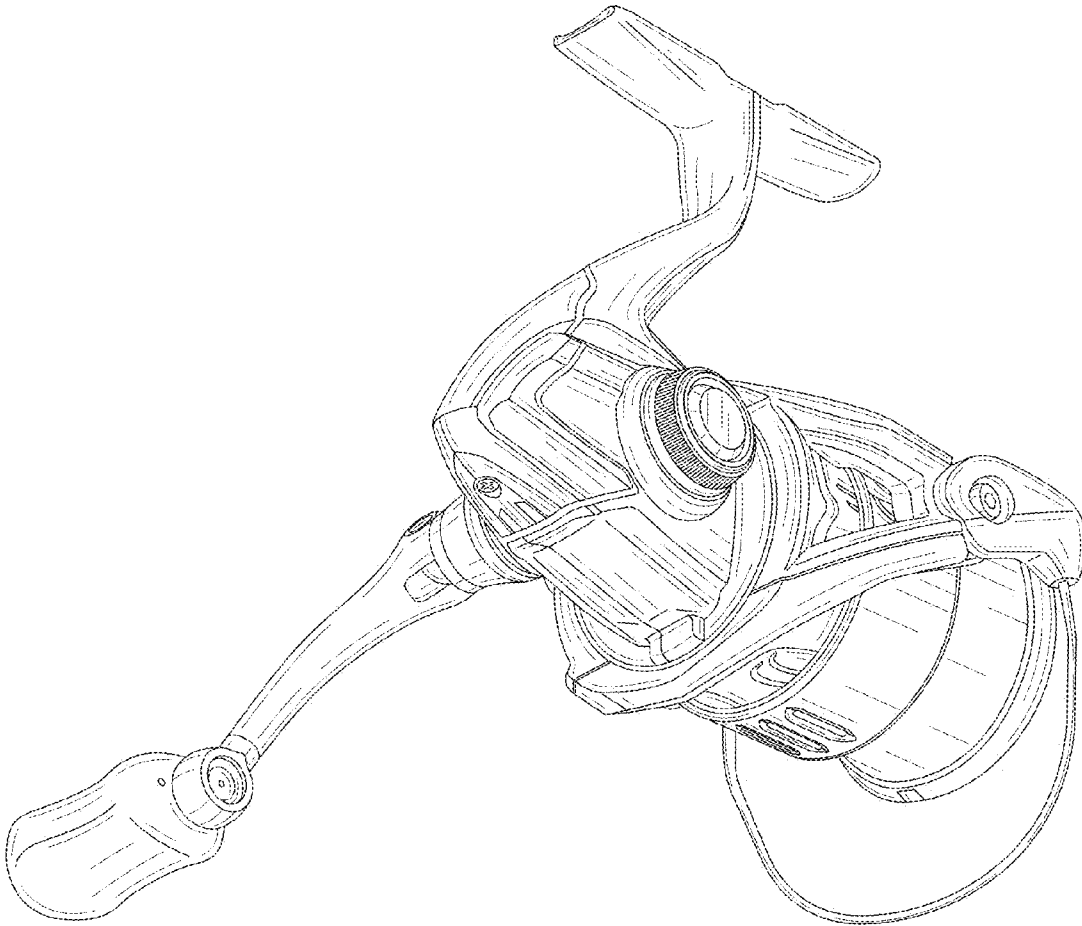

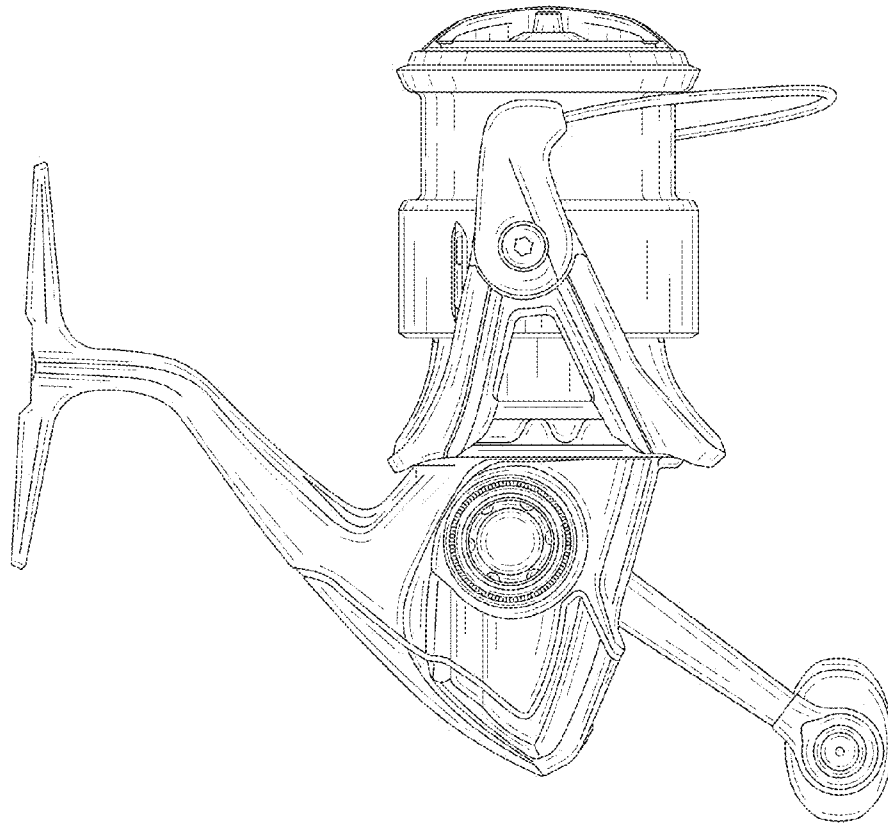

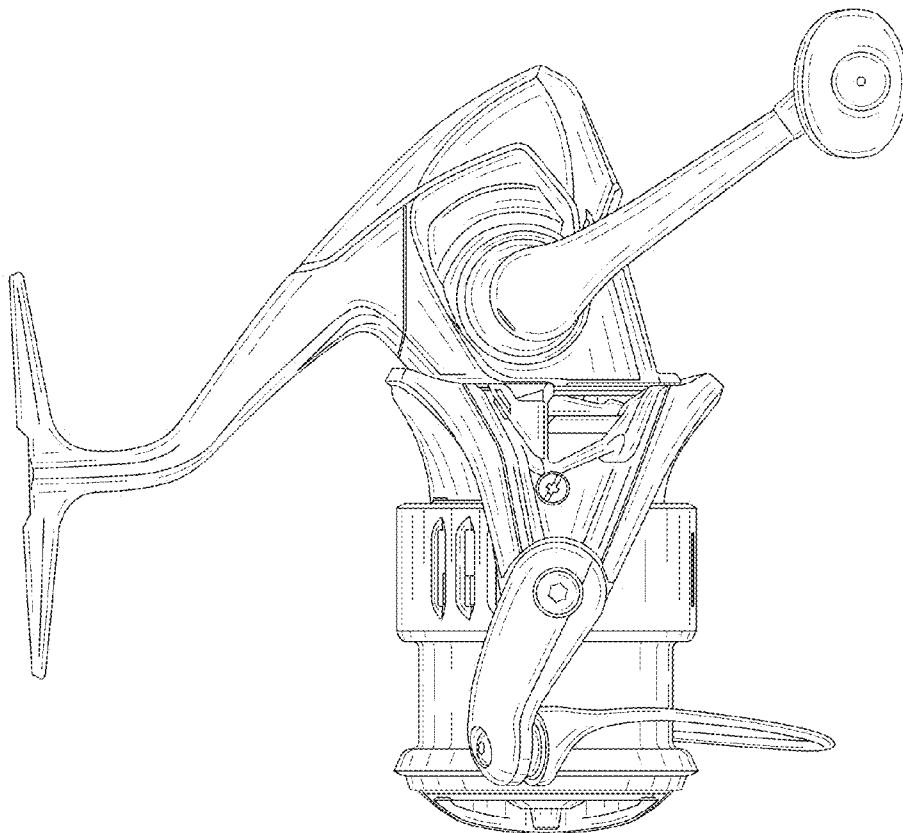

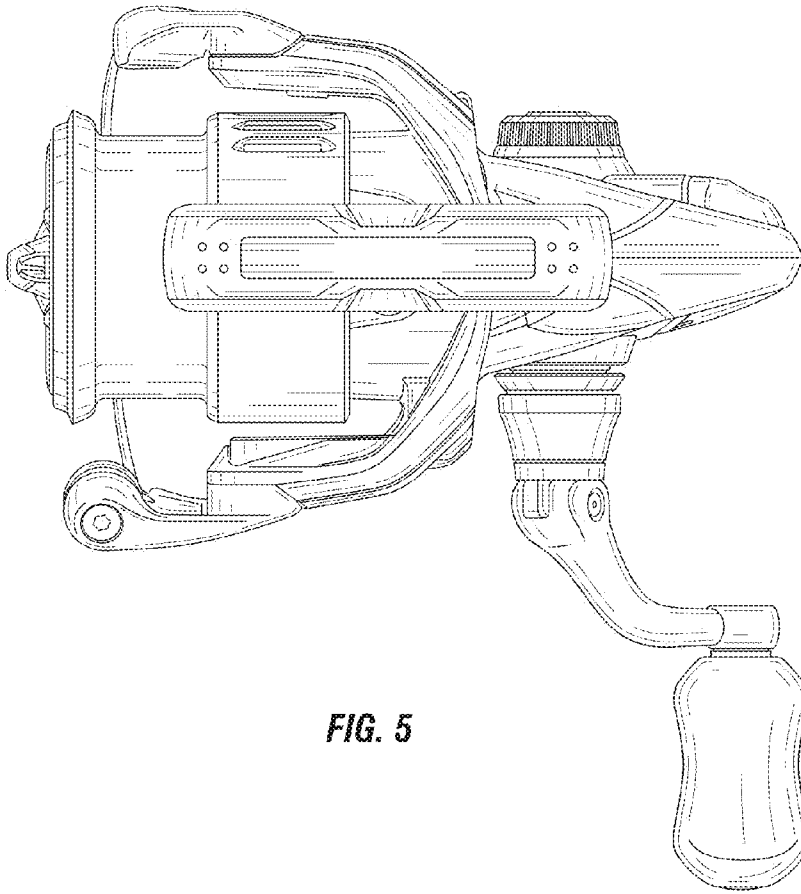

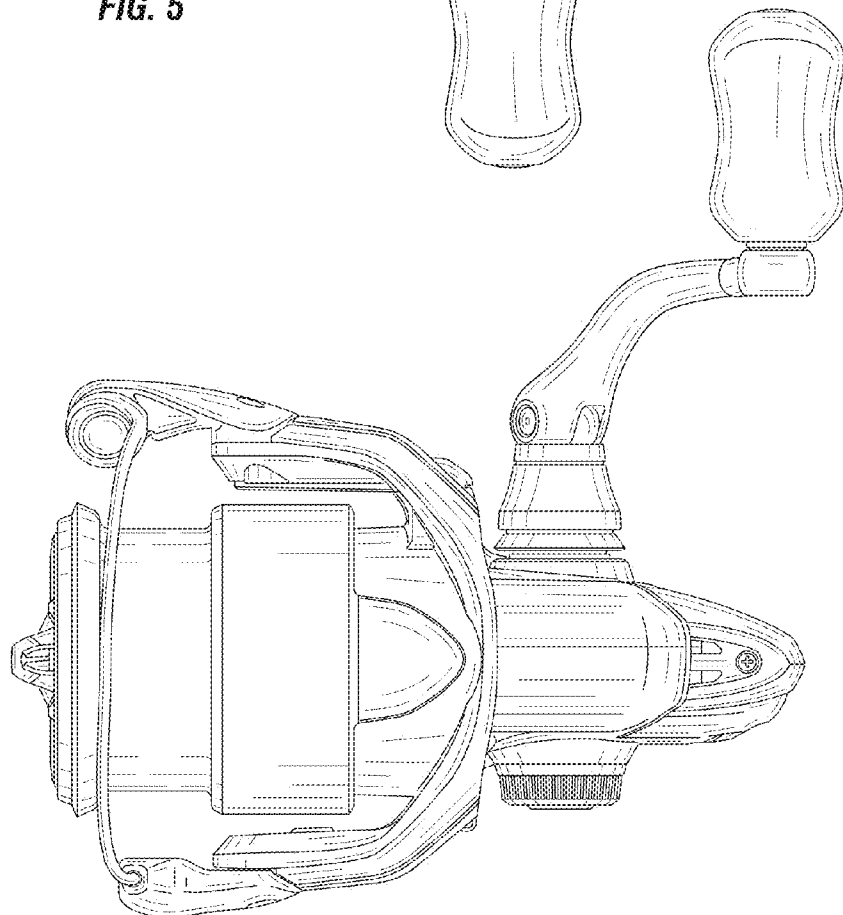

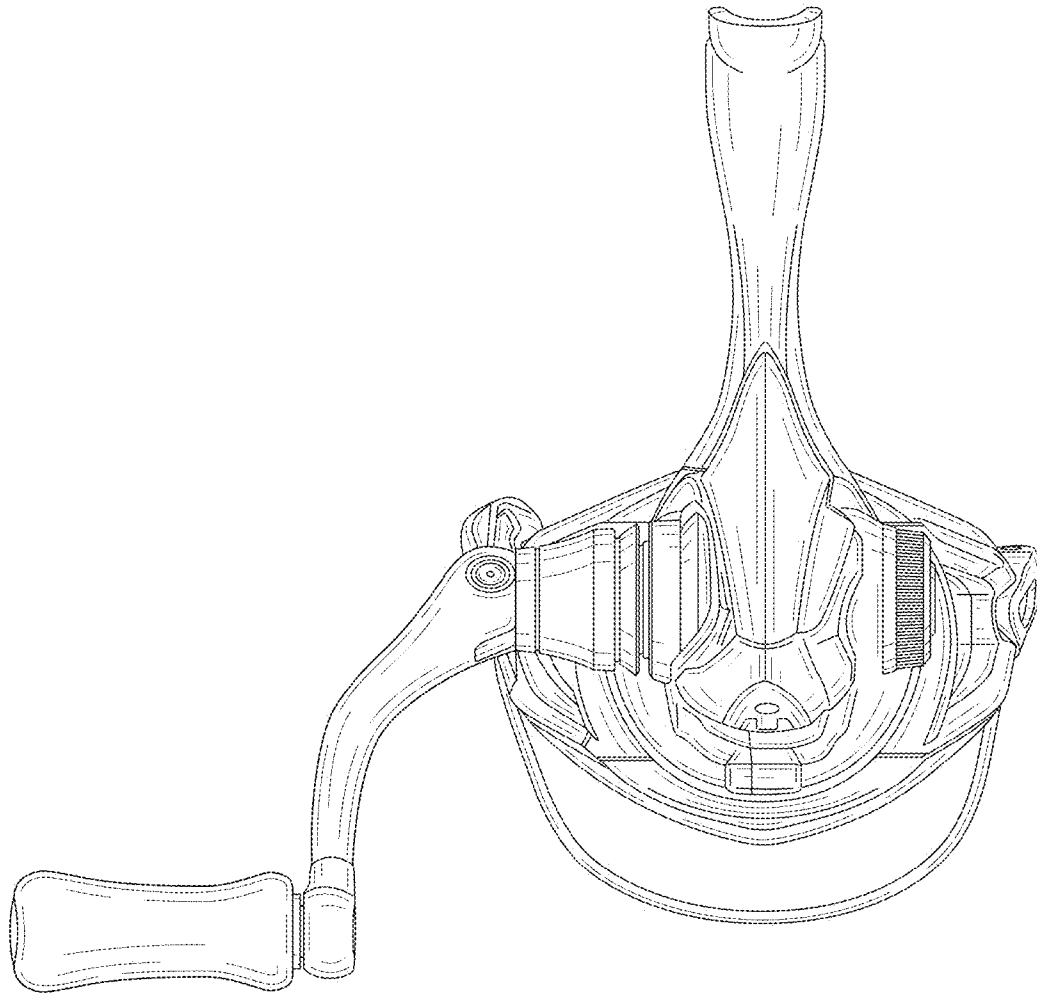

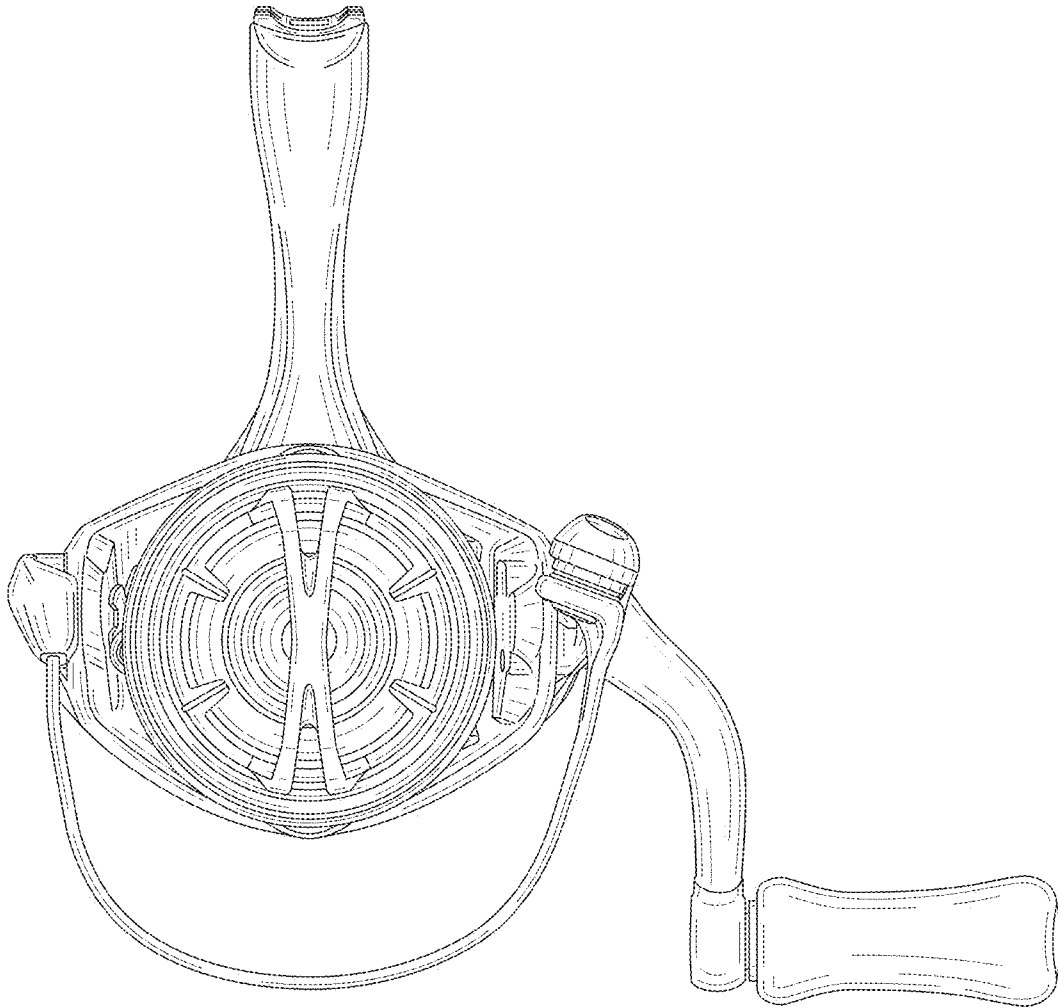
