(57) **CLAIM**

The ornamental design for a bucket base edge shroud system, as shown.

DESCRIPTION

FIG. 4 is a bottom view of the bucket base edge shroud system.


FIG. 5 is an enlarged right side view of the bucket base edge shroud system.












